- \_\_\_\_\_ Large-Print Test Materials – Test administrators must transcribe student responses into the online test delivery system. Requires signed confidentiality form.
- \_\_\_\_\_ Multiplication Table – paper-based table (1 × 1 to 12 × 12) for math items.
- \_\_\_\_\_ Paper Test Format – Test administrators must transcribe student responses into the online test delivery system. Requires signed confidentiality form.

  - \_\_\_\_\_ Print on Demand for Mathematics
  - \_\_\_\_\_ Print on Demand for ELA – include **listening** passage scripts
- \_\_\_\_\_ Read-Aloud in English (human reader) for ELA reading **passages** for paper-based tests – **Only for GRADES 6-8 and blind students at all grades who have not acquired adequate Braille skills.** Requires solitary placement and signed confidentiality form.
  - \* This accommodation is only appropriate for a very small number of students, estimated to be approximately 1-2% of students with disabilities participating in a general assessment.**
- \_\_\_\_\_ Speech-to-Text – Requires solitary placement and signed confidentiality form.
  - \_\_\_\_\_ Student uses their own assistive technology devices to produce written responses. Test administrators must transcribe student responses into the online test delivery system.
  - \_\_\_\_\_ Student uses the embedded speech-to-text accommodation with vendor-designated settings for operating system and test delivery system.
- \_\_\_\_\_ Text-to-Speech for online testing – Requires headphones OR solitary placement and signed confidentiality form.
  - \_\_\_\_\_ Embedded for ELA reading **passages** – **Only for GRADES 6-8 and blind students at all grades who have not acquired adequate Braille skills.**

  - \_\_\_\_\_ Embedded for ELA, Mathematics, and Science **stimuli and items** – Designated support, please see the 2024-2025 UAAG for implementation.
- \_\_\_\_\_ Word Completion for students with motor, orthopedic, or neurological disability that prevents or inhibits encoding capacity. Test administrators must transcribe student responses into the online test delivery system. Requires signed confidentiality form.
