# MINUTES OF THE NOVEMBER 22, 2022 REGULAR MEETING OF THE WASHOE COUNTY SCHOOL DISTRICT BOARD OF TRUSTEES

November 22, 2022

# 1. Opening Items

## 1.01 CALL TO ORDER

The regular meeting of the Board of Trustees was called to order at 1:03 p.m. in the Board Room of the Central Administration Building, located at 425 East Ninth Street in Reno, Nevada.

## 1.02 ROLL CALL

Vice President Diane Nicolet and Board Members Adam Mayberry, Ellen Minetto, Joe Rodriguez, and Beth Smith were present. Board Member Jeff Church was present through video conference. Superintendent Susan Enfield and staff were also present.

Vice President Nicolet read the following into the record on behalf of President Angela Taylor, dated November 21, 2022:

It is with mixed emotions that I submit my official letter of resignation from the Washoe County School District Board of Trustees effective immediately.

While I was originally informed that I could stay in office until the Nevada State Supreme Court canvasses the election results on November 22, 2022, today I learned that waiting until then could potentially create a legal issue and be challenged in court. Although I was advised that it isn't settled law, it doesn't make sense to risk putting the District in a protracted legal battle.

For the past 8 years, I have been blessed by the opportunity to represent the students, staff, schools and citizens in District E. During that time, I am humbled to have been elected to serve as Board President for 4 years, Board Vice President twice and Board Clerk once. I understand that leadership is a privilege and although not perfect, I hope my tenure leaves a positive impact behind.

I am excited about the future of the Washoe County School District a new chapter begins — new Superintendent, new Board, new strategic plan. Thank you for the honor and privilege to serve the District that I love.

## 1.03 PLEDGE OF ALLEGIANCE

JJ Batchelder, Board Services Coordinator, led the meeting in the Pledge of Allegiance.

- 2. Items for Presentation, Discussion, Information and/or Action
- 2.01 REVIEW AND DISCUSSION BY THE BOARD OF TRUSTEES REGARDING THE APPLICATIONS RECEIVED TO FILL THE VACANCY ON THE BOARD IN DISTRICT E CREATED BY THE ELECTION OF TRUSTEE ANGELA D. TAYLOR TO THE NEVADA ASSEMBLY; AND POSSIBLE ACTION TO SELECT THOSE CANDIDATES TO BE INTERVIEWED BY THE BOARD FROM AMONG THE FOLLOWING LEGALLY-QUALIFIED APPLICANTS: MEGHAN BEYER, KELLIE CROSBY-STURTZ, JOSEPH GILBERT, CODY JOHNSON, ADRIENNE POTTER, JOHN REYES, AND ALEX WOODLEY; THE CHARACTER, COMPETENCE, AND **MISCONDUCT** OF APPLICANT MAY BE CONSIDERED BY THE BOARD PER NEVADA **REVISED STATUTE (NRS) 241.033 AND ADMINISTRATIVE ACTION MAY** BE TAKEN AGAINST ANY APPLICANT PER NRS 241.034

Neil Rombardo, Chief General Counsel, reviewed the process previously used by Boards of Trustees to determine which applicants would move forward to be interviewed. Each Trustee would select three applicants to move forward to the interview stage. In terms of point distribution for the applicants, the top applicant each Trustee would be interested in interviewing would receive 3 points, the next applicant would receive 2 points, and the final applicant would receive 1 point. Once all results had been tallied, a motion would be required to move up to three candidates forward for interviews.

Vice President Nicolet explained each applicant would be provided 5 minutes to address the Board and community. No questions from Trustees would occur during this time. The order of the applicant remarks would be based on a random draw.

Meghan Beyer explained why she was interested in serving on the Board of Trustees. She talked about her experiences volunteering in her children's school, working as a substitute teacher, and conversations with teachers and other parents. She hoped she would bring a fresh perspective to the Board as a passionate mother interested in helping all children. She was interested in improving working conditions for teachers, including increasing pay, since she believed that would be the most important factor in improving educational outcomes for students.

John Reyes spoke to his experience and interest in serving on the Board of Trustees. He was a recent graduate of the District and felt he would bring a youthful mindset to the Board. He had spent his time since graduation traveling, working, and volunteering. He noted his experience in the Men of Color program helped to provide him the leadership skills needed to serve on the Board.

Joseph Gilbert talked about his desire to be a champion of public schools as his primary interest in serving on the Board of Trustees. He believed it was important to address the challenges the schools were facing since that was the only way to improve the schools, currently ranked last in the nation. He wanted to address the chronic absenteeism and violence, especially sexual violence, occurring in the schools. He felt his experience as a business leader and former student athlete from the area made him the best applicant for the position. He believed the only way to get the District back on track was to "set a blow torch to it."

Alex Woodley spoke about his experience and interest in serving on the Board of Trustees. He provided information on his childhood and the importance of teachers in his life, his service in the United States Marine Corps, college, and raising a daughter as a single father. He currently worked for the City of Reno and volunteered his time on various non-profit boards. He was interested in helping the teachers and families to ensure no child was left behind and that they had the resources they needed to achieve their hopes and dreams.

Kellie Crosby-Sturtz explained about her experience as a parent and an educator as the primary reasons for wanting to serve on the Board of Trustees. As an educator in the District, she had served on various boards for both the State of Nevada and the Washoe County School District to improve education for all children. She understood the challenges many students faced and the services the District was able to provide both the students and families. She was interested in providing opportunities for students to reach their career or college goals. She believed she could provide a voice from the classroom to help address the challenges the District was facing.

Cody Johnson talked about his experience and why he was interested in serving on the Board of Trustees. He mentioned he was a candidate on the ballot for the seat in 2012 because he was interested in giving back to the schools because of what school had meant to him growing up. He noted he was the first person in his family to attend college. He had served as a volunteer coach for different sports and had also been an active member in various non-profits. He was a small businessman and understood the challenges teachers faced because his wife was an elementary school teacher.

Adrienne Potter was not present to provide remarks.

Vice President Nicolet opened the meeting to public comment.

Valerie Fiannaca expressed concern over the speed in which the Board was trying to fill the seat. She did not believe it was appropriate for Trustee Minetto to participate in the selection because of the amount of time she had left on the Board. She was concerned over Mr. Woodley's experience in government and would prefer to see someone with business experience selected. She urged the Trustees to seek balance for the Board and select Mr. Gilbert for the open seat because he had a plan for public education.

Tracey Hilton was a former student in the District and native Nevadan. She spoke in support of Mr. Gilbert for the open seat because she felt he was the only applicant who had a plan to improve the schools and that he would bring the community together.

Jodi Shaw was a long-time Reno resident. She spoke in opposition to Mr. Gilbert and wondered if someone of his character should even be allowed to apply for such a position. She felt it was inappropriate for someone to even be considered for a seat on a school board who had been fined \$10,000 for failing a drug test, spoke in support of Alex Jones on the Capitol steps on January 6, 2021, and who continued to speak against the sanctity of elections. She urged the Board to consider someone who was interested in raising the intelligence of all students to fill the vacant seat.

Nancy Carlson spoke in support of Mr. Gilbert. She indicated she had heard him speak numerous times. She believed Mr. Gilbert had the ideas and motivation to move students forward towards academic excellence. She remarked that his business and leadership skills were qualities that would fit in nicely with the other Trustees. She mentioned there were many in the community who were frustrated over what had occurred during the pandemic and felt it was important to have someone on the Board who was willing to speak in support of the students.

Patricia Moser Morris spoke in support of Mr. Gilbert. She understood he had been following the District for a number of years and had identified the challenges that needed to be addressed in the District. She thanked the Board for listening to her.

Paul White spoke in support of Mr. Gilbert. He claimed to be a career school reformer who had turned around numerous schools. He believed the only person who could address the rampant absenteeism, drug use, and violence against teachers was Mr. Gilbert. He expressed concern over the implementation of policies that did not allow Trustees and community to make unannounced school visits to actually see what was going on in the classrooms. He urged the Board to move Mr. Gilbert forward in the process.

Marie Rodriguez spoke in support of Mr. Woodley to fill the vacant seat. She had lived in the area since 2000 and had many grandchildren in the public schools. She knew today's students would be the ones running the schools years from now, so it was important for them to get every opportunity for a solid education. She had met Mr.

Woodley on numerous occasions and believed he was the most qualified person for the open seat because he was a testament to what public education could do.

Renee Rezentes spoke in support of Mr. Gilbert for the vacant seat on the Board of Trustees. She believed Mr. Gilbert was the best person for the position because of his experience. She felt Mr. Gilbert would provide unique insights into helping students because of his past mistakes and that he would be fair to all sides. She urged the Board to select someone who would be a fighter and make good changes in the District.

Dan Morgan spoke in support of Mr. Woodley for the vacant seat on the Board. He provided various examples of why he believed Mr. Woodley was the most appropriate person, including his service in the military, the fair practices Mr. Woodley continually upheld in the city department he ran, and his commitment and dedication to the charities he served.

Victoria Rios spoke in support of Mr. Woodley serving on the Board of Trustees. She urged the Board not to listen to the political rhetoric and select the most appropriate person for the vacant seat. She indicated diversity was important because there was not a lot of diversity on the Board already and it was critical for the make up of the Board to mirror that of the community, where diversity continued to increase.

Dr. Cesar Minera represented a network of 15 Hispanic churches in the area. He recommended the Board select Mr. Woodley for the vacant seat on the Board of Trustees. He believed Mr. Woodley was the best person for the position because of his dedication to improving all aspects of the community. He praised Mr. Woodley's ability to collaborate and work with others of various groups.

Jeff Vesley mentioned he was present because he had read an article stating Robert Beadles was threatening to sue if the Board did not select "his" candidate for the vacant seat. He urged the Trustees not to be intimidated by threats. He urged the Board to select someone who was willing to work and collaborate with all the Trustees. He did not agree with Mr. Gilbert's assessment of needing to "burn down the house" because where were the students supposed to go in the meantime. He believed the Board should select Mr. Woodley because of his problem-solving skills and new and innovative ideas.

Bruce Parks expressed frustration because he believed the Trustees had already made up their mind in who they wanted to fill the vacancy. He was frustrated because he did not believe the majority of the Trustees listened to what the people in the community were asking them to do. He claimed all the evidence showed the schools in the District were terrible and the current Board was not doing anything to improve the schools. He

believed the only candidate to come forward with a plan was Mr. Gilbert, but since that plan was not what the Board wanted to hear, they would probably not select him.

Dr. Noris Dupree spoke in support of Mr. Woodley for the vacant seat on the Board. He believed Mr. Woodley was the most qualified for the position because he understood the importance of school being the only safe place some students could go to, the only place some students received meals, and the only place where some students felt cared for. He felt Mr. Woodley was solution-focused and interested in getting the job done, not just for the students, but for the teachers and staff.

Pablo Nava Duran expressed his thoughts on each of the applicants. He indicated the only applicant he was opposed to was Mr. Gilbert. He mentioned Mr. Woodley was his first choice, followed by Ms. Beyer, Mr. Johnson, Ms. Crosby-Sturtz, and Mr. Reyes.

Trustee Smith mentioned the invitation to apply stated candidates must submit two components as part of the application. She noted there were two candidates who did not submit both components: Joseph Gilbert and John Reyes. She believed the process was clear and fair, so expecting the candidates to submit all information was an important test for her and she could not support those candidates who did not meet the requirements. She was impressed with the other candidates because they had the experience and qualifications needed to be part of the Board and make decisions impacting education.

Trustee Church highlighted that the emails to the Board appeared to be about 70% in favor of Mr. Gilbert and about 30% in favor of Mr. Woodley. He believed the Board should honor the community and move those two applicants to the interview phase of the process, then the final decision could be made. He did not think it would be fair to move additional candidates forward because the interest was really for the two applicants he had mentioned.

Trustee Rodriguez agreed with Trustee Smith in terms of what was to be submitted as part of the applicant. While he appreciated Mr. Reyes' comments, he could not support him because the application requirements were not met. He believed the Board should move three applicants forward and it would be difficult to choose from the remaining applicants.

Trustee Mayberry provided insight into what he was looking for from the applicants. He wanted someone who was interested in collaborating with the other Trustees. He appreciated the information the applicants provided at the meeting and noted the decision would be difficult because they were all qualified.

Trustee Minetto remarked that since her time on the Board, the Trustees had always removed those from consideration who did not complete the application requirements

so it was not new that some Trustees were not considering two of the applicants. The final decision would be challenging because all the applicants were extremely qualified.

Vice President Nicolet noted the Board did receive emails supporting the other candidates, not just for two applicants. She agreed the decision would be difficult because the qualifications of the applicants were excellent. She provided information on what she was looking and listening for when each applicant spoke, such as a focus on service, students and families, law and policy, and collaboration.

Vice President Nicolet recessed the meeting for 10 minutes for rankings and tabulation.

Trustee Church suggested the Board narrow the pool to two applicants to interview.

It was moved by Trustee Smith and seconded by Trustee Rodriguez that **the Board of Trustees reviewed the applications submitted to fill the vacant position in District E on the Board, and selected the following candidates to be interviewed by the Board: Meghan Beyer, Kellie Crosby-Sturtz, and Alex Woodley.** The result of the vote was 5-1: (Yea: Adam Mayberry, Ellen Minetto, Diane Nicolet, Joe Rodriguez, and Beth Smith. Nay: Jeff Church.) Final Resolution: Motion Carries.

Vice President Nicolet recessed the meeting for 5 minutes.

# 8. Reports

## 8.03 **SUPERINTENDENT'S REPORT**

Superintendent Susan Enfield reported on her activities including meetings with staff, community leaders, and the media. She thanked Emily Ellison, Chief Human Resources Officer, for her service to the District and wished her the best in her future endeavors.

# 3. Consent Agenda Items

It was moved by Trustee Rodriguez and seconded by Trustee Mayberry that **the Board of Trustees approves Consent Agenda Items 3.02 through 3.04.** The result of the vote was Unanimous: (Yea: Jeff Church, Adam Mayberry, Ellen Minetto, Diane Nicolet, Joe Rodriguez, and Beth Smith.) Final Resolution: Motion Carries.

3.02 The Board of Trustees accepted the Budget Transfer Reports and provided authorization to include budget transfers between functions or programs for the General Fund for the period October 1, 2022, through October 31, 2022, in the amount of \$232,920 and approves the transfers from the District's General Fund Contingency Account to the Assessment MAP budget for the additional costs for MAP testing (\$156,050) and to the Communications budget for the Thought Exchange subscription (\$57,600), in the official Board minutes as required by Nevada Revised Statute 354.598005.

- 3.03 The Board of Trustees approved the Award of Request for Proposal for Strategic Planning Facilitator, RFP# 51-P-09-23-AS, to Performance Fact, Inc. in the amount of \$105,000 for a term beginning December 1, 2022 and ending June 30, 2023.
- 3.04 The Board of Trustees approved the Interlocal Agreement between the City of Reno and the Washoe County School District for the 360 Blueprint Mentorship Program.

# 4. Legislative Items

4.01 PRESENTATION, DISCUSSION, AND POSSIBLE ACTION TO ADOPT AND/OR PROVIDE DIRECTION ON THE 2023 WASHOE COUNTY SCHOOL DISTRICT LEGISLATIVE PLATFORM FOR THE UPCOMING 2023 NEVADA LEGISLATIVE SESSION TO INCLUDE THE AREAS OF FUNDING, ACADEMIC SUCCESS, STUDENT & STAFF HEALTH AND SAFETY, EDUCATOR SUPPORT, AND COMMUNITY CENTERED APPROACH TO PUBLIC EDUCATION

Dylan Shaver and Tess Opferman, Pinyon Public Affairs, presented the draft 2023 Washoe County School District Legislative Platform. The purpose of the legislative platform was to provide direction to the Superintendent and District legislative team on the stance of the District on various pieces of legislation since it was not possible for the Board to review all legislation the District would take positions on. Highlights from the Platform included the District's Bill Draft Request (BDR) on systemic modernization, 10% pay increase for all education personnel, clear and forceful language regarding unfunded mandates, and creating opportunities for students to thrive on their own terms.

Trustee Rodriguez wondered why the District was only asking for a 10% increase. Mr. Shaver indicated the revenue to support a 10% increase was available and it was a sustainable amount. It was not clear if asking for a higher percentage would be sustainable.

The Trustees discussed if the 10% figure was appropriate or if the District should consider including a higher percentage. They were concerned if only 10% was requested, then school districts could end up receiving even less. Some Trustees were concerned how any additional funds would be allocated and if there were ways to ensure it would be used for a 10% across the board increase.

Trustee Church questioned if any additional funds could be used for salary increases or if the additional funds would be subject to negotiations first. He was uncomfortable approving such a request because he was not sure if he wanted to mandate the other

school districts in Nevada use additional funds just for salaries since their school boards might want to use the funding for something else.

Trustee Rodriguez asked if the Platform would allow the Board to champion other bills they were interested in supporting or if that was the purview of Pinyon Public Affairs. Mr. Shaver mentioned Pinyon Public Affairs would review legislation using the Platform as a guide. They would then submit bills to Superintendent Enfield and her team to review and determine if a supporting, neutral, or opposing should be taken on any specific bills. If the Board wanted to take a strong position, there were other avenues available that could be used.

Trustee Smith remarked that she would be interested in seeing additional language included in the Legislative Platform regarding the weighted funding formulas and how they were applied to all students, especially those who fell into more than one category, class size requirements, the funding equation used that placed Washoe County on the bottom in terms of per pupil amounts, and student behavior and discipline mandates.

Trustee Mayberry requested additional information on what a data-driven system was, competency-based learning models, and how to streamline the licensing and hiring processes without minimizing the requirements. Deputy Superintendent Keo explained the intent of a data-driven system was to leverage current assessment data, as well as other data collected by the District, and not increase the number of assessments occurring. Competency-based learning was finding ways for students to demonstrate competency in a topic or subject instead of focusing on the number of "seat" hours as a demonstration of understanding of a particular topic. In terms of streamlining the licensing process, the District wanted to make it easier for experts in Career and Technical Education (CTE) fields to become teachers.

Trustee Rodriguez wondered if there was time to make changes to the draft Platform based on the information provided during the presentation. Superintendent Enfield remarked the intent of the review was to allow staff to hear from the Trustees and gather input based on the discussion. A revised 2023 Legislative Platform could be brought back in December for final approval.

It was moved by Trustee Rodriguez and seconded by Trustee Mayberry that **the Board** of Trustees changes the 10% increase to a 20% increase and moves the location of the language to the first page of the document.

Vice President Nicolet opened the motion for discussion.

Trustee Smith indicated she would prefer to provide feedback on the Platform and then have staff present the revisions at a future meeting where the Board could provide final approval.

Vice President Nicolet remarked that she would like to have input from the Office of Business and Finance before making any final decisions.

Trustee Smith requested a friendly amendment that would allow for a proposed 20% increase to be reviewed by staff and feedback brought back, along with the final draft of the Platform, to the Board for additional review.

Trustee Church stated he was not comfortable with the 20% figure.

The motion was withdrawn by Trustee Rodriguez and seconded by Trustee Mayberry to allow for an alternative motion.

It was moved by Trustee Smith and seconded by Trustee Mayberry that the Board of Trustees directs Superintendent Enfield to explore a 20% increase with research from staff and legislative partners and bring the information back for consideration at the December 13 Regular Meeting.

Vice President Nicolet opened the motion for discussion.

Trustee Church clarified the motion was not the final motion for the agenda item.

Vice President Nicolet stated that was correct. The motion was only related to a 20% salary increase.

The result of the vote was 5-1: (Yea: Adam Mayberry, Ellen Minetto, Diane Nicolet, Joe Rodriguez, and Beth Smith. Nay: Jeff Church.) Final Resolution: Motion Carries.

The Board continued their discussion on items they would like to see as part of the Legislative Platform, including a review of the funding formula and weighted amounts, traffic safety, human trafficking, student behavior and discipline, streaming licensing, and limits on any possible new taxes. Superintendent Enfield cautioned that was important for the Platform to be broad and not focus on too many specifics. She urged the Trustees to determine if topics they were interested in could be included as part of the larger headings.

It was moved by Trustee Church and seconded by Trustee Rodriguez that **the Board of Trustees directs Superintendent Enfield to consider the opinions expressed and provides additional information at the next meeting.** The result of the vote was Unanimous: (Yea: Jeff Church, Adam Mayberry, Ellen Minetto, Diane Nicolet, Joe Rodriguez, and Beth Smith.) Final Resolution: Motion Carries.

#### 5. Finance Items

# 5.01 PRESENTATION AND DISCUSSION ON THE FISCAL YEAR 2023-24 BUDGET PROCESS AND 4-YEAR FINANCIAL PLAN

Mark Mathers, Chief Financial Officer, and Jeff Bozzo, Budget Director, provided a presentation on the development of the District's budget, the Pupil Centered Funding Plan (PCFP), the State Education Fund, and the creation of a 4-year financial plan. If the state adhered to the spirit of the PCFP, the District should see an increase in revenue because of the strength of the economy. The impacts of a possible recession on the State Education Fund and State General Fund were reviewed. Policy questions related to the development of the State Education Fund were posed. The outlook for the District's Fiscal Year 2024 budget was presented.

Vice President Nicolet asked what the state budget process was like with a new governor. Mr. Mathers explained a new governor did not have the opportunity to provide a lot of input into the new budget because they took office in January and the legislative session began in February. New governors were forced to heavily rely on the prior governor's recommended budget, which was based on the projections from the Economic Forum made in early December.

Vice President Nicolet recessed the meeting for 20 minutes.

Adam Searcy, Chief Operations Officer, explained the 2022/23 'A' Major Projects Program was presented to and approved by the Capital Funding Protection Committee in September 2022. The Program included one project, which was a new elementary school in the north Spanish Springs area. The current and projected growth in the community and elementary school enrollment for the area was reviewed. He noted the District did not want to build new schools unless they were absolutely necessary. The budget for the Program was for the design phase only. The District would continue to monitor the growth and re-evaluate the project prior to presenting any item to begin construction.

Trustee Church inquired about the capacity of John C. Bohach Elementary School. Mr. Searcy stated the capacity of the school was about 715 students. The current enrollment of the school was 800 students.

Trustee Rodriguez thanked staff for bringing the recommendation. He highlighted that the Spanish Springs and the North Valleys areas were the fastest growing sections of Washoe County.

It was moved by Trustee Rodriguez and seconded by Trustee Mayberry that **the Board of Trustees approves the Washoe County School District Capital Improvement Program, to include the 2022/23 'A' Major Projects Program in the amount of \$3,000,000 to provide for projects throughout the District.** The result of the vote was Unanimous: (Yea: Jeff Church, Adam Mayberry, Ellen Minetto, Diane Nicolet, Joe Rodriguez, and Beth Smith.) Final Resolution: Motion Carries.

6.02 QUALITY OF EDUCATION - REVIEW OF SMARTER BALANCED ASSESSMENT (SBA) MATHEMATICS DATA IN GRADES THREE TO EIGHT AND HOW THE WASHOE COUNTY SCHOOL DISTRICT (WCSD) USES THE INFORMATION TO IMPROVE STUDENT LEARNING OUTCOMES IN OUR SCHOOLS

Dr. Troy Parks, Chief Academic Officer, and Joe Ernst, Chief Accountability Officer, provided a presentation on Smarter Balanced Assessment (SBA) math data in grades 3 through 8 and some high school math data. The District numbers mirrored the national trends occurring, which was that the 2021-22 School Year numbers had increased 3 percentage points from the 2020-21 School Year, but the numbers were still down 6 percentage points from the 2018-19 School Year or pre-pandemic levels. The math learning recovery from the learning loss related to the pandemic was not occurring as quickly as the English Language Arts (ELA) data. The math data was reviewed by subpopulation to show there were clear disparities and gaps, which had increased during the pandemic, that had to be addressed. The District data was compared with the State of Nevada data, state charter school data, Clark County School District data, and data from other states who participated in SBA. High school math data was reviewed. Information on how the District was working to improve math pathways to create a smooth transition from middle school math to high school math. The District was also looking at developing equitable grading practices aligned to the essential standards, so students were able to show progress and achieve a passing grade, even if they did not master the standards. The strategies to addressing the challenges were presented.

Vice President Nicolet asked if District-sponsored charter schools were included as part of the District data or as part of the state charter school data. Mr. Ernst indicated the

individual school district-sponsored charter schools were included as part of the state's data, but were not included as part of either the state charter school data or the individual school districts' data.

Trustee Smith appreciated the comparison with other states because it showed the District was tracking with everyone else. She did want to see improvement in the scores, but she took some comfort in knowing what was occurring in the District was occurring elsewhere in the country.

Superintendent Enfield provided additional information on the use of SBA and why there were many across the country interested in looking at other ways to measure learning outcomes. One area she was interested in having additional conversations about was using a growth measure that would show where a students began and where they ended up.

Trustee Smith requested additional information on how the District was aligning middle school math classes to ensure they were setting students up for success in high school. Dr. Parks explained the reason for the intense focus on the essential standards for middle school math was to help set the students up for success. The District held deliberate conversations with high school math teachers and 8<sup>th</sup> grade math teachers to ensure the skills needed to be successful in algebra and geometry were taught in 8<sup>th</sup> grade. The District was hoping to see the results of those conversations soon.

Vice President Nicolet highlighted it was important to start working on the skills needed for algebra and higher math sooner the 8<sup>th</sup> grade. She would like to see a greater focus beginning in 3<sup>rd</sup> and 4<sup>th</sup> grades since that appeared to be where the decline in achievement began.

Trustee Church expressed disgust that 66% of students did not meet the standards. He felt the agenda item should be an action item so the Board could provide direction on what should be done to improve scores. He did not believe the District was doing enough to address the problems and a committee on education should be established by the Board. He was also interested in addressing drug testing, chronic absenteeism, community involvement, and other areas. He did not understand how 66% of students were not meeting standards and the District had a graduate rate of 85%.

Trustee Mayberry asked if SBA, which was required by the state, aligned with the District's curriculum. Mr. Ernst stated the state and District standards were aligned with SBA; however, he was concerned with the rigor with which the standards were assessed. The problems included on the assessments were extremely complex and he believed all school districts were working to improve the rigor on the curriculum that was previously based on the state criterion tests.

Superintendent Enfield cautioned the Trustees and community not to use a single data point to measure the success of a student. The story of a student's success was not based on one test but on the culmination of their years in school. It was important to think broadly when it came to student success.

Dear Trustees and board members,

In 2017, the <u>Nevada legislature</u> looked at the time schools must dedicate to testing in our state. In support of <u>SB303</u>, Senator Woodhouse stated, "These tests have become an impediment to doing the underlying activity they were intended to measure—the education of our children."

WCSD teacher, and now Assemblywoman Natha Anderson, submitted the <a href="SBAC">SBAC</a> schedule at Pine Middle School as evidence. She showed how 9 weeks of their school year is disrupted due to SBAC testing. Students and educators from all over Nevada <a href="testified">testified</a> the harmful effects of the amount of testing we do in Nevada. Students testified how pressured they felt to do well on SBACs, many to the point of tears. Teachers testified how testing cuts into instructional time, forced librarians to close libraries for testing, and removed support professionals (like SPED para-professionals and counselors) away from their duties to help with test administration. (If you haven't watched these <a href="testimonies">testimonies</a>, I highly urge you to do so.)

As a former educator myself with K-12 experience in three different Nevada districts, I have seen the negative impact over-emphasis on high stakes and standardized tests have, not only on our students but on the profession of teaching.

In 2019, <u>an audit</u> was done on the amount of testing that occurs in Nevada. The report found that 84% of Nevada District Test Directors stated too much time was spent on the Smarter Balanced Assessment (SBAC).

Despite this, unfortunately our legislature did not choose to limit the emphasis on high stake testing.

Although the time taken on tests like the SBACS are a concern, the use of SBAC scores themselves is just as concerning. For a long time, states and districts have used high stakes tests to drive curriculum and instruction. The punitive consequences of low scores on these exams makes it unreliable as a measure of teacher effectiveness or student achievement. Focus on raising test scores inhibits academic growth rather than raising it: content and teaching is narrowed to what is tested and <u>instructional pacing</u> is aligned to test schedules, not student understanding of content. Temporary gains in test scores hide the lack of long-term significant growth, especially for ELL, IEP, FRL, and minority students. These effects are especially damaging to students already struggling who desperately need more meaningful instructional time aimed at growth not common standards. Likewise, high SBAC scores may hide the lack of growth for GT students.

Yes, we need to know how students are doing, but the SBAC exam does very little to inform parents and teachers as to what students need. Test scores are not available until after class placement is assigned and students have graduated on to the next grade level. More holistic data is already available and can provide a better understanding of where our students stand.

From <u>2018 – 2021</u> levels of staff stress have climbed significantly. In 2018, 44% of all staff felt burnt out. In 2021, that number jumped to 57%. In 2018, 39% said they don't know if they'll make it to retirement. Now the number has jumped to 49%. It is imperative that the district focus on those things that will reduce work level stress and increase retention. More training will not resolve the issues of large class sizes and inadequate prep time. Teaching assignments in the classroom should be prioritized.

Although the SBAC exams are mandated by the state, the Board could take three actions:

- Acknowledge the shortcomings of the SBACs publicly and resist making policy based on these scores alone.
- Work with other districts to push for change at the legislative level. In other states, such as Florida, groups of school boards have come together to demand a reduction in mandated standardized high stakes testing in schools. This would be a show of alliance with educators and families who have trying to fight back against the increasing amount of time our students must spend taking tests instead of learning.
- Question any district policies that encourage teachers and admin to structure instruction based on test content, such as more rigid alignment with SBAC content and rigid adherence to pacing guides based on test schedules.

Students are still struggling from the after effects of the pandemic, and teachers are trying to fill learning gaps caused by over a year of academic and social interruption. Now more than ever, our district needs to focus on those things which do lead to student learning and teacher retention.

As over <u>100 educational researchers</u> stated in a 2016 report on California's use of the SBAC, "Testing is not the magic bullet for school improvement."
