### Washoe Inspire Academy Parent and Family Engagement Policy/Plan and Procedures

Washoe Inspire Academy is committed to the goal of providing quality education for every child in our school. To this end, we want to establish partnerships with parents and with the community. Everyone gains if Washoe Inspire Academy and the student's family work together to promote high achievement. Caregivers play an extremely important role as children's first teachers and Washoe Inspire Academy prioritizes support for families by working with them every step of the way to identify needs and connect them with community partners.

Washoe Inspire Academy recognizes some students may need the extra assistance available through the Title I program to reach the state's high academic standards. Washoe Inspire Academy intends to include parents in all aspects of the school's Title I program. The goal is a school-home partnership that will help all students succeed.

## PART I-SCHOOL PARENT AND FAMILY ENGAGEMENT POLICY/PLAN REQUIRED COMPONENTS

Washoe Inspire will hold individual parent conferences such as intake meetings, pathway transition meetings, and behavior and academic meetings with each of its students during the time the student is at Inspire. The purpose of these conferences will be to set goals for school and for home and to design a plan to help the students be successful in attaining these goals. Each teacher from Washoe

Inspire will be invited to attend these parent conferences so parents can be made aware of student progress and can build positive parent-teacher relationships.

Staff at Washoe Inspire Academy will offer parent home visits with each student, subject to the family's willingness to attend these voluntary visits.

Involve parents, in an organized, ongoing, and timely way, in the planning, review, and improvement of the school plan under Section 1112, school wide under Section 1114, and the process of the school review and improvement under Section 1116.

Family inclusive events will be conducted throughout the year so all families can review and provide feedback on the Family Engagement Plan. The Parent and Family Engagement Plan will also be posted on the website for parent review.

Families will be a vital part in the development and revision of Washoe Inspire's Parent and Family Engagement Policy. Throughout the year, as parent conferences are being held, parents will be asked to give their ideas and reflections into our Parent and Family Engagement Policy.

Families of participating children will be given timely information about graduation requirements, community resources, behavior expectations.

Families will be provided a description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the proficiency levels students are expected to meet.

Families are encouraged to contact the classroom teacher directly with questions or concerns about their child.

Families are invited to see administration if contacting the classroom teacher does not resolve their questions and concerns.

Families are always welcome to observe in their child's classroom

School will communicate with families about school programs through progress reports, conferences, and phone calls.

Curriculum, assessment, and proficiency levels will be explained as needed throughout the school year.

Parent comments/concerns collected at Annual Title I Meeting, through the yearly Parent/ Family climate survey, and through Family contact with the school.

If a parent is not satisfied with SPP, their comments will be submitted to the district along with the plan. Parent comments will be included in the Parent Engagement Plan before presenting the plan to the school district.

To ensure effective involvement of the school, parents, and community involved, each school and district must:

Washoe Inspire will use state academic standards for blended curriculum along with Edgenuity. Parents can log-in to Infinite Campus and online Edgenuity courses to track progress and progress will also be reviewed at student's goal setting meetings.

Provide materials and training to help parents to work with their children, such as literacy training and using technology (including education about the harms of copyright piracy).

Materials will be provided to parents at the goal setting meetings. Parents and students will have access to information through a variety of media such as Email, Phone Calls, Edgenuity, and Connect Ed.

Provide professional development to teachers, specialized instructional personnel, and other staff on the value of parent and their communities to increase academic achievement.

Staff members will receive professional development regarding the importance of academic achievement and parent involvement through Wednesday PLCs and professional learning opportunities, emails, and other outlets.

Staff will implement SEL strategies in the classroom and provide students with regular SEL lessons. Restorative Circles will be used to focus on the Washoe Inspire community and to support each individual student.

Coordinate and integrate parent engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support family engagement.

Information from community organizations such as Project 150, Washoe County Library Services, Family Resource Center, and Children in Transition will be provided to the parents. Parents and students will have access to food, clothing, and other items through the Food Bank of Northern Nevada and Project 150. All families will be given information about any upcoming family engagement programing.

Ensure that information related to school and parent programs, meetings, and other activities is sent to the parents of participating children in a format and, to the extent practicable, in a language the parents can understand.

Our events will be communicated to parents in both English and Spanish using the assistance of translators, Connect Ed calls, email, monthly newsletter, and translated materials. Information will be provided during Parent Nights and home visits regarding activities occurring in the area.

Students will receive classroom progress reports as needed and WCSD report cards quarterly to inform parents of current academic achievement or concerns.

To enhance communication with our parents/guardians and respect our non- or limited-English speaking families, translations of written material and interpreters for meetings and conferences are available.

All Connect-Ed messages from the telephone system will be sent to homes in English or Spanish, depending on the home language preference.

Washoe Inspire will have a full time Teacher or Dean who acts as the FACE Liaison (Family and Community Engagement Liaison) who is available during school hours

The following are allowable activities:

May involve parents in the development of training for teachers, principals, and other educators to improve the effectiveness of such training. Allow opportunities for parents to share their knowledge of available community resources.

May provide necessary literacy training from funds received under this part if the district has exhausted all other reasonably available sources of funding for such training.

May pay reasonable and necessary expenses associated with local Parent and Family Engagement activities, including transportation and childcare costs, to enable parents to participate in school-related meetings and training sessions. Parent University provides transportation and interpreters for all their workshops.

May train parents to enhance the involvement of other parents.

May arrange school meetings at a variety of times, or conduct in-home conferences between teachers or other educators, who work directly with participating children, with parents who are unable to attend such conferences at school, in order to maximize Parent and Family Engagement and participation. Phone calls and/or home visits will be conducted when parent is unable to attend conference week.

May adopt and implement model approaches to improving Parent and Family Engagement.

May establish a district parent advisory council to provide advice on all matters related to Parent and Family Engagement in programs supported under this section.

May develop appropriate roles for community-based organizations and businesses in Parent and Family Engagement activities. Provide facilitators such as, children's cabinet, food bank (smart shoppers).
