With the High School Facility Benchmark top worse schools in overall adequacy are Wooster, Sparks, Reed, and McQueen, placing Wooster as the focus. In the Middle School facility Benchmark top worse in overall adequacy Vaughn, Dilworth, Sparks MS, placing Vaughn as the focus. Elementary School Benchmark the top worse in overall adequacy Lemmon Valley, Hunter Lake, Maxwell, Warner, Stead, Gomm and Peavine. **Charlene Bybee**, asked why is it that Sky Ranch came in with a red on technology and furniture when it is a brand-new school? **Paul Mill** stated that these are preliminary findings, there are categorical changes since they are still crunching numbers.

- improves facilities in poorest condition,

The least educationally adequate of WCSD middle schools: Undersized classrooms, Insufficient facilities for Special Education, Insufficient facilities for STEM, Arts, and physical fitness, No flexible spaces for learning interventions and enrichment. Insufficient space for collaboration and counselling, Challenging street drop-off

improves utilization and operational efficiency

Step in the right direction: Right-sizes one of the smallest, least operationally efficient middle schools in WCSD. Replaces one of the least energy efficient schools.

#### doesn't limit other options

Consistent with districtwide capacity strategy: Single-school campus will not limit options. Economically feasible with WC1, \$15M deferred maintenance cost avoidance.

#### shovel ready achievable by 2025.

Proven solution: Meets 2025 school opening. Lessons learned from O'Brien experience. Safe, less disruptive construction separated from occupied school.

#### The Recommendation is the following:

- Proceed immediately with procurement of A&E design and CM services to rebuild Vaughn on the same site.
- School remains in operation during construction separated with safety barriers
- Demolition of existing building and new playfields after the move-in.

**Justin Ivory** asked if they would be looking into a renovation like the one at Swope or would it be something more like O'Brien, new building.

**Paul Mills** stated that for a renovation like Swope due to the conditions of the building and to bring it up to date with no increase of space for more students the dollar amount would be approximately between \$50-\$70m. The better solution would be the O'Brien way, rebuild, bring students in and demolish the building adding space for more students.

**Charlene Bybee** asked what would the new building capacity be?

**Adam Searcy** stated the capacity would be in the approximation of 1400 student range.

Adam Searcy states that the participation in the analysis and presentation from Canon that a rebuild of Vaughn Middle School is justified recommendation. In support of that we are bringing forward a budgetary recommendation of \$3.5 million that represents a partial funding of the design phase that allows to begin that work initially and carry through the end of the fiscal year, to try and cause that project to open as soon as the 2025/2026 school year.

**Andrew Diss,** Vaughn is the partner in education of the Grand Sierra and has been for years. A large portion of kids who go to school there are children of our team members at GSR and I make several visits along with a lot of people that I work with to Vaughn and we tried to do what we can to help them out because as Mr. Mills made clear that school needs a lot of love.

**Mr. Diss** would like to recommend the approval of \$3.5 million dollars to the 2022/2023 B Major Projects program into forward recommendation to a future meeting of the Board of Trustees.

**Mr. Anderson** seconds the motion.
