Possible benefit changes being discussed may include, but are not limited to; out-of-pocket Max, Deductibles, Primary Care Physician Visits Co-Pay, Specialist Office Visit Co-Pay, Emergency Room Co-Pay, Urgent Care Co-Pay, Carryover Deductible, placing new hires on the high deductible health care plan for the first two years of employment, Generic and Brand Retail Prescription Co-pay, Generic and Brand Mail Order Prescription Co-Pay and Co-Pays for 90 Day Retail Prescriptions - presented by LP Insurance.
