

## Thursday, May 27, 2021 Group Insurance Committee Meeting

DUE TO EVOLVING CONCERNS FOR PUBLIC SAFETY RESULTING FROM THE COVID-19 EMERGENCY AND PURSUANT TO THE GOVERNOR OF NEVADA'S DECLARATION OF EMERGENCY DIRECTIVE 006 SECTION 1 (EXTENDED BY LATER DIRECTIVES THE MOST RECENT OF WHICH IS DIRECTIVE 044), WHICH SUSPENDS THE REQUIREMENT IN NRS 241.023(1)(B) THAT THERE BE A PHYSICAL LOCATION DESIGNATED FOR MEETINGS OF PUBLIC BODIES WHERE MEMBERS OF THE PUBLIC ARE PERMITTED TO ATTEND AND PARTICIPATE, MEETINGS MAY BE HELD BY TELECONFERENCE ONLY.
