2.03 PRESENTATION AND DISCUSSION OF WASHOE COUNTY SCHOOL DISTRICT GROUP INSURANCE INTERNAL SERVICE FUND AS OF JUNE 2021 (For Discussion Only)

Jessica Young, Controller, reviewed the Health Insurance Internal Service Fund statement as of June 2021, and compared against the statement of June 2020. According to the comparative statement of net assets as of June 2021, the total assets were \$45,871,399 as compared to \$40,450,119 at the same time last year. Total liabilities were \$8,216,550 as compared to \$11,632,832 last year. The total net position as of June 2021 was \$37,753,694 as compared to \$28,918,238, an increase.

2.04 Presentation and Discussion of Washoe County School District Health Insurance Internal Service Fund rate stabilization concepts and health insurance internal service fund concepts (FOR PRESENTATION AND DISCUSSION ONLY)

Laura Thurston, Risk Coordinator, discussed the District is moving into a healthier season with the fund. Ms. Thurston mentioned the District is looking into exploring strategies to keep rates stable for the future. Lloyd Barnes, LP Insurance representative, discussed Rate Stabilization and Catastrophic Claims fund concepts.

2.05 PRESENTATION AND DISCUSSION OF WASHOE COUNTY SCHOOL DISTRICT GROUP INSURANCE CLAIMS EXPERIENCE REPORT AS OF AUGUST 2021 (For Discussion Only)

Lloyd Barnes, LP Insurance representative, discussed the Average Monthly Comparison which provides data to include active enrollment of employees and dependents; claims

from medical, prescription, dental, and vision; and specific utilization from medical and pharmacy categories such as emergency, lab x-ray, pharmacy, urgent care, etc.. Mr. Barnes also discussed the number of hospital admits for the current year, the average cost per inpatient/outpatient admits and average days per inpatient/outpatient stays.

2.06 PRESENTATION AND DISCUSSION OF WASHOE COUNTY SCHOOL DISTRICT GROUP INSURANCE ANTHEM CLAIMS ACTIVITY AND TURNAROUND REPORTS AS OF AUGUST 2021 (For Discussion Only)

Pamela Davidson, Account Manager for Anthem, reviewed the claims experience report through August 2021. It is the goal of Anthem to process claims within 30 days. For the month of August claims were processed within 60 days at a rate of 99.6%.

Ms. Davidson reviewed the current percentages for claims paid within 30 days for the PPO Dental, PPO Medical, HSA Dental, HSA Medical, PPO Dental, and PPO Medical.

2.07 Presentation and Discussion of Washoe County School District Group Insurance Wellness Program Report to cover current events and programs, as of August 2021 (FOR INFORMATION AND DISCUSSION ONLY)

Laura Thurston, Risk Coordinator discussed, the Health Assessment and Wellness program refresh starting August 1, 2021, the deadline to complete the Health Assessment is December 1, 2021. Ms. Thurston also discussed Wellness Screenings will be available August 1, 2021 to November 15, 2021 by appointments with Specialty Health and Lab Corp and available immunizations. Ms. Thurston discussed the Fall Step A-Thon Challenge which will run from October 18, 2021 to November 8, 2021.
