MINUTES OF THE MEETING OF THE WASHOE COUNTY SCHOOL DISTRICT SEXUALITY, HEALTH AND RESPONSIBILITY EDUCATION ADVISORY COMMITTEE

October 12, 2020

1. Opening Items

1.01 Call to Order

The meeting of the Sexuality, Health and Responsibility Education (SHARE) Advisory Committee was called to order at 5:32 p.m. Due to the COVID-19 health emergency declared by Governor Sisolak and consistent with current guidelines and directives, the meeting was conducted virtually.

1.03 Action to Adopt the Agenda

Fourth (4th) Grade Curriculum video library to remove the existing WCSD 4th Grade SHARE Curriculum videos and replace the current WCSD 4th Grade SHARE Curriculum videos with three updated videos to be used with the existing WCSD 4th Grade SHARE Curriculum The Proposed Video Replacements include: Always Changing and Growing Up/Boys (https://youtu.be/G57Sug7JpQE), Always Changing and Growing up/Girls (https://youtu.be /OR1XJZ0xRSo), Making Tough Choices with Kid President https://youtu.be/gdsCUExLE-Y); and Possible Action to either Recommend Adoption of the proposed videos to be used with the existing WCSD 4th Grade SHARE Curriculum and Deletion of the Existing Curriculum 4th Grade SHARE videos by the WCSD Board of Trustees or Recommend Revisions of the 4th Grade **SHARE Curriculum video library to the SHARE Coordinator for Future** Additional Consideration by the SHARE Advisory Committee.

It was moved by Committee Member Ashley Wade and seconded by Committee Member Kelly Roper that the SHARE Advisory Committee recommends to the Board of Trustees that we remove the current videos from the curriculum and replace them with the three videos outlined, Always Changing and Growing for Boys, Always Changing and Growing Up for Girls, and Making Tough Choices with Kid President, with the stipulation that the teachers end the first video at 14 minutes, 20 seconds, the second video at 16 minutes, 20 seconds, and the third video at four minutes, 30 seconds in an effort to remove advertising from the classroom.

Committee Member Tanja Hayes suggested a friendly amendment, to add a talking point after the Always Changing and Growing Up Girls to mention or discuss the fact that different types of hair might need to be washed at different frequencies, and it's okay no matter how you do it.

Committee Member Manny Magana suggested a friendly amendment, at the end of each of these videos to remind students that their counseling team is also somebody that they can go to within the school.

It was moved by Committee Member Manny Magana and seconded by Committee Member Ashley Wade that the SHARE Advisory Committee recommends the removal of the existing sixth grade shared curriculum videos and replace them with the two videos that were proposed to us, which are sex education for in S puberty. I do believe that's middle school puberty and then understanding HIV AIDS, learning the facts, fight the stigma, stay safe, with the advisement that the first video be cuts off at 14:50. It was moved by Committee Member Tanja Hayes and seconded by Committee Member Manny Magana to amend the motion, **to cut off the video sex education for middle school video two puberty at 14:57, so as to included the website, kidshealth.org.** The result of the vote was Unanimous: Pass (Yea: Lydia DeFlorio, Tanja Hayes, Sara Kiser, Manuel Magana, Kelly Roper, Andrea Thompson, Ashley Wade, and Rabbi Benjamin Zober.) 2.05 Presentation and Discussion of the Proposed Sexuality, Health, and Responsibility Education (S.H.A.R.E.) Seventh (7th) Grade Curriculum, to include Lesson Plans and Accompanying PowerPoint Presentation Materials, for Draft Lesson Abstinence, Contraceptives and Sexually Transmitted Infections (STIs), (as indicated in Attachment A to this agenda) and the concepts proposed to include: Abstinence, Birth Control Methods, Emergency

Contraception, Sexually Transmitted Infections and HIV Transmission, Local Resources for STD Treatment and Testing, and the Inclusion of One Video: Sex Education for Middle School Video 3 - Sex, Contraception and STIs (https://youtu.be/cml6eJNEyowz); and Possible Action to either Recommend Adoption of the Proposed Curriculum, with any Additional Revisions, and Deletion of the Existing Curriculum Related to the 7th Grade SHARE Curriculum Lesson Abstinence, Contraceptives and Sexually Transmitted Infections by the WCSD Board of Trustees or Recommend Revisions to the 7th Grade Draft SHARE Lesson Abstinence, Contraceptives and Sexually Transmitted Infections (STIs) to the S.H.A.R.E. Coordinator for Future Additional Consideration by the S.H.A.R.E. Advisory Committee.

It was moved by Committee Member Andrea Thompson and seconded by Committee Member Tanja Hayes that the SHARE Advisory Committee recommends. To send back to Rochelle Proctor for the following changes so that we may review, we have high STI risk, low STI risk, no STI risk, instead of simple high risk, low risk and no risk on slide three, we remove the phrase where it says, do something sexual. We instead replace that with certain sexual activities with that person. Remove scabies from the worksheets. However, we also want to make sure that we mentioned that scabies can be spread through non-sexual contact. And we also want to add on when it talks about low risk activities for STDs that we add the inclusion of non-latex condoms also.

Committee Member Kelly Roper suggested a friendly amendment, to remove bathing together and we remove mutual masturbation from no risk behaviors.

The maker of the motion, Manny Magana, did not accepted the amendment.

Committee Member Sara Kiser suggested a friendly amendment, STD be amended to STI throughout the lesson.

The maker of the motion, Manny Magana, and the seconder, Tanja Hayes, accepted the amendment.

Committee Member Ashley Wade suggested a friendly amendment, to send changes to the Board.

The maker of the motion, Manny Magana, and the seconder, Tanja Hayes, accepted the amendment.

It was moved by Committee Member Manny Magana and seconded by Committee Member Tanja Hayes that **the SHARE Advisory Committee recommends. To send changes to**

the Board. Have high STI risk, low STI risk, no STI risk, instead of simple high risk, low risk and no risk on slide three, we remove the phrase where it says, do something sexual. We instead replace with certain sexual activities with that person. Remove scabies from the worksheets. However, we also want to make sure that we mentioned that scabies can be spread through non-sexual contact. And we also want to add on when it talks about low risk activities for STDs that we add the inclusion of non-latex condoms, and STD be amended to STI throughout the lesson. Seventh (7th) Grade Curriculum, to include Lesson Plans and Accompanying PowerPoint Presentation Materials, for Draft Lesson Reproduction and Sexual Health, (as indicated in attachment A to this agenda) and the Concepts Proposed to Include: Review Of Biological Male And Biological Female Reproductive Systems, the Process of Human Reproduction And Conception, Define Sexual Intercourse, and the Inclusion of Two Videos: Sex Education for Middle School -Bodv (https://youtu.be/D6ABqVHNRWc) and Human Journey in the Womb (https://youtu.be/IdYX CkgJO0); and Possible Action to either Recommend Adoption of the Proposed Curriculum, with any Additional Revisions, and Deletion of the Existing 7th Grade SHARE Curriculum Lesson Related to the Reproductive Systems of the Biological Male and Biological Female and the Process of Human Reproduction and Conception, by the WCSD Board of Trustees or Recommend Revisions to the 7th Grade Draft SHARE Lesson Reproduction and Sexual Health to the S.H.A.R.E. Third, to allow the teacher to make the best decision on how to do the activity to help the students answer the questions on slide three.

The maker of the motion, Andrea Thompson, did not accepted the second amendment.
