1. Opening Items

Seventh (7th) Grade **Curriculum, to include Lesson Plans and Accompanying PowerPoint** Presentation Materials, for Draft Lesson Healthy Relationships (as indicated on attachment A to the agenda), and the concepts proposed to include: Healthy Relationships, Setting Boundaries, Consent, Local Resources for Relationship Issues, and the Inclusion of Two Videos: Teen Voices: Friendships and Boundaries (https://youtu.be/yjzGxLg1Dgs) and What Makes a Relationship Healthy (https://youtu.be/UB9anEZx9LU); and Possible Action to either Recommend Adoption of the Proposed Curriculum, with any Additional Revisions, and Deletion of the Existing Curriculum Related to the 7th Grade SHARE Curriculum Healthy Relationships by the **WCSD Board of Trustees or Recommend Revisions to the 7th Grade** Draft S.H.A.R.E. Seventh (7th) Grade Curriculum for Draft Lesson Reproduction and Sexual Health and proposed videos Sex Education for Middle School-Body Basics (https://youtu.be/D6ABgVHNRWc) and Human Journey in the Womb (thttps://youtu.be/IdYX_CkgJOO); and Deletion of the Existing 7th Grade Curriculum related to Reproduction and Sexual Health or Recommend Further Edits to the Revisions to the S.H.A.R.E. Coordinator.

It was moved by Committee Member Sara Kiser and seconded by Committee Member Kelly Roper that the SHARE Advisory Committee recommends the adoption of the proposed seventh grade curriculum, reproduction and sexual health, to the Washoe County School District Board of Trustees on the provision that Rochelle adds some instructional information for the teachers about clarifying The contraceptives, the efficacy of contraceptives and what dual use means. The result of the vote was Unanimous: Pass (Yea: Lydia DeFlorio, Tanja Hayes, Sara Kiser, Manuel Magana, Kelly Roper, Andrea Thompson, Ashley Wade, and Rabbi Benjamin Zober.) Final Resolution: 8 0, Motion Carries.

2.04 Presentation and Discussion of the Current Sexuality, Health, and Responsibility Education (S.H.A.R.E.) Washoe County School District (WCSD) Definition of Abstinence, to Include Reviewing the Currently Used Definition and the Possibility of Changing the Language in the Current Definition; and Possible Action to Recommend Adoption of the Definition of Abstinence with Committee Edits to the Language of the Definition and apply the revised definition to all WCSD S.H.A.R.E curriculum referencing the definition of Abstinence, by the WCSD Board of Trustees.

It was moved by Committee Member Kelly Roper and seconded by Committee Member Tanya Hayes that the SHARE Advisory Committee recommends amending the Washoe County School District definition of abstinence, by adding a sub bullet to sub bullet SEX. Saying pregnancy, most commonly results from vaginal sex. The new definition will apply to all the lessons that have already been newly written as well as elementary school lessons. The result of the vote was Unanimous: Pass (Yea: Lydia DeFlorio, Tanja Hayes, Sara Kiser, Manuel Magana, Kelly Roper, Andrea Thompson, Ashley Wade, and Rabbi Benjamin Zober.) Final Resolution: 8 0, Motion Carries.
