RE: **PERS CONTRIBUTION INCREASES/SALARY
SCHEDULE ADJUSTMENTS**

We would like to share information we have received from the State of Nevada Public Employees' Retirement System (PERS) Retirement Board. The PERS Retirement Board has informed WCSD that the contribution rates for all members (employees) are scheduled to increase for all contribution plans, effective July 1, 2023. The impact of this action is that, effective July 2023, all salary schedules and/or PERS contributions will be adjusted as outlined below:

WESP Employer and Employee Paid (Classified/ESP)	8/9/2023	15.50%	17.50%	2% Increase in PERS Deduction; No Salary Reduction

These adjustments are being made in accordance with and as mandated by NRS 286.421, which requires WCSD and employees to equally absorb the costs associated with these PERS contribution increases. You may be aware that in 2021 a PERS increase was also implemented.

An example of the impact these deductions will have for an employee on an employer paid salary schedule, with an increase in the PERS contribution rate from 29.75% to 33.50%, is as follows:

Current Monthly Salary:	\$3,000
New Monthly Salary:	\$2,943.75 (\$3,000 reduced by 1.875% = \$2,943.75)

Please note that we have been in contact with the Association Presidents regarding these adjustments and informed them of the impending increases. We understand the impact that this PERS change has on your take-home pay and apologize that this action is unavoidable. Please know that we will continue to advocate for greater funding levels from the State to school districts in Nevada in order to secure greater compensation for our staff. These changes are set to take place on the dates outlined above provided there are no changes legislatively. Please also note that these changes are in regard to the PERS increase only. The final impact on salary will be based on any salary changes negotiated for 2023-24.

NV PERS regularly schedule informational program sessions to provide a general overview of PERS and discuss upcoming changes.
