**DATE REPORT WRITTEN:** January 15, 2019

**SUMMARY**: The Board will receive an update on the budget process for Fiscal Year 2019-20, including analyses of certain issues requested by the Board on September 25, 2018.

**ADDITIONAL BACKGROUND INFORMATION:** Nevada Revised Statutes require the District to file annual budgets. On September 25, 2018, the Board conducted a workshop related to financial results for Fiscal Year 2017-18 and the Fiscal Year 2019-20 budget. At the workshop, the Board's questions included:

- 1. Look at how we might staff schools differently to close achievement gaps
- 2. High school transportation can we look at different regions for our high school teams to reduce transportation mileage for sports events
- 3. Examine costs to see if we can charge them to bond funds (WC1)
- 4. Look at contracted services (consulting services) to reduce costs, instead of reduction District positions
- 5. Review usage of District take-home vehicles
- 6. Review fees for transportation athletic expenses

Staff will report on Item #3 and provide updates on other items.
