TITLE: UPDATE AND DISCUSSION OF THE 2019-20 FISCAL YEAR BUDGET AND PROCESS MOVING FORWARD (FOR DISCUSSION AND POSSIBLE ACTION)

SUMMARY: The Board will receive an update on the Fiscal Year 2019-20 budget including information on proposed program reductions that departments have indicated have a minimal to moderate impact, analysis of the General Fund's fund balance, and possibly new information impacting the budget since the previous update. The Board may provide direction on the remaining options to reduce the budget, and there will be a discussion of the budget process moving forward.

ADDITIONAL BACKGROUND INFORMATION: At the February 26, 2019 budget work session, the Board was presented information regarding the District's ongoing structural deficit, results of the Priority Based Budgeting (PBB) process, and how those results could be used in developing possible options to reduce the deficit. None of the options are preferred and many of the options result in deep reductions to those programs. However, without additional funding, a reduction to the District's expenses is the only way to meet the Board's policy of eliminating the budget deficit.

Therefore, staff will seek direction from the Board regarding a process for consideration of additional reductions to ultimately balance the budget. Prior to this discussion, staff will present a summary of program reductions presented on February 26 that departments have indicated have a minimal to moderate impact. Staff will also provide a projection of the fund balance for the General Fund.

Nevada Revised Statute (NRS) 354.596 and 354.598 require a tentative budget be filed on or before April 15th and requires the Board to give notice of a time and

place of a public hearing on the tentative budget no sooner than the third Monday in May and no later than the last day of May and final budgets of school districts to be adopted on or before June 8th of each year. Statute also allows the District 30 days after the close of a Legislative Session to submit an Amended Final Budget if increases or decreases to revenues are not included in the final budget.
