

# Friday, May 21, 2021 Work Session of the Board of Trustees

The Board will make reasonable efforts to provide appropriate space for all members of the public consistent with the Governor's Directive 045 and the Washoe County Local Authority Plan - Roadmap to Recovery Mitigation Measures. The Washoe County School District may be more restrictive than the standards required by statewide and county local authority plan. Public gatherings are restricted to no more than 250 individuals or 50 percent of fire code capacity, whichever is less, under strict social distancing requirements. The District will provide the public the ability to view the meeting from another room, if needed, and that room will not exceed 50% capacity.

Further, in order to protect the health, safety, and welfare of all members of the general public, staff, and the Trustees as well as commiserate with the Governor's Directives and the Washoe County Local Authority Plan - Roadmap to Recovery Mitigation Measures, all members of the general public will be expected to observe social distancing and wear appropriate face coverings that cover the nose and mouth per the Governor's Directives. Any person who fails or refuses to wear a face covering shall be considered to be committing a nuisance per Board Policy 1505 and Administrative Regulations 1506, 1520. The person will receive a minimum of one warning to either wear or properly wear a face covering. At the discretion of the Board President in consult with the Superintendent or the Office of the General Counsel and after a warning, the person will be asked to leave the meeting. If the person refuses to leave the meeting, the person will be trespassed from District property per Board Policy 1505 and Administrative Regulations 1506, 1520.

The Board respectfully requests that after members of the public make their public comment, they watch the meeting online or in the overflow room to provide enough space for all members of the general public to make public comment. The Board will also accept public comments before and during the meeting through publiccomments@washoeschools.net. The Board will take time to read those comments during the meeting, announce the names of those who provided public comment via email, and make those comments a part of the public record.
