MINUTES OF THE MAY 25, 2021 REGULAR MEETING OF THE WASHOE COUNTY SCHOOL DISTRICT BOARD OF TRUSTEES

May 25, 2021

1. Opening Items

1.01 CALL TO ORDER

The regular meeting of the Board of Trustees was called to order at 2:02 p.m. in the Board Room of the Central Administration Building; 425 East Ninth Street; Reno, Nevada.

1.02 ROLL CALL

President Angela Taylor and Board Members Jacqueline Calvert, Andrew Caudill, Jeff Church, Ellen Minetto, and Diane Nicolet were present. Board Member Kurt Thigpen was present through video conference. Superintendent Kristen McNeill, Student Representative Victoria Gomez, and staff were also present.

1.03 PLEDGE OF ALLEGIANCE

Trustee Andrew Caudill led the meeting in the Pledge of Allegiance.

1.04 **ACTION TO ADOPT THE AGENDA**

It was moved by Trustee Caudill and seconded by Trustee Minetto that **the Board of Trustees approves the agenda as presented.** The result of the vote was Unanimous: (Yea: Jacqueline Calvert, Andrew Caudill, Jeff Church, Ellen Minetto, Diane Nicolet, Angela Taylor, and Kurt Thigpen.) Final Resolution: Motion Carries.

2. Consent Agenda Items

Trustee Church requested Consent Agenda Item 2.07, Approval of a Memorandum of Understanding between the Washoe County School District and the Washoe Education Association, Consent Agenda Item 2.08, Possible Action to approve the Sexuality, Health and Responsibility Education (SHARE) Advisory Committee Reappointments, and Consent Agenda Item 2.09, Approval of the Reappointment of Members to the School Naming Committee, be pulled for additional discussion.

It was moved by Trustee Nicolet and seconded by Trustee Church that the Board of Trustees approves Consent Agenda Items 2.02 through 2.06 and 2.10

through 2.20. The result of the vote was Unanimous: (Yea: Jacqueline Calvert, Andrew Caudill, Jeff Church, Ellen Minetto, Diane Nicolet, Angela Taylor, and Kurt Thigpen.) Final Resolution: Motion Carries.

- 2.02 The Board of Trustees approved the minutes of the January 26, 2021 Regular Meeting of the Board of Trustees.
- 2.03 The Board of Trustees approved the minutes of the January 29, 2021 Work Session of the Board of Trustees.
- 2.04 The Board of Trustees approved the grant application to the Nevada Department of Education, Title IV-B 21st Century Community Learning Center (CCLC) Competitive Grant Cohort 7 for \$1,478,284.79.
- 2.05 The Board of Trustees approved the grant application to the Nevada Department of Education for the adult high school program for RiSE Academy for Adult Achievement for \$1,307,720.
- 2.06 The Board of Trustees approved the 3-year agreement for Cannon Cochran Management Services, Inc., for third-party administration of the Washoe County School District's Self-insured Workers' Compensation program with a rate of \$98,095/year or \$294,285 for 3 years, beginning July 1, 2021 and ending June 30, 2024.
- 2.10 The Board of Trustees approved the Authorization to Move Forward with Bid #21-98-B-04-AA Pavement Rehabilitation Projects at Alice Smith Elementary School, Alyce Taylor Elementary School, Lena Juniper Elementary School, Sun Valley Elementary School, and Reno High School, in the estimated total amount of \$1,217,000, with Ratification of the Award of these Projects at a Future Board Meeting.
- 2.11 The Board of Trustees approved the Authorization to Move Forward with Bid #21-99-B-04-AA, Pavement Rehabilitation Project at Esther Bennett Elementary School, in the estimated total amount of \$1,053,000, with Ratification of the Award of this Project at a Future Board Meeting.
- 2.12 The Board of Trustees awarded Bid #21-94-B-04-DA, Roof Replacement on Sections U & V with New Heating, Ventilation, and Air Conditioning (HVAC) Units at Sparks High School, to Western Single Ply for \$350,000.
- 2.13 The Board of Trustees accepted the "Budget Transfer Report" and provided authorization to include budget transfers between functions or programs for a total amount of \$30,367.42 for the period April 1, 2021

- through April 30, 2021 in the official Board minutes, as required by Nevada Revised Statute 354.598005.
- 2.14 The Board of Trustees approved the grant application to the U.S. Department of Education for Title VI (Indian Education) grant in the amount of \$188,648.
- 2.15 The Board of Trustees approved the purchase of curricular materials from The DBQ Project for teacher professional learning from Senate Bill(SB) 314 Financial Literacy funds in the amount of \$190,875.
- 2.16 The Board of Trustees approved the re-appointments of Justin Ivory, as the Construction Projects and Finance Representative, and Elise Bunknowski, as the General Public Representative, to the Capital Funding Protection Committee and the Oversight Panel for School Facilities for 2-year terms, ending June 30, 2023.
- 2.17 The Board of Trustees approved the re-appointments to the Student Attendance Advisory Committee of the following members for 2-year terms ending June 30, 2023: Keri Pruitt, Child Welfare Representative; Lacey Keele, Community Services Representative; and Charles Aglubat, At-Large Representative.
- 2.18 The Board of Trustees approved the Memorandum of Understanding between the Washoe County School District and the Washoe Education Support Professionals for the payment of the employee's contracted hourly rate of pay for summer school 2021 in the total approximate amount of \$270,000.
- 2.19 The Board of Trustees approved the Memorandum of Understanding between the Washoe County School District and the Washoe Education Association for the payment of daily rate of pay for summer school 2021 in the total approximate amount of \$4,000,000.
- 2.20 The Board of Trustees approved, pursuant to Nevada Revised Statute 286.523, Nutrition Services Workers and Housekeeping Workers as critical labor shortage areas in order to hire individuals under critical needs status.
- 2.07 APPROVAL OF A MEMORANDUM OF UNDERSTANDING BETWEEN THE WASHOE COUNTY SCHOOL DISTRICT AND THE WASHOE EDUCATION ASSOCIATION PROVIDING FOR THE PAYMENT OF STIPENDS TO SPECIAL EDUCATION TEACHERS FOR ADDITIONAL CASE LOAD

MANAGEMENT, NECESSARY BECAUSE OF SPECIAL EDUCATION VACANCIES, FOR THE 2019-20 AND 2020-21 SCHOOL YEARS, IN THE AMOUNT OF \$30 PER HOUR

Trustee Church requested clarification on why the additional stipend was needed for Special Education teachers. Emily Ellison, Chief Human Resources Officer, explained the additional stipend was necessary to ensure requirements of Individual Education Programs (IEPs) were logged appropriately due to increased caseloads.

Trustee Church asked if the increased caseloads were due to a lack of teachers to fill the positions. Ms. Ellison mentioned the challenges in recruiting teachers, especially Special Education teachers, were not unique to the Washoe County School District. The United States was currently experiencing a national teacher shortage. The agenda item was specific to case management due to vacancies because even if a position was vacant, the requirements of the IEPs still needed to be met and the information logged.

Trustee Church believed the District needed to re-evaluate the recruitment and retention of teachers. He indicated he would approve the agreement, but mentioned that the District would be better served by spending the funds on bringing in experts in recruitment and retention to provide training to staff.

Trustee Calvert wondered what additional training teachers would need to assist in providing services to Special Education students. Ms. Ellison noted there was specialized training that was required for the students to be served. Teachers were able to receive additional certifications in specific Special Education areas. The District did provide options for teachers interested in earning additional certifications to serve students with special needs while remaining in the classroom.

It was moved by Trustee Caudill and seconded by Trustee Calvert that **the Board of Trustees approves the Memorandum of Understanding between the Washoe County School District and the Washoe Education Association for the payment of stipends to Special Education Teachers for additional vacancy case management, in the amount of \$30 per hour.** The result of the vote was

2.08 POSSIBLE ACTION TO APPROVE THE SEXUALITY, HEALTH AND RESPONSIBILITY EDUCATION (S.H.A.R.E.) ADVISORY COMMITTEE REAPPOINTMENTS OF SARA SEIBERT AS A PARENT/GUARDIAN Α REPRESENTATIVE, LYDIA **DEFLORIO AS PARENT/GUARDIAN** REPRESENTATIVE, **KELLY** ROPER AS **PARENT/GUARDIAN** Α REPRESENTATIVE, MANUEL MAGANA AS Α **COUNSELING**

REPRESENTATIVE, AND RABBI BENJAMIN ZOBER AS A RELIGION REPRESENTATIVE, FOR TWO-YEAR TERMS ENDING JUNE 30, 2023

Trustee Church asked if all members of the community were able to submit an application for the positions. Rochelle Procter, SHARE Coordinator, explained, pursuant to current Board Policy, members of a committee in good standing could be reappointed to the committee without the position begin opened to additional applications. The members of the committee seeking reappointment were all members in good standing. There were additional open positions available for members of the community to submit applications for, if they fit into the specific category.

Trustee Church stated he could not support the agenda item because he, as a new Trustee, would be interested in having a larger say in who sat on committees, especially the SHARE Advisory Committee. He would like to send the agenda item back to staff and open the positions to all members of the community and their ability to have their 1st Amendment Free Speech on the committee heard.

Neil Rombardo, Chief General Counsel, cautioned that the ability of a member of the community to serve on a public body was not related to free speech or the 1st Amendment. Board Policy 9100, section 4b, outlined the ability to re-appoint members to committees if they were in good standing. The Board had previously requested the language be included in policy because of challenges recruiting volunteers to serve on committees. It would be important for the Board to consider the language in the Policy when discussing the re-appointment to committees. The intent was to make the reappointment process as easy as possible because there was such a lack of community volunteers interested in serving.

Trustee Church asked if the Board was obligated to approve the agenda item. Mr. Rombardo stated a Trustee could vote any way they wanted.

Trustee Church remarked that he would prefer the Trustees have the ability to have a say in who served on committees and, since he and some others were new, they deserved the right to select who should sit on the committee.

Trustee Nicolet mentioned she had been a member of various committee in the District for about 20 years so she was familiar with the committee process. In her experience, there had never been a rush for community members to serve on committees because there was a large time commitment, as well as outside work that was needed. She believed that if a member of a committee was in good standing and willing to continue to serve, they should be allowed to continue to serve.

Trustee Church felt that he should be able to reach out to his constituents and that he would be able to get a number of them to apply for the positions so there was community representation.

President Taylor opened the meeting to public comment.

Karen England, Nevada Family Alliance, agreed with Trustee Church's comments. She believed there were a number of people who would be interested in serving on the SHARE Committee and the ultimate responsibility for appointment members was with the Board of Trustees. She mentioned since there was always so much interest in the Committee, if someone wanted to remain on the Committee, they should reapply like everyone else. She felt it was important that the community was represented on the Committee.

It was moved by Trustee Church and seconded by Trustee Caudill that **the Board of Trustees sends the re-appointments back to staff to reopen the positions to all applicants.**

President Taylor opened the motion for discussion.

Trustee Nicolet wondered if the Board was ignoring Board Policy 9100 if they voted to send the item back to staff. Mr. Rombardo indicated it was important to remember everyone who served on any committee was a member of the community, so the community's voice was heard. The intent of Board Policy 9100 was to make the process as simple as possible for members interested in continuing to serve because there was a challenge in recruiting members for committees. If the Board were to send the item back to staff, the process used to recruit members and advertise open positions would need to be followed. It was important to note, since the Board approved the re-appointment process in Board Policy 9100, no re-appointments to committees had ever been sent back to staff.

President Taylor expressed her support for those members of committees interested in continuing to serve. The terms on committees were for 2 years and there were opportunities every year to serve on different committees. She did not want to see members interested in continuing to serve removed, especially if there were open seats available for others in the community.

The result of the vote was 3-4: (Yea: Andrew Caudill, Jeff Church, and Ellen Minetto. Nay: Jacqueline Calvert, Diane Nicolet, Angela Taylor, and Kurt Thigpen.) Final Resolution: Motion Fails.

It was moved by Trustee Nicolet and seconded by Trustee Calvert that **the Board of Trustees approves**, for the Sexuality, Health and Responsibility Education

(S.H.A.R.E.) Advisory Committee, the re-appointment of members Sara Seibert, Lydia DeFlorio, and Kelly Roper as parent/guardian representatives, Manuel Magana as a counseling representative, and Rabbi Benjamin Zober as a religion representative for two-year terms ending June 30, 2023. The result of the vote was 4-3: (Yea: Jacqueline Calvert, Diane Nicolet, Angela Taylor, and Kurt Thigpen. Nay: Andrew Caudill, Jeff Church, and Ellen Minetto.) Final Resolution: Motion Carries.

2.09 APPROVAL OF THE RE-APPOINTMENT OF THE FOLLOWING MEMBERS OF THE SCHOOL NAMING COMMITTEE FOR TWO YEAR TERMS BEGINNING ON JULY 1, 2021 AND ENDING ON JUNE 30, 2023: LISA LOEDER, TRUSTEE ZONE A REPRESENTATIVE; CHRISTIANA FRANK, TRUSTEE ZONE G REPRESENTATIVE; AND SCOTT BENTON, TRUSTEE ZONE F REPRESENTATIVE

Trustee Church requested additional information on how members of the committee were selected for each of the Trustee Zones and expressed frustration he was not made aware of the appointment for his area. He requested, at least, the proposed member for his area be removed from consideration until he had an opportunity to meet with the individual.

Trustee Caudill asked if the appointments based on the Trustee District to the School Naming Committee were the same as for the Zoning Advisory Committee, where the individual Trustees were involved in the recruitment effort. Michele Anderson, Chief Communications and Community Engagement Officer, explained the various committees had different criteria for membership, which could be based on where someone lived or their relation to the District, such as parents or staff. The individuals included on the agenda item were interested in continuing to serve on the committee and the reappointment process outlined in Board Policy 9100 was followed. It was important to note that the School Naming Committee currently had three vacancies, which had been open since 2020.

Trustee Caudill felt there was value in having the individual Trustee assist in the recruitment and selection of a candidate who represented their individual area.

Trustee Minetto wondered what seats were currently vacant on the Committee. Ms. Anderson noted the seats for Trustee Zones C, E, and G were vacant beginning in June 2020. Samantha Fredrickson, Public Relations Specialist, explained the same process was followed in 2020, but due to COVID and the lack of scheduled meetings for the Committee, there was little interest from the community in serving. In 2021, additional openings on the Committee became available and a total of five open seats remained. The District opened the application period and received five applications, which would be presented to the Board for consideration at a future meeting; however, in order for

all five applicants to be considered, a current member of the Committee needed to be placed in another open seat.

President Taylor mentioned if the Trustees were interested in having greater involvement in the process, then it was important to include that as part of the Policy or Administration Regulation. She could understand the desire of Trustees wanting greater involvement, especially if an individual were representing their district.

Trustee Minetto requested additional clarification on the process used when multiple applications were received for a particular seat. Ms. Anderson remarked the School Naming Committee had not had numerous applications for a single seat, but she knew there was a process other committees used to review applications and interview prospective members. Mr. Rombardo explained the District used standard Human Resources recruiting and interviewing methods as part of the process, if multiple applications were received.

Trustee Nicolet commented that she would prefer not to input in the process to avoid potential conflicts. She trusted those who were doing the work to select the best candidates for committee members. She wondered if part of the challenge for the School Naming Committee was that there was not a lot of work for them to do at the present time.

Trustee Calvert stated she was fine with the current process and appreciated members of the community wanting to be involved in the District.

President Taylor suggested approval of Ms. Frank and Mr. Benton, then have Ms. Loeder come back for consideration as one of the open at-large seat representatives.

Trustee Church felt the Board Policy on School Naming was in conflict with Board Policy 9100 because the Policy on School Naming indicated all names would be brought forth to the Board for consideration.

President Taylor explained the language quoted from the Board Policy on School Naming was related to the proposed names of schools, not committee members.

It was moved by Trustee Caudill and seconded by Trustee Minetto that the Board of Trustees approves the following re-appointments to the School Naming Committee for terms ending June 30, 2023: Christiana Frank, Trustee Zone G Representative; and Scott Benton, Trustee Zone F Representative; and requests staff bring back the consideration of Lisa Loeder, as an At-Large Representative to a future meeting. The result of the vote was 6-1: (Yea: Jacqueline Calvert, Andrew Caudill, Jeff Church, Ellen Minetto, Angela Taylor, and Kurt Thigpen. Nay: Diane Nicolet.) Final Resolution: Motion Carries.

3. General Public Comment

3.01 **PUBLIC COMMENT**

Gib Patton was a recent resident of the area and had become concerned after hearing that Critical Race Theory could be taught in the schools. He did not believe it was appropriate to ask 5th graders about white male privilege and make them feel guilty for things they could not control. He urged the Board to think about what the curriculum would do to students moving forward.

Don Kennedy was a parent and grandparent in the District. He spoke against Critical Race Theory being taught in the District. He did not believe the Board or anyone in the District knew what Critical Race Theory was nor had they experienced discrimination, like he had as a Catholic boy growing up in Salt Lake City, Utah. He believed the Board was considering teaching white shaming and that those who wrote the Constitution were racist. He mentioned history should be taught from all sides and not a theory based on a political agenda.

William Smith spoke about an incident at Earl Wooster High School with members of the football team. He claimed the female principal came into the boys locker room to check if the students were wearing masks and remained in the room for a few minutes, with the boys in various states of undress. He believed the investigation completed by the District was incomplete and inadequate, which left the boys feeling violated and like the District did not care about them. He urged the Board to look into the matter and take action against the principal.

President Taylor paused the general public comment period.

4. Legislative Items

4.01 PRESENTATION, DISCUSSION, AND POSSIBLE ACTION TO PROVIDE DIRECTION RELATED TO CURRENT AND PROPOSED LEGISLATION DURING THE 2021 NEVADA LEGISLATIVE SESSION BASED ON THE APPROVED 2021 WASHOE COUNTY SCHOOL DISTRICT LEGISLATIVE PLATFORM, TO INCLUDE SUPPORT OF OPTIMAL K-12 PUBLIC EDUCATION FUNDING, SUPPORT OF STUDENT AND STAFF HEALTH AND SAFETY, PROMOTION OF ACADEMIC SUCCESS AND EQUITY FOR ALL STUDENTS, SUPPORT FOR EDUCATORS, AND PROVIDING A COMMUNITY CENTERED APPROACH TO DECISION-MAKING, AS WELL AS UPDATES TO THE WASHOE COUNTY SCHOOL DISTRICT'S LEGISLATION, ASSEMBLY BILL (AB) 57

Lindsay Anderson, Director of Government Affairs, provided an update on the 2021 Nevada Legislative Session. The District's bill, Assembly Bill (AB) 57, was amended in the Senate and the Assembly concurred with the amendment, allowing for final passage and transfer to the Governor's Office for signature. The status of bills the District was in support of was provided. The official K-12 funding legislation, Senate Bill (SB) 458, had been introduced and included the approximate amount the District was expecting.

President Taylor opened the meeting to public comment.

Karen England, Nevada Family Alliance, claimed the Board and District was trying to not only push Critical Race Theory on the District but on the entire state as well through AB261. She did not believe the Board was following what was happening in the Nevada Legislature closely enough or they did not care. She believed the legislation mandated the teaching of Critical Race Theory and LGBTQ+ in the classroom and was frustrated the District spoke in support of the bill, along with the District's student activist group, Washoe County Students for Change. She stated the people of Washoe County did not want Critical Race Theory taught in the schools or anywhere else in Nevada.

Trustee Church requested additional information on AB261, including if the District testified in support of the bill. Ms. Anderson stated AB261 had been approved by both chambers of the Nevada Legislature and was headed to the Governor's desk for signature. District staff had reviewed the bill and did not flag the legislation for any concerns so the District testified in support.

3. General Public Comment

3.01 **PUBLIC COMMENT**

President Taylor reopened the general public comment period.

Valerie Fiannaca thanked the Board for their work; however, she expressed disappointment in the passage of the legislation related to Critical Race Theory. She believed what was happening currently in the United States was following Saul Alinsky's *Rules for Radicals* and the long-term plan would lead to Communism and Marxism taking root, which would not end well for anyone.

Alan Munson spoke against Critical Race Theory being taught in the schools and expressed disappointment in the passage of Assembly Bill 261. He felt that what was being taught was that blacks were the only one who were able to speak about being oppressed and did not acknowledge the achievements of people like Barrack Obama, Condoleezza Rice, and Dr. Ben Carson. He urged the Board to teach that hard work would lead to success.

Ruth T. expressed concern over the teaching of Critical Race Theory and social justice in the schools because they amounted to the indoctrination of children. She believed Critical Race Theory was the new racism because it taught blacks that they could never succeed based on the color of their skin, which went against the teachings of Martin Luther King, Jr. Additionally, other scholars stated that the intent of Critical Race Theory was to teach non-whites that they could never achieve anything greater than even the poorest of whites and they should look at all whites as oppressors.

Cynthia Miller was a concerned citizen from the area. She believed the community needed to go back to the values she was raised on during the 1960's, because propaganda was not taught in schools, police and firemen were our friends, children were taught to be proud to be Americans, true history was taught in the schools, morals were important, and sex education was not taught in school. She felt children were now being taught LGBTQ+ was the thing to do, biology was about genital manipulation, and students took field trips to participate in riots.

Carol Hoover was a prior elementary school teacher and concerned that teachers were now telling students they should be ashamed and guilty for being white. She claimed students would become confused and disengaged from school. She urged the District to go back to the basics in education and teach American history and civics.

Bruce Parks stated the passage of AB261 did not support the implementation of the proposed Benchmark curriculum the District was considering. He claimed there were members of the Board who were speaking to groups within Washoe County and saying there were groups deliberately spreading misinformation about the proposed curriculum. He felt those who did not believe the proposed curriculum was Critical Race Theory or part of the 1619 Project were either deliberately deceitful or willfully ignorant.

Jon Myers remarked that there were thousands of citizens in Washoe County ready to vote the Trustees out of office if they supported the proposed curriculum. He mentioned if the Board did approve the curriculum, the campaign would be very different in 2 years because the people he spoke to would not support any current member of the Board. He believed the "woke" generation was not educated enough to research history to truly understand what happened in the past.

Robert Heinrich expressed concern over the proposed social justice curriculum because it was indoctrinating children against their families. He did not believe the outcomes for any individual were decided on because of the color of their skin or that an individual's attributes were predetermined. He felt past injustices were promoted in the curriculum and that students were told the injustices continued to exist. He believed the proposed curriculum was a violation of Title VI, and other federal legislation, because it divided people by race and created a racially hostile environment.

Rita Pepi spoke against the proposed curriculum based on Critical Race Theory because it was based on Marxism. She claimed Superintendent McNeill had spoken in support of the proposed curriculum because she wanted to create 62,000 social justice warriors. She indicated the District should focus on the basics and teach that a person should be judged by the content of their character, not the color of their skin.

Superintendent McNeill stated the comment referenced was not something she had ever said and that she had been misquoted. She indicated the quote had been posted on a website and she hoped it had been removed because it was incorrect.

Deena Lane spoke against Critical Race Theory and read from Matthew 18 in the Bible.

Paul White cheered the news that two members of the Board were resigning and urged all other Trustees, except Jeff Church, to resign as well. He believed the time spent on the Board by Trustees Caudill and Thigpen was time wasted because they did not accomplish anything. He claimed the other Trustees ran "for the kids," by they had done nothing to improve the education for the kids.

Hope Backman was the parent of two children in the District. She expressed her disappointment in the actions of the Board and Superintendent McNeill because they were not supporting the students. She claimed Superintendent McNeill was forcing parents to live under her rule and she would work to ensure Superintendent McNeill was not re-elected. She believed students throughout the District were suffering from ringworm on their faces because they were forced to wear masks instead of breathing fresh air.

Janet Butcher expressed frustration over what she believed was an unorganized and confusing meeting at a smaller venue so the Board would discourage parents from attending the meetings. She compared Critical Race Theory to social justice curriculum and claimed the intent of Critical Race Theory was to destroy America through unproved assumptions, conjecture, and conclusions based on guesswork. She believed equity was a Marxist concept that allowed groups the ability to reach the same outcomes, while equality was an American ideal that focused on equal rights of the individual. She urged the Board to get back to basics moving forward.

Shannon Coley spoke against the proposed Benchmark supplemental curriculum because she believed it was based on Marxism and intended to divide society into classes. She felt it was more important to provide the youngest students with various perspectives and not focus on equity but instead equality. She urged the Board to consider curriculum that would teach children to stand out and strive towards achievement. She claimed that only teaching one aspect was indoctrination and did not belong in the schools.

Mark Green expressed concern over the proposed supplemental curriculum. He did not believe the materials were vetted properly through the District's own curriculum adoption standards, to include having teachers and community members meeting to compare notes and thoughts. He mentioned he, and many other community members who had spoken, was concerned with the language and tenor of the proposed supplemental materials because it was so similar to Critical Race Theory. He felt the Board and District were showing a certain level of distain for the parents and other community members opposed to the materials based on their words and actions. He requested the District provide the community with information on who was involved in selecting the materials and the entire process.

Ciara Pegoda wondered why the Board and District were considering the adoption of a curriculum developed by an advocate of social justice and equity consultant. She felt the proposed materials went beyond the Nevada Academic Content Standards. She believed the District should focus on the current social studies standards that had been vetted and approved by the Nevada Department of Education and the curriculum adopted by the Board. She mentioned the current K-6 social studies curriculum was inclusive and did not disempower anyone. She urged the Board to look at curriculum based on both the current standards and research, not from a consultant.

Linda Park expressed astonishment anyone who was rational would support Critical Race Theory or assorted names it went by because it was racist and Marxist. She urged the Board to educate, not indoctrinate students and that they should not use classrooms as Petrie dishes for social experiments. She proclaimed the District should stop harming the children and reconsider the \$5 million already spent on the curriculum. She asserted that the Superintendent McNeill wanted 64,000 social justice warriors and was ignorant of the facts. She urged the Board to provide an education that relied on a good education of fact.

Superintendent McNeill asked where Ms. Park heard the information attributed to her regarding "social justice warriors" because it had brought up before and was not correct information. Ms. Park indicated she had read it in the *Reno Gazette-Journal*.

Maria Skolnick was a parent in the District and the child of immigrants. She stated her parents taught her that through hard work, determination, ambition, and education that she could be whatever she wanted in America. She noted she had seen segregation and faced discrimination while growing up in the South in the 1980s, but it did not lead her to act like a victim. She was frustrated the District had previously omitted Asian Americans from the Board's anti-racism resolution because some in the District felt Asian Americans had not historically been discriminated against, but seemed to forget about Asian Americans being sent to internment camps. She wondered if the push to include a social justice curriculum was really about racism or because, as she believed,

the Biden Administration was issuing \$6 million in competitive grants for school districts across the country to teach Critical Race Theory and the 1619 Project.

Blair Spelth urged the Board to remove the face covering requirement for students because he felt it was emotionally damaging them. He stated his children would not return to the District's schools while "muzzled." He did not believe the District was living up to their motto and that the policy goals of the District to promote equity and diversity were misguided since the goal of the District should be education. He believed the District was controlled by the "radical left" because of the commitment to equity and diversity. He would like to see the District hire the most qualified people and not base the decisions on politics. He spoke against the proposed Benchmark supplemental curriculum for K-5 because it was ugly, divisive, and racist.

Karen England, Nevada Family Alliance, stated that Nevada Family Alliance had been fighting against the "radical and progressive" SHARE curriculum that they believed taught students about anal sex, dental dams, and how to obtain abortions without any parental involvement. They also opposed the recommended resources for families because they felt the material was not appropriate. Nevada Family Alliance also opposed policies that allowed teachers to not provide information to parents on a child's sexual orientation or status. She claimed Empower Nevada Teachers had denigrated Nevada Family Alliance because of their opposition to "pornographic sex-ed." She called on the District to employ the use of body cameras on teachers because that would show the parents and community what was actually being taught in the classrooms.

Dana Fought, Nevada Family Alliance, believed there was a clear agenda on the part of the Board to favor one agenda or one side of the issue, while trying to silence other voices. She played a portion of a prior meeting where a discussion occurred where the Trustees were interested in finding a way for teachers to talk about Black Lives Matter and LGBTQ+ and not talk about Pro-Life or the 2nd Amendment.

President Taylor stated there were additional parts of the conversation from the meeting referenced that were not played that also talked about how teachers could provide balanced discussions in classrooms regarding controversial topics, while also supporting their students.

Jeff Church expressed disappointment in having to provide remarks as part of public comment since it limited the amount of time he had to speak. He urged the Board to move the June 8 meeting because the current venue was not large enough to accommodate all the people he believed were waiting outside or had left. He provided a handout that requested an agenda item that would have the Board determine if Board Reports should be placed back on agendas. He mentioned the Superintendent had refused to meet with him under any circumstances and he believed that was improper.

He stated if he had done something wrong, then the Board should tell him and hold a hearing so he could correct anything. He was concerned that he was not provided an office in the building to conduct his work and manage a \$1 billion budget.

President Taylor clarified that all Trustees had the same opportunity to ask for items to be placed on agendas and all Trustees had the same opportunity to speak at meetings, so there was no different treatment of Trustees at the dais because that would be inappropriate.

Suzanne Welcome and Max Callaghan spoke in support of transgender students and the ability of teachers to support their students especially because transgender students were under enough pressure to just try to be themselves. Ms. Welcome expressed concern for her son who had identified as transgender for a few years because she wanted to ensure he was supported and welcomed when he returned to the classroom for the next school year. She wondered how teachers would be able to address bullying issues surrounding gender identity and expression without explaining to all students what that meant.

Kaylynn Sutton wondered why the Board was making students wear masks if they wanted to protect students. She believed the wearing of masks was what made students sick and would make them pass out. She had two cousins she was concerned about because they had to go to school and where masks. She felt kids should be allowed to wear face shields instead of masks because the masks contained parasites.

Melanie Sutton thanked Trustee Church since she felt he was the only member of the Board who listened to the people in the community. She did not believe any of the other Trustees were standing up for the children or America. She stated she was a patriot who was in support of the children. She noted she was now homeschooling her children because she refused to allow her children to wear masks. She spoke against Critical Race Theory because it was racist and promoted segregation.

Annie Story stated her grandson had asthma and could not breathe while wearing the masks. She had told him not to wear the mask at school, but the teacher admonished him and told him to put it back on because he was younger than 9. She felt the rules surrounding masks were confusing and needed to be clarified for staff and families. She claimed the Board had become very political and they were exceeding their authority and power by requiring masks. She spoke against the proposed Critical Race Theory because she felt it taught that all whites were white supremacists, which was not true. She did not believe white privilege existed and that anything that taught one race was to blame for the ills of all other races was racist. She stated it was more important for children to learn from the past and that teaching racism to combat racism was not appropriate or acceptable.

Myra Almond spoke against the mask requirement in schools because she believed it amounted to child abuse and they did not work. She did not agree with the teaching of Critical Race Theory or that there should be mandatory vaccines for children.

Kandy Lyons stated Nevada was ranked 35th in the nation in terms of education and that the District needed to get back to teaching the basics in schools, not waste time teaching Critical Race Theory. She mentioned that federal law prohibited school districts from mandating vaccines because they were still considered experimental. She did not want her children to be guinea pigs for the vaccine or have them wear masks that were harmful and did not prevent disease.

President Taylor explained there was no mandatory COVID vaccine in the Washoe County School District and that students were allowed to remove their masks while outdoors.

Mindy Lilyquist was the parent of four children in the District and expressed concern over the continued divisiveness she saw on the Board. She felt the Board and District were in constant turmoil and that the children were the ones suffering. She urged the Board to stop considering controversial topics and focus on the basics. She stated she did not agree with the proposed Benchmark social justice curriculum because she believed it chipped away at the Constitution. She claimed the proposed curriculum was a way to present blame and shame to students and amounted to indoctrination. She mentioned she had heard from some in the community the Wallace Global Foundation was providing the District was a large grant if the proposed curriculum was adopted.

Superintendent McNeill stated the Wallace Foundation was in no way related to the Benchmark curriculum.

Paulina Gersorvich was a grandparent in the District. She spoke against the proposed supplemental curriculum. She believed it was important for the District to focus on ensuring students were able to speak and read English and that it was up to the families to teach morals and ethics. She urged the Board to reject Critical Race Theory and social indoctrination and the proposed Sexuality, Health, and Responsibility Education lessons that included information from Planned Parenthood.

Carole Fineberg remarked that she had recently returned from a trip to Salt Lake City and found there were no mask requirements in Utah or the rural Nevada counties. She was concerned over a statement she had heard that the District's requirements were more stringent that both the state and Center for Disease Control (CDC). She spoke against the proposed changes to the Sexuality, Health, and Responsibility Education curriculum because of the references to dental dams, gay sex, and abortion for 6th graders.

Daniel McClure mentioned he had joined the Navy and became a nuclear reactor operator. He noted he learned management and leadership while in the military. He expressed frustration over the District's COVID policies.

Kenji Otto stated he had researched how elected officials could be recalled and was willing to help others begin the efforts. He spoke against Critical Race Theory because he believed it was based on communism. He claimed it was intended to divide the country.

Mark Leonard spoke against the proposed supplemental curriculum and read various quotes from Fredrick Douglas to support his belief. He felt the Board and District were not focused on teaching knowledge but that certain classmates were oppressing them. He believed that since the Board was not trying to educate the children, then they were trying to enslave them. He condemned the actions of all the Trustees, except Jeff Church.

Matt True stated he was against any 1619 and Critical Race Theory lessons being taught in the schools. He mentioned teachers had told him that he was more involved than most parents in the schools and indicated he was frustrated with the continued missteps of the Board and District. He believed the teachings the District was focused on would lead to more violence, not less. He provided examples of what had occurred to his youngest son when he spoke up for what he believed and that his son was ostracized by those who he thought were his friends.

Andrea McVaney was the parent of a kindergartener in the District. She expressed concern over the proposed Benchmark supplemental curriculum and having her student enrolled in a school where it was taught. She believed all people were worthy of respect and that the true history of America needed to be taught; however, she felt it was important to remember people were flawed and it was more important to learn from history than teach it was wrong. She stated she would prefer children be taught sharing and kindness rather than divisiveness.

Roger Edwards mentioned he was a conservative and the leader of a conservative group in the area. He indicated it was important for the Board and District to focus on traditional education and not socialized indoctrination. He did not believe the District should approve the sex ed curriculum or any Critical Race Theory and should instead look at the quality of education. He claimed the District was graduating students that could not read or write because they were no longer part of the curriculum.

Sharon Williams remarked that she grew up in southern Virginia where the schools were segregated until she was a senior in high school. She believed she got a great education because the schools focused on the basics. She expressed concern over the proposed supplemental curriculum and the diversity projects because she believed they

were doing more harm than good in the schools. She urged the Board to teach students perseverance and developing a strong constitution, rather than topics meant to divide people.

John Eppolito, Protect Nevada Children, expressed concerns over the privacy policy of the Benchmark Advanced social justice curriculum. He believed Benchmark could label children as racists starting in kindergarten based on their responses to questions and which lessons they chose to take, and the parents would never know. He was concerned that the data collected would be used against children in the future, which was what Protect Nevada Children had been concerned about for years. He claimed student data that was supposed to be protected by the District had been stolen and sold on the dark web or to the Chinese. He agreed with prior speakers that the proposed curriculum was more indoctrination than education.

Margaret Martini stated that if the Board were to approve the proposed social justice curriculum, they would do more to divide the community than any actions taken previously taken by Superintendent McNeill. She claimed the proposed curriculum was more of an indoctrination than education and read from various lessons included in the curriculum that she believed supported her claims.

Georgette Stormo spoke in support of what many of the parents had said. She mentioned common schools were originally designed to promote citizenship in the United States to create national cohesion, through teaching children to read, write, and speak English. She believed that the schools had been corrupted and were now teaching Marxists beliefs and Critical Race Theory, with students being indoctrinated and not educated.

Paul Larson claimed many present at the meeting speaking out against the proposed curriculum had served the country during the Cold War and were concerned they were seeing what they fought for slip away. He believed the proposed curriculum was based on Marxism and frustrated because the District was teaching the theory to students when so many had fought to escape it.

Bayleigh Grill was a middle school student and frustrated that she and her classmates were required to wear masks throughout the day. She believed wearing the masks all day caused anxiety and that it was difficult to breathe. She urged the Board and District to allow students the opportunity to remove the masks so students could better communicate with each other. She expressed frustration that teachers and other school staff were allowed to remove their masks, but the students would get in trouble if they removed their masks to take a drink or speak louder so another student could hear them.

Jessica Foster was a parent in the District and urged the Board to remove the masks for students. She stated sending her daughter to school everyday with the mask was creating anxiety and depression.

Chris McAvoy spoke against the proposed Benchmark Advanced curriculum because she believed it was based on lies. She felt the curriculum was created based on a single event and labeled individuals based on the color of their skin, not who they were as individuals. She believed the Board was "picking politics" over education and that the Board and Superintendent should be following the District's motto of "Every child by name and face to graduation."

Jaimee Shepler expressed support for Trustee Church and believed the current location of the meeting was a violation of Nevada's Open Meeting Law because it was not large enough to accommodate everyone. She spoke against the proposed Sexuality, Health and Responsibility Education (SHARE) program because she believed it was up to the parents to teach their children about their own sexuality. She believed the proposed Benchmark curriculum was Critical Race Theory was anti-American and perpetuated racism.

Ann Sweder spoke against the proposed curriculum because she believed it was Critical Race Theory and should not be taught in the schools. She claimed Critical Race Theory was a Marxist weapon designed to take control of America and there were few in America that realized what was happening. She wanted to educate parents on the neo-Marxist code words they needed to be aware of, such as equity, oppressed, systemic racism, and social justice, so they could fight against Critical Race Theory in the schools. She urged the Board to only teach the basics in schools.

Paul Solaegui was a grandparent in the District and local business owner. He spoke against any proposed curriculum that sought to undermine the United States Constitution. He was interested in becoming a more involved member of the community because he was concerned about social programs corrupting society.

Kasey Thelander was a parent in the District. He expressed frustration over what he claimed were teachers scolding children for playing tag and requiring social distancing. He believed the District was causing more emotional damage to children than the pandemic. He claimed the principals and area superintendents said they were following the Governor's directives and what others had told them to do, but they would not provide him with the names of those directing them. He did not believe students should have to wear masks and was frustrated the schools were still requiring the masks and social distancing. He remarked that even though the Board would not call the proposed curriculum Critical Race Theory, that it was and the Board should not be teaching it in the schools.

Lonnie Feemster, Reno-Sparks NAACP, mentioned he was present to talk about the proposed social justice curriculum, but that he had spoken with many others present outside and now believed deeper conversations needed to occur. He remarked that there were differences in how people defined terms and that without common understandings of definitions, then there would remain confusion in what was meant by equity, social justice, and Black Lives Matter. He stated that he would no longer use the term Black Lives Matter, but instead say the Black Lives Matter movement for criminal justice reform because the phase more accurately stated what he meant to convey. He appreciated the conversations he was able to have with those who disagreed with him because the conversations were respectful; however, it was clear there was a lot of confusion and misunderstanding about what was actually occurring in the schools.

Valerie Wade thanked the Board for their work because she believed what they did mattered. She and her family had lived in the area for many years and attended schools in the District. She believed that it was important for the Board and District to support the teaching of social justice because white supremacy, bigotry, and hate could not be tolerated. She spoke about her family coming to the area in the 1950s and their history. She believed minority groups had been silenced from attending the meeting and speaking because of the "Klan-style gathering in front of the building." She felt that when hard history was taught, those threatened responded with anger. She urged the Board and District to provide students with the necessary information and history to understand what was occurring in society and make sense of the images they saw everyday on the internet.

Victoria Miller was from the area and had recently moved back from Southern California with her family. She mentioned many of the friends her children had were black and brown, so she was concerned about a curriculum that would teach them that they were racist because they were white and privileged. She stated she would rather the schools teach students to love each other and not hate based on what someone looked like. She remarked that she appreciated the time Trustee Church had spent with the community and expressed frustration that he was being "shut out."

Cathy Reyes expressed that the only Trustee listening to those at the meeting was Trustee Church and that he was the only one speaking out against Critical Race Theory. She believed the other Trustees were not listening to the constituents and she wondered what the end result of teaching Critical Race Theory was for the District. She claimed the Board was purposefully restricting access to the meeting by holding it in a small room. She spoke against the proposed sex education curriculum because she believed parents should teach that to their children. She remarked that the mask requirement was a joke.

Traci Palone and Emberlynn spoke against the wearing of masks and distance learning. They believed the masks did not work and made it difficult to breathe. Ms. Palone felt the teachers were pressuring students to wear masks and that her daughter should not be afraid of going to school because she might have to share a bathroom or play on sports teams with boys.

Scott Wallace was a pediatrician in Reno. He noted the American Academy of Pediatrics (AAP) and the Centers for Disease Control (CDC) based their decisions on science and research, including the importance of in-person learning for children. He noted in order for in-person learning to occur, it needed to be conducted in a safe environment, which included social distancing and mask wearing. He believed many of the statistics quoted were misinterpreted and taken out of context and that COVID could impact anyone, of any age or health status. He stated masks were important because they protected others around you if you were the one infected. He remarked that it was critical to protect each other so there was not another surge in cases because that would be what could close schools again.

Jonna AuCoin was a principal in the District. She mentioned she was listening to the meeting on her way home and heard so much negativity that she had to come to the meeting to say thank you to the Trustees and Superintendent McNeill. She remarked that she had not always agreed with the decisions made during the pandemic, including the reopening of schools, but it was the correct decision and the students were thriving now that more were back in person. She commented that she was disappointed in how Trustee Church was representing her as a constituent because, in her opinion, it appeared he only wanted to create tension. She noted there were challenges that needed to be addressed in the District and improvement did need to occur, but there were also great things happening in the schools and classrooms. She believed it was important for kindergarteners to learn how to speak up when they did not think a rule was fair because that was where the development of critical thinking skills began.

Beth Martin agreed with the remarks provided by Principal AuCoin. She expressed her support for the proposed supplemental curriculum because it tied into the current Benchmark curriculum that was already being taught. She was frustrated at the misrepresentation occurring because the comments were not based on the materials, just that it was "indoctrination." She stated the proposed lessons aligned with the current standards related to listening, speaking, reading, and writing. She remarked that teachers taught students to analyze historical documents and artifacts, and how to make logical, fact-based arguments based on historical events, which was critical in understanding both the positive and negative aspects of American history. She indicated she was unclear why teaching students to understand how and why race impacted history was threating to some. She stated Superintendent McNeill was not dividing the community but was one of the most involved superintendents she had work

under over the past 13 year and that she was proud of the work the Superintendent was doing.

Kristen DeHaan mentioned she agreed with Principal AuCoin and Ms. Martin. She noted, as a teacher in the District, that the students did pay attention and that many watched the Board meetings and were frustrated when adults were continuing to say they would not be able to go to college, find a job, or were not being educated. She stated the teachers were teaching reading, writing, math, and history, with many kindergarten students reading by the end of the school year, while some required additional assistance for whatever reason. She mentioned teaching sex education was not new and that when she was in high school the students learned how to put on a condom. She appreciated the in-person meetings by the Board and noted people complained when the meetings were held in larger venues because they said they could not hear.

Joe Morabito was a member of the community. He spoke against the proposed social justice curriculum because he believed it was based on Marxist and Critical Race theories, as well as the 1619 Project, which he felt was revisionist history. He remarked that any curriculum that taught to hate white men, or anyone, and to shame white children because they were "privileged" was against the students' Civil Rights. He indicated he would be working with others to monitor what was occurring in the classrooms and what teachers and school administrators were saying if the proposed curriculum was adopted. He claimed the proposed curriculum would result in civil lawsuits. He stated he was also opposed to any policies that allowed boys to use girls' bathrooms and locker rooms or boys to compete in girls' competitive sports.

Calen Evans, Empower Nevada Teachers, stated the primary focus of the organization was to address educational funding issues in Nevada. He noted the group was comprised of educators and community members throughout Nevada with differing political views and beliefs. He explained the group's social media platforms served to bring people together who supported public education and the views and opinions expressed by members of the group may or may not be the same as the board of directors of Empower Nevada Teachers. He mentioned there were other groups targeting what members of Empower Nevada Teachers had said on the organization's social media pages and cautioned that any post, unless written by the organization's administrators, were the views of the individual and not the organization. emphasized Empower Nevada Teacher did, and would continue, to support the students, no matter their race, religion, sexual orientation, or color. He believed lies and misinformation were being spread to further a particular political agenda by those who were not involved in education in Nevada and stated Empower Nevada Teachers would not be silent and allow that to occur.

Rachel Fisher was a teacher in the District and part of Rainbow Educators of Nevada, which advocated for inclusivity in the schools. She spoke in support of the proposed updates to the Sexuality, Health and Responsibility Education (SHARE) curriculum. She believed the updates were long overdue. She mentioned the information was medically accurate and important lessons for students. She noted comprehensive sex education did not lead to increased sexual activity but prevented bullying, harassment, abuse, disease, and unintended pregnancy.

YeVonne Allen thanked the Board for listening to members of the community. She urged them all to stand up for equity, diversity, and inclusion and not let hate, bias, and misinformation change their views on what they knew was right. She mentioned she could not believe what many people had stated during public comment and many of the comments showed exactly why critical thinking skills needed to be taught in the schools. She remarked the Trustees were elected to support the entire community and not just a vocal minority that showed up to meetings because the students in the District were very diverse. She also spoke in support of the proposed sex education curriculum because it was inclusive and needed in the schools.

7. General Public Comment

7.01 **PUBLIC COMMENT**

Brian Gibb was a parent in the District. He explained his son was born with a severe heart defect which put him at a disadvantage with COVID-19. He remarked that he was tired of teachers and school district administrators making decisions without consulting health officials because the decisions were impacting children. He noted the language from the health officials strongly recommended masks be worn in elementary schools because children were not vaccinated. He believed the District made a mistake by removing the mask requirement in elementary schools because there were many students who remained susceptible to COVID.

The Board received comments from the following: Donald Philips

President Taylor recessed the meeting for 30 minutes.

5. Items for Presentation, Discussion, Information and/or Action

5.01 PRESENTATION AND DISCUSSION TO REVIEW KINDERGARTEN UPDATES FOR THE 2021-22 SCHOOL YEAR

Kacey Edgington, Kindergarten Facilitator, provided the Board with a presentation on the plans for kindergarten for the 2021-22 School Year. The District followed the requirements of Nevada Revised Statute (NRS) 392.040, which required the screening of children who did not attend a District or District approved kindergarten program to determine if the child was prepared to enter into the 1st grade. She mentioned 100% of children tested by the District so far were prepared to enter 1st grade, which she knew was a concern of the Board since some families had opted their children out of kindergarten due to the pandemic. Information on the supports provided to students and families was provided. The kindergarten registration for the 2021-22 School Year was at 92% of the expected applications and comparable to the 2018-19 School Year enrollment. Additional information on current legislation being considered by the Nevada Legislature was provided and the events conducted to transition children from PreK to kindergarten.

President Taylor requested clarification on the legislation. Ms. Edington explained the bill would revise the age at which children would be able to begin kindergarten. Currently the age was based on a date, but the proposed change would stated that a child must be 5 years old on or before the start of a school year to enter kindergarten,

which could impact about 100 students annually in the District who started when they were 4 years old who turned 5 within 30 days of the start of school.

Trustee Caudill asked if the District was anticipating an increase in kindergarten registration as the schools opened up more and if there was a decrease in COVID cases. Ms. Edington indicated the District was expecting the enrollment numbers to increase based on current registrations.

Trustee Caudill wondered how many kindergarten students were enrolled at North Star Online. Ms. Edington mentioned that as of May 20, 2021, there were 18 kindergartens registered at North Star Online.

Trustee Minetto recalled that when she was teaching in the elementary schools, there always seemed to be a large influx of kindergarten students through the first month of a new school year. She asked if the District continued to see similar increases. Ms. Edington stated the District was working hard to prevent that from happening because the first few weeks were extremely important in developing a routine, which was one of the reasons for the increased community outreach by the District and individual elementary schools.

5.02 DISCUSSION AND POSSIBLE ACTION TO REVIEW THE COVID-19 CASE COUNTS IN SCHOOLS, ADEQUACY OF STAFFING LEVELS, AND OTHER APPLICABLE FACTORS, AS WELL AS DATA INDICATORS USED TO ASSESS COVID-19 COMMUNITY RISK TO INCLUDE COMPLETED RISK ASSESSMENT FORMS, TEST POSITIVITY, COMMUNITY WIDE CASE RATES AND HOSPITALIZATIONS, AND, IF DATA INDICATORS SUGGEST VERY HIGH RISK OR ABOVE FOR UP TO 7 DAYS, OR THE BOARD DEEMS IT NECESSARY, THE BOARD OF TRUSTEES WILL CONSIDER RELEVANT ACTIONS THAT MAY INCLUDE CHANGES TO IN-PERSON, HYBRID, AND FULL-DISTANCE LEARNING MODELS

Dr. Paul LaMarca, Chief Strategies Officer, provided an update on COVID-19 cases in the community. Information on the collaboration with the Washoe County Health District was presented. Currently, Washoe County was in the "moderate/yellow" range and the average daily cases and test positivity continued to decrease.

President Taylor thanked the members of the Washoe County Health District who were present for the meeting. She appreciated all their work and support through the past year.

President Taylor opened the meeting to public comment. The Board received comments from the following:

Trustee Church mentioned he had visited various schools within his district and saw chaos in terms of students wearing masks and the teachers' ability to enforce the wearing of masks. He would be interested in at least holding a discussion on allowing parents and children to use face shields instead of masks.

It was moved by Trustee Church and seconded by Trustee Caudill that **the Board of Trustees directs the Superintendent to allow the use of face shields in place of face masks at all District schools and facilities.**

President Taylor opened the motion for discussion.

Trustee Nicolet wondered why the original decision was made not to allow the use of face shields. Superintendent McNeill read from the current directive, Governor's Directive 045, Section 4: "Effective immediately, individuals not exempted from Directive 024 and 028, or guidance issued by the Nevada Health Response, shall be required to cover their nose and mouth with a face covering in a manner consistent with guidance issued by the CDC, and any subsequent guidance issued by the CDC..." Based on her reading of the directive, she did not believe a face shield would comply. Dr. LaMarca added there was a time when the District was prepared to allow the use of face shields and had even ordered some for the schools; however, in late July 2020, the Centers for Disease Control (CDC) provided guidance that face shields were not appropriate substitutes for face coverings. He noted the CDC had subsequently provided additional guidance on the types of face coverings and materials that were appropriate. There had been exceptions made to allow the use of face shields for students who were physically unable to wear a mask.

Trustee Church believed the information on the CDC website would allow for face shields.

President Taylor requested a representative from the Health District provide their guidance on if face shields were acceptable alternatives. Heather Kerwin, Infectious Disease Epidemiologist, Washoe County Health District, stated that face shields were originally designed for use in medical settings for providers who were conducting procedures where aerosols or bodily fluids could be released. The shields were intended to protect the other personal protective equipment being worn, to include a mask. Because SARS-COVID19 was air borne, particles were released whenever someone breathed, spoke, sang, played an instrument, etc. If the masks were worn tight against the mouth and nose, the more protective it would be because it would not allow as many particles to escape. While there were instances when a face shield was a more appropriate choice, most of the time a mask should be used since it provided the most protection.

Trustee Nicolet remarked that there had already been confusion with the changes for those age 9 and under. She believed, since it was so close to the end of the school year, that the District should not make any additional changes. She understood the concerns raised by parents, but she did not want to create more confusion.

Trustee Calvert commented that the Board had been provided with information that exceptions were provided for students with special needs to use a face shield, but that the mask did offer more protection.

Trustee Caudill wondered if face shields would provide additional flexibility for staff members who were vaccinated.

President Taylor cautioned that the District did not know who was vaccinated and who was not, so it would be challenging to allow the use of face shields for those who were vaccinated without requiring staff to disclose their personal medical information. She indicated that she was hesitant to make any large-scale changes without receiving additional information and feedback from families and staff.

Neil Rombardo, Chief General Counsel, provided the definition of face covering, as anything covering the nose and mouth, including, without limitation, cloth face masks, surgical masks, towels, scarfs, and bandanas. Face shields were not part of face coverings, so the Board and District would be in violation of the Governor's Directive if the motion were approved.

Trustees Church and Caudill withdrew their motion based on the definition provided.

5.03 PRESENTATION, INFORMATION, AND DISCUSSION ON STAFF RECOMMENDATIONS FOR THE OPENING OF SCHOOL PLANS FOR THE 2021-22 SCHOOL YEAR TO INCLUDE THE FULL RETURN OF STUDENTS TO ELEMENTARY SCHOOLS, MIDDLE SCHOOLS, AND HIGH SCHOOLS

AND TO INCLUDE INFORMATION ON ACADEMICS, OPERATIONS, TRANSPORTATION, NUTRITION SERVICES, HUMAN RESOURCES, MITIGATION SAFETY MEASURES, AND AN UPDATE ON THE PLAN FOR NORTH STAR ONLINE SCHOOL TO SERVE AS THE DISTRICT'S ONLY ONLINE/DISTANCE LEARNING SCHOOL

Superintendent McNeill and members of the District's Leadership Team presented the recommendations for the 2021-22 School Year, including providing information on processes and procedures to be in place for the operational and academic sides of the District.

Pete Etchart, Chief Operating Officer, reviewed the state guidance and local authority plans that were used to determine how the District would proceed in the opening of schools for the 2021-22 School Year. The District would continue to monitor information and guidance released by the state and Centers for Disease Control (CDC) to determine if changes would need to be made prior to the start of school.

Dr. Paul LaMarca, Chief Strategies Officer, presented information on the current mitigation strategies that the District anticipated continuing through the next school year to prevent increased spread of COVID-19, including increased hygiene opportunities, sanitation, and other strategies related to contact tracing. It was important to remember the proposed plans for the 2021-22 School Year were based on what was currently known in terms of guidance and recommendations, but those could change. The District would also be implementing a new pilot program for contact tracing and exclusions for the summer school session. The intent was to avoid the large-scale exclusions of students through the use of seating charts, accurate rosters, and having the materials for contact tracing completed at the start of the school year. The District had not determined how vaccinations would be handled and if someone would need to be excluded if they had been vaccinated.

Trustee Nicolet wondered how the District would be able to allow access to student information, including vaccination status, while maintaining medical privacy requirements. Dr. LaMarca mentioned there were challenges, but the District had been able to maintain confidentiality through the current school year. The entities were able to share information quickly by having some District staff working in the Health District offices.

Trustee Caudill asked how students would be able to keep up academically if they were excluded since the only on-line learning would be through North Star Online and the individual schools would not be providing that as an option. Dr. LaMarca indicated some of that information would be provided later in the presentation. One of the reasons the District wanted to develop a more efficient exclusion process was so that there were not students being excluded for excessive amounts of time.

Superintendent McNeill added that the development of the exclusion process should be considered a "silver lining" because the District would be able to utilize the same process is exclusions were required for other diseases or viruses, such as whooping cough or chicken pox.

Adam Searcy, Chief Facilities Management Officer, presented the operational considerations for the 2021-22 School Year. The District had been able to increase the amount of fresh air being circulated throughout all facilities, as well as ensuring regular cleaning and disinfecting of surfaces.

Trustee Caudill wondered if the District had been able to address the concerns related to the smoke days that had to be called in August 2020. Mr. Searcy noted 2020 was more of an extreme in terms of the intensity and duration of the smoke from the wildfires. The concerns with the smoke were not necessarily related to the air quality in the buildings, but more a concern with students walking to and from school and being exposed. The District would have to weigh any possible change to distance learning due to a natural disaster versus the safety of students and staff getting to and from the buildings.

Trustee Minetto requested clarification on when the air circulation was in effective. Mr. Searcy stated the general time frame was an hour before and after the school day; however, the Facilities Management Department did take into consideration other activities that might be occurring before and after the school day.

President Taylor thanked everyone in Operations for all their work. She indicated there were other school districts across the country looking at what had been done in the Washoe County School District, especially related to circulating the air in the buildings.

Lianka Soliz, Nutrition Services Director, explained how they anticipated streamlining operations to account for the expected growth due to universal free lunches. Nutrition Services wanted to return to pre-COVID operational models and bring back point of service lines in the cafeterias.

Trustee Nicolet requested clarification on point of service. Ms. Soliz remarked that even though there would not be cash exchanged for the meals, the District still needed to conduct a meal count each day.

Trustee Church wondered if there was a plan if the District was not able to fully staff Nutrition Services, such as bringing in outside vendors. Ms. Soliz noted the District would work with the individual school sites before they would bring in outside vendors.

Scott Lee, Assistant Transportation Director, reviewed the current staffing levels in Transportation. The District was about 50 people short on staffing, plus approved leaves of absences, left the District about 23% short on staffing. The District was currently able to meet general education and mandated transportation needs because of distance learning and hybrid, which led to decreased ridership.

Rick Martin, Transportation Director, presented the transportation considerations for the 2021-22 School Year. A return to normal ridership and occupancy levels for the next school year meant that the District would need to implement about 25 driver routes, which equated to 27 of the open driver positions. Possible solutions to the transportation challenges were explained, including double runs for elementary schools and increased walk zones.

Trustee Church remarked that he would like to see the recruiting program revamped because he believed at least 25% - 50% of the personnel challenges could be handled through new and innovative recruiting strategies in the short term.

Trustee Nicolet wondered how many elementary school students walked the 1.25 miles because it was a long way for the younger kids. Mr. Martin indicated the District transported about 1/3 of all District students and the majority of those transported were in elementary school. If the District were to increase the walk zone for elementary schools to 1.5 miles, about 2,000 students would be impacted. Mr. Etchart added that the District would have a short amount of time to let families know about any changes.

Emily Ellison, Chief Human Resources Officer, provided information on the Human Resources considerations for the next school year. The largest challenges were related to recruitment, so the District would be looking at utilizing some of the strategies used in the recruitment of guest teachers during the current school year.

Dr. Troy Parks, Chief Academic Officer, reviewed the academic considerations and how the District would work to support teachers in the classrooms. The District would continue the use of professional learning communities (PLCs) to support high levels of learning for all students in the District. Building learning facilitators would be used in the elementary schools to support the work of the PLCs and provide additional assistance to teachers on how to understand the data, especially related to what should occur when students were not learning. Some of the "silver linings" the District was able to learning throughout the pandemic included the creation of the Distance and Blended Learning Department, more efficient use of time and resources with families, increased on-line collaboration, and higher levels of differentiation to support personalized student learning. Information on how the District would support students who were excluded was highlighted and would included the increased use of laptops for learning.

Jeanna Curtis, Area Superintendent, presented an update on North Star Online Academy, which would be the only distance learning options available to students beginning with the 2021-22 School Year. The District created four "hubs" throughout the community where students and teachers from North Star could go to receive inperson learning and support. North Star Online was prepared to accept up to 2,000 students and currently had 619 students enrolled, with the deadline for applications of May 28, 2021.

President Taylor asked what would happen if someone wanted to change from distance learning and back to their zoned school. Ms. Curtis explained the District was encouraging students to begin at North Star if they had an interested in distance learning because the curriculum was different and if would be difficult to go back and forth between the different curriculum models. It was more difficult to start with inperson learning and move to North Star.

Trustee Caudill wondered why the deadline for applications was May 28, 2021. Ms. Curtis remarked that the enrollment process for North Star Online was different than enrolling in a traditional school. The enrollment process would take a couple of weeks to move through Infinite Campus and then for the student to be registered for the classes by Pearson.

Trustee Nicolet requested additional information on dual credit opportunities, extracurricular activities, and lunches for students enrolled in North Star. Ms. Curtis mentioned lunches were not provided at North Star Online. In terms of extracurricular activities, the teachers at North Star were the advisors for clubs and they would generally meet on Fridays. Athletics and other events, such as dances, were handled through the student's zoned schools. The dual credit program was the same as in other high schools and offered the same opportunities for students interested in the classes.

Rollins Stallworth, Coordinator of Activities and Athletics, reviewed the current directives related to high school athletics. The District recommended coaches, workers, and student athletes get vaccinated, as able, prior to the start of their individual seasons. For the 2021-22 School Year, the District was planning on conducting full athletic seasons, unless told otherwise. Spectators would be allowed in accordance with state and local guidance, to include the use of face coverings.

Trustee Nicolet asked how the District would be providing information to parents regarding vaccines since there were many who remained concerned. Mr. Stallworth explained his intention was to inform parents that vaccines would extend the longevity of a season if an outbreak were to occur at a campus because they would not be excluded if they had received the vaccine.

President Taylor added the language was to recommend vaccines for athletes so parents did have the choice. It was important to share the impacts of what would occur with and without a vaccine and then it would be up to the parents.

Joe Ernst, Lead Area Superintendent, presented the recommendation for the 2021-22 School Year for all elementary schools. The District was recommending full in-person learning for all elementary schools, following all state guidance, with full distance learning options available through North Star Online School.

President Taylor opened the meeting to public comment. The Board received an email from the following:

It was moved by Trustee Caudill and seconded by Trustee Nicolet that **the Board of Trustees accepts the recommendation to return to full in-person learning for all elementary schools, following all State guidance, for the 2021-22 School Year.** The result of the vote was Unanimous: (Yea: Jacqueline Calvert, Andrew Caudill, Jeff Church, Ellen Minetto, Diane Nicolet, Angela Taylor, and Kurt Thigpen.) Final Resolution: Motion Carries.

Lauren Ford, Lead Area Superintendent, presented the recommendation for the 2021-22 School Year for all middle schools. The District was recommending full in-person learning for all middle schools, following all state guidance, with full distance learning options available through North Star Online School. No hybrid schedule would be offered for middle schools. Some middle schools had determined they would continue with a block schedule format to allow for extended class times and would no longer provide lockers for improved efficiency in students getting to classes on time. An orientation would be offered at all middle schools for 6th graders, as well as 7th and 8th graders as time allowed.

It was moved by Trustee Caudill and seconded by Trustee Minetto that **the Board of Trustees accepts the recommendation to return to full in-person learning for all middle schools, following all State guidance, for the 2021-22 School Year.** The result of the vote was Unanimous: (Yea: Jacqueline Calvert, Andrew Caudill, Jeff Church, Ellen Minetto, Diane Nicolet, Angela Taylor, and Kurt Thigpen.) Final Resolution: Motion Carries.

Jeana Curtis, Area Superintendent, presented the recommendation for the 2021-22 School Year for all high schools. The District was recommending full in-person learning for all high schools, following all state guidance, with full distance learning options available through North Star Online School. No hybrid schedule would be offered for high schools. High schools were looking at various options to enhance learning in high school, such as blended learning through Edgenutiy and tutoring opportunities.

It was moved by Trustee Caudill and seconded by Trustee Minetto that **the Board of Trustees accepts the recommendation to return to full in-person learning for all high schools, following all State guidance, for the 2021-22 School Year.**The result of the vote was Unanimous: (Yea: Jacqueline Calvert, Andrew Caudill, Jeff Church, Ellen Minetto, Diane Nicolet, Angela Taylor, and Kurt Thigpen.) Final Resolution: Motion Carries.

President Taylor recessed the meeting for 10 minutes.

5.04 DISCUSSION AND POSSIBLE ACTION TO APPROVE THE PROPOSED SEXUALITY, HEALTH AND RESPONSIBILITY EDUCATION (SHARE) 6th GRADE CURRICULUM, AS RECOMMENDED BY THE SHARE ADVISORY COMMITTEE

Kindra Fox, Director of Curriculum and Instruction, and Rochelle Procter, SHARE Coordinator, provided a presentation on the development of the Sexuality, Health and Responsibility Education (SHARE) 6th grade curriculum. Background information on the SHARE program, including governing documents, was reviewed. It was emphasized that active parent permission was required for students to participate in the SHARE curriculum and lessons. Permission was provided through the registration process in Infinite Campus. The SHARE Advisory Committee was comprised of 9 individuals and membership was dictated by Nevada Revised Statutes. The District had been working on updating the SHARE curriculum for all grades beginning with high school in 2018 to ensure up-to-date and appropriate information was provided on topics such as consent, setting boundaries, healthy relationships, medically accurate local resources, and that the curriculum met the needs of the diverse student population. The proposed curriculum was available for viewing by the community and included a survey opportunity. The majority of parent respondents were from 5th and 6th grades and expressed their support for the proposed curriculum.

President Taylor requested additional information on who provided the SHARE curriculum in the schools. Ms. Procter noted the curriculum was provided by counselors, science teachers, health teachers, and as part of the JROTC program in high school. She added that if there was a teacher uncomfortable providing the lessons, she would always work with the teacher and present the lessons herself. She remarked she appreciated the opportunities to go into the classrooms because it provided a chance to hear directly from the students and learn firsthand about the questions they were asking.

Ms. Procter presented the community resources provided to students as part of the SHARE curriculum. It was important to note there was no adopted textbook for the SHARE curriculum in the District and that she had only used a definition on consent for

the high school curriculum as part of a book referenced during public comment. The book was also listed as a parent resource on the SHARE website.

President Taylor thanked Ms. Procter for the clarification. She asked why the Crisis Pregnancy Center was not listed as a community resource. Ms. Procter stated the question had previously been raised and she spoke with the medical representative on the SHARE Advisory Committee, who was a certified family nurse practitioner, for a clear and easy to understand reason why the Crisis Pregnancy Center was not listed. The reason why it was not a good choice to provide to students was, "Much of the medical community considers Crisis Pregnancy Centers to be unethical, as often their organizations seek to intercept women with unintended pregnancies to prevent abortions. They often state they are providing 'medical services' and yet they have no licensed medical staff and are not subject to regulatory bodies, licensure, or credentialing. Given that they are not licensed medical clinics, they cannot legally be held to the privacy requirements in the HIPPA Act, which can lead to violations of client privacy, especially surrounding adolescent populations. Often Crisis Pregnancy Centers engage in 'counseling' services that are misleading, false, and not evidenced-based."

Trustee Nicolet wondered if there were other opportunities for students, whose parents had opted them out of the SHARE curriculum, to learn about the basic human sexuality system. Ms. Procter noted if a parent opted their child(ren) out, then they were opted out of all of the SHARE curriculum. In high school, students were required to take a health class where they might learn the basics of human development, but the information was not the same or as extensive as what was provided as part of the SHARE program. The curriculum was available on the District's website if parents were interested in providing the information themselves to their children. Ms. Fox added parents were required to fill out the information whenever they enrolled a student for a new school year, so as children entered into higher grades, parents could change their minds.

Trustee Nicolet asked what was meant by "meet the needs of diverse populations." Ms. Procter commented that it meant the District was meeting the needs of all students in the curriculum, to include the needs of the LGBTQ+ population. The intent was always to have the parents as the first educator at home and that the District was reinforcing or supplementing information. However, it was also important to remember there were some children who were not provided those opportunities. Students needed to know certain information to ensure their own health and safety, which included the correct usage of terminology.

Trustee Church inquired if a parent could attend the SHARE lessons. Ms. Procter cautioned that would not be appropriate for parents to sit in on the lessons because of the conversations that could occur with other students. Additionally, before each SHARE lesson, the students were reminded that the topics that occurred during the

lessons were not to be discussed outside of the lesson, and then only at home with a parent. Index cards were also provided to students at the beginning of each lesson to allow the opportunity to ask anonymous questions.

Trustee Minetto expressed concern that the Crisis Pregnancy Center was still not included because other medical professionals might disagree with the views of the Committee representative. Ms. Procter affirmed that she could not support the inclusion of the organization as a medical resource if they did not have to have a licensed medical professional on staff.

Trustee Caudill mentioned he did not see anything controversial in the lessons and that the District had been providing so many resources and supports to parents. He was concerned with including Planned Parenthood as a resource because they were a public school district.

President Taylor noted it was important to remember that Nevada law required school districts to provide instruction on certain topics and she appreciated there was a complete review occurring of all grades to ensure they were relevant to what was currently occurring.

Trustee Church asked where Planned Parenthood was included as part of the curriculum. Ms. Procter replied that Planned Parenthood was used as a resource in the development of the curriculum, but their information was not provided as part of the 6th grade curriculum.

President Taylor opened the meeting to public comment.

Emily Mimnaugh was a local attorney representing Pacific Justice Institute. She had reviewed the proposed curriculum and believed there were at least two legal objections. She stated she was concerned about parents actually providing informed consent and that resources were provided on certain sectarian groups, while others were left out. She provided examples of where she believed the legal concerns were obvious.

Kristen DeHaan was a teacher in the District. She expressed her support for the proposed curriculum, especially related to social media. She provided information to the Trustees on how social media made adults feel, thus it was critical to educate students so they had a better understanding of how and what they were feeling when they read comments that were unkind or hurtful.

Baillie Stewart was a teacher at a District sponsored charter school, who was responsible for providing the SHARE lessons. She thanked staff and the SHARE Advisory Committee for the proposed curriculum because the current curriculum was the same curriculum she received when she was a 6th grader in the Washoe County

School District. She stated she did not see anything in the curriculum that her students would not understand or were already having quiet conversations about with each other. She believed the new curriculum was more focused and medically driven than the current version.

President Taylor requested Legal address some of the concerns raised during public comment. Neil Rombardo, Chief General Counsel, noted the instructional materials were not required to be available to the public until after the Board had approved the curriculum. It was challenging to address all the concerns raised during public comment without time to research the concerns, but he believed the proposed curriculum met the requirements outline in Nevada Revised Statutes. He would need to conduct some additional research on if counselors were actually teaching the SHARE lessons, but it was the Board's purview to approve the curriculum and the Superintendent's purview on who taught the curriculum.

President Taylor appreciated the information. It was clear the District had to teach SHARE and that it was up to the Board to approve the curriculum, so the one question that would need to be reviewed was for the Superintendent to confirm who could teach the lessons.

Trustee Church requested clarification on the law and if the Board had to approve the teachers who were providing the lessons. Mr. Rombardo noted the law referred to was more a reference to how education professionals were hired in smaller school district across Nevada, which had the Board approve the hiring. The Washoe County School District Board of Trustees had authorized personnel decisions, namely hiring and firing, to the Superintendent.

It was moved by Trustee Thigpen and seconded by Trustee Nicolet that **the Board of Trustees approves the proposed 6th Grade SHARE curriculum, as recommended by the SHARE Advisory Committee.** The result of the vote was 5-2: (Yea: Jacqueline Calvert, Jeff Church, Diane Nicolet, Angela Taylor, and Kurt Thigpen. Nay: Andrew Caudill and Ellen Minetto.) Final Resolution: Motion Carries.

I would like the following statement of concern to be read into the record at the upcoming board meeting:

Dear WCSD Board,

I am the parent of a 3rd grader and a Kindergartner at Incline Elementary.

I am writing to express my utter dismay at the new mask policy which was implemented with approximately 12 hours notice and in violation of CDC guidance.

I understand the science, that children are not driving the pandemic and that cases of covid are down. People are getting vaccines, which is good. But my children do not have access to the vaccines. You have forced my family to make an impossible choice: risking my childrens' health to send them to interact among large groups of unvaccinated and unmasked people in an indoor setting, or deny them their education.

Thank you for your email.

As you may know, on Sunday evening the Nevada Department of Education issued guidance for school districts across the state regarding the use of masks in our schools and on school buses to prevent the spread of COVID-19. Please see the new guidance below:

• Students who are 9 years of age and younger do not need to wear a face mask when they are inside or outside of

a school building.

- All other students must continue to wear a face mask inside of school buildings but may remove their mask outside during lunch, recess, or PE.
- All students and staff must continue to wear a face mask when they are on a school bus
- All staff must continue to wear a face mask inside school buildings regardless of vaccination status
- Staff who are fully vaccinated do not need to wear a mask when they are outdoors or outside of a school building.

The Washoe County School District has followed Governor Directives and state guidance as we've worked to keep our schools safe throughout this challenging year. I also know that no COVID action we've taken has met the approval of everyone, as this is a very personal, challenging and polarizing issue. As such, I understand that regardless of how hard we try, there are unfortunately no answers today that will please everyone. Some families believe that the NDE moved too quickly. Others believe that this does not go far enough. It's been a real challenge.

For those families who would like the guidelines to go farther and faster, we hear you. We simply asked for your patience as protocols continue to be rolled back safely. For those who believe that these new guidelines go too far, we hear you, too. Please know that this is not a mandate. And we encourage you to make the best decision for your family as it pertains to continuing to wear masks.

Good evening,

Thank you for taking the time to read this correspondence. As of last week, the CDC has released new guidance regarding those that are vaccinated. "Update that fully vaccinated people no longer need to wear a mask or physically distance in any setting, except where required by federal, state, local, tribal, or territorial laws, rules, and regulations, including local business and workplace guidance" https://www.cdc.gov/coronavirus/2019-ncov/vaccines/fully-vaccinated-guidance.html

On 5/3/21 Governor Sisolak signed emergency directive 045, "which updated the mask and face covering requirements for the State of Nevada to align with the CDC's recommendations on mask usage, including any subsequent guidance issued by the CDC. As a result, the updated guidance on masks issued today by the CDC is effective immediately in Nevada."

My questions still stands, from the last correspondence I sent on 4/27/21, can the mask requirement for teachers be lifted? In addition, will mask requirements for students be removed? Specifically, for children 3-9 (students in pre-k through 3rd grade)? The Governor, in directive 024, stated that children under 9 do not have to wear masks, "young children between the ages of two and nine are exempt from this requirement".

While the CDC may *recommend* that those not vaccinated should continue to wear masks (including children), I have to ask if this is the best recommendation that our district continue to enforce when our own Governor never made that a requirement. Children, specifically birth-11 can't control when or if a vaccine will be approved for them to receive. Why should they continue to be forced to wear masks when a *possible* requirement isn't yet achievable? Our county (not just school district), as of 5/16, has 54 active cases in children 0-10. *I have included the 0-4 population as the pre-k classes have students 3-4 years of age*. The total population for that age range is 63,211. This is less than .1%.

There are 31,510 enrolled students in PreK-6th grade. *This number includes some middle schools that have a PreK, 5th or 6th grade on campus. Marvin Picollo's enrollment numbers for PreK-6th grade are also included. The district website, as of 5/12/21, states that there are 23 active cases in that grade range (PreK-6th). This is similar to the entire county count in that the total of active cases for students in PreK-6th grade is less than 1%.*

Why should students in PreK-6th grade continue to be forced to wear masks when the percentage of active cases for that age range is below 1%?

My son attends a strategies PreK in WCSD as a typical peer. Strategies classroom are designed for students with autism. Young students with or without autism learn a great deal in early instruction and intervention classrooms. Language and social development are 2 areas targeted in the classroom he attends. Current guidelines restrict peer interaction and shared materials and are limiting language development. Students are making progress, but not as much in years past. I would know as my daughter also attended this program 2 years ago. Having a mask covering a teacher's face limits a child's ability to see how certain sounds and words are formed. Having a mask cover children's faces limits their willingness to engage with each other and the teacher. Having a mask covering a teacher's and children's faces doesn't allow for children to read facial expressions. All of this delay language development and decrease positive peer interaction and relationships. Limiting interaction by enforcing social distancing, not allowing the use of shared materials, and continuing to enforce mask wearing is detrimental to their growth, relationships, and education.

Teaching Kindergartners, and other grade levels I imagine, with a mask on is difficult. Some students can't hear sounds of letters correctly (vowel sounds are especially difficult). They aren't able to see (behind my mask) the shape my mouth makes to distinguish the sound difference. I have tried the clear mask and they just fog up. Directions are not as clear; my voice has been "lost" many days this year because I'm trying to project my voice.

Again, I ask: have you been able to see a child's face when they are asked a question and are told to "speak louder" or "project their voice"? It's heartbreaking. They may already be unsure of themselves and we are forcing them to speak louder because of masks. This can result in embarrassment or eventually give them anxiety about speaking. Please don't suggest that a child can write a response. In upper grades, that is feasible, not in Kindergarten.

I have read published articles that include a statement from Dr. McNeill saying she is waiting for further guidance from the Nevada Department of Education regarding mask guidelines. Please, to everyone involved, consider changing the mask requirement for students under 9 and vaccinated adults.



Welcome to the wild west of gamblers, prostitutes, cowboys, and rogue superintendents. In the final three weeks of an untoward school year, Superintendent McNeil makes a unilateral decision to rescind the mask requirement for children ages 9 years old and younger in the Washoe County School District. McNeil, who has previously exuded favoritism towards a vociferous minority of facebook friends demanding personal freedoms, has once again taken an audacious, forceful move that has left many stakeholders aghast of what to do. Her decision was so slapdash that the principal of my child's elementary school was not even aware of the district policy until she checked her phone the next morning with no lead up that this was going to occur. According to the state superintendent, Jhone Ebert, the NDE guidance was to keep masks in place for the remainder of the school year and to consult with local health authorities before dropping masking. The CDC is recommending that children in public schools should still be wearing masks to protect them from variants of COVID that are more contagious. When I contacted Trustee Thigpen of the board of trustees, he purported that due to the 'drastic' change of mask requirements by the CDC and Nevada Department of Education, the board relinquished the sole decision powers to the superintendent. So what are parents who are not comfortable with this drastic shift supposed to do? What choices have been afforded to them? From the calls and emails that I have made, none so far. I am submitting public comment in lieu of attending the meeting. It was beyond irresponsible for the Superintendent to make a sudden, rash decision to allow children 9 years and younger to no longer wear masks in the classroom. Parents, teachers, and administrators were informed late on Sunday night before the start of a school week. What compelled the Superintendent to make such a call is unknown. My name is Dr. Steven Althoff. I have been a practicing pediatrician in Reno, NV for 20 years. I have about 30 years of combined experience teaching students at the University of Illinois, the Mayo Clinic (Rochester, MN), and the University of Nevada (Reno).

Recently a letter to the WCSD signed by 33 local pediatricians and pediatric sub specialists was published in the RGJ criticizing the decision to allow children under the age of 9 to attend schools without masks. I would like the board to recognize that I and many other physicians purposefully did not sign that letter.

While it can be argued that the timing (with only a few weeks left in the school year) was ill-advised, it cannot be argued that there is clear data to support that the wearing of masks by this age group prevents deaths due to Covid19. Specifically due to the lack of data, the WHO recommendation provides a great deal of latitude in this regard.

In short, for clinicians to publicly criticize the WCSD for this decision in particular was a gross over reaction. Pediatricians and the WCSD should be working together to care for our community of children. In my opinion the WCSD has done an admirable job of walking the "mine field" of decision's to be made over the past year.

Be advised, as a taxpayer of Washoe County, I object to the Draft PURCHASE AND SALE AGREEMENT AND ESCROW INSTRUCTIONS as drafted (and attached) which will eventually complete the sale of the Old Incline Village Elementary School located at 771 Southwood Blvd, Incline Village NV to the Tahoe Transportation District (TTD).

The reason for this objection is as follows:

Currently, condition # 4 of Page 1 of the WASHOE COUNTY SCHOOL DISTRICT BOARD RESOLUTION 20-009 (attached) - i.e A resolution of intent to sell a 6.41-acre parcel located at 771 Southwood Boulevard in Incline Village, NV to the Tahoe Transportation District for \$2.35 million in accordance with Nevada Revised Statutes 277.050, states "The transaction must close as soon as reasonably possible after all

approvals by the Washoe County School District and the Tahoe Transportation District are complete and legally valid."

I believe that Items 9.5 and 9.6 of the attached Draft PURCHASE AND SALE AGREEMENT AND ESCROW INSTRUCTIONS (attached) obtained by a public records request from the Tahoe Transportation District (Agenda Item VII.A ATTACHMENT D of TTD Board Agenda Packet of March 12, 2021, Pages 70 and 71) By and between SELLER: Washoe County School District and BUYER: Tahoe Transportation District are not valid and misrepresent Sellers (WCSD) knowledge of the location and nature of any underground storage activities, buried foriegn materials and fill areas and further, misrepresent the Seller's knowledge with regard to any use, placement, storage, discharge or release of any hazardous materials or other toxic waste substances as defined or regulated under federal, state, or local laws as well as misrepresentation of any hazardous substances at any time being used, placed, stored, discharged, or released on the subject real property by Seller.

Items 9, 9.5 and 9.6 of the Draft Purchase and SALE AGREEMENT AND ESCROW INSTRUCTIONS state:

9. SELLER REPRESENTATIONS AND WARRANTIES.

Seller makes the following representations and warranties to the best of Seller's actual knowledge,

and agrees to the following covenants and obligations for the benefit of Buyer.

9.5 Seller has no knowledge of the location and nature of any underground storage activities,

buried trash or foreign materials, fill and disposal areas or other sites of this sort on the subject real

property, whether these sites are visible from the surface of the land or not.

9.6 Seller represents and warrants that it has no knowledge of any use, placement, storage, discharge or release of any hazardous or toxic wastes or substances as defined or regulated under federal,

state, or local laws ("Hazardous Substances") on the subject real property nor, to the best of Seller's

knowledge, except as specified in this subsection, <u>have any Hazardous Substances at any time</u> been used,

placed, stored, discharged, or released on the subject real property by Seller or any third party.

I hereby allege that the Washoe County School District knows or should have known about:

- The history of the property's 10,000 gallon underground petroleum oil storage tank (UST).
- Past sample findings of Oil and Grease on the property referred to in a report by Western Environmental Testing Laboratory dated 5/4/2011.
- Significant and existing presence of asbestos as well as potential public contamination and
 exposure over the life of the school, connected with building construction materials within
 the existing school buildings, now abandoned and <u>currently existing as a health hazard and
 a public nuisance.</u>

PURCHASE AND SALE AGREEMENT AND ESCROW INSTRUCTIONS

THIS AGREEMENT is made and entered into by and between <u>Washoe County School District</u>, herein referred to as "Seller"; and <u>Tahoe Transportation District</u>, hereinafter referred to as "Buyer". The effective date of this Agreement shall be the date of the last signature hereto.

1. GENERAL.

- 1.1 Seller is the owner of that certain real property (the "subject real property") consisting of approximately 6.41 acres located at 771 Southwood Boulevard in Incline Village, Washoe County, Nevada, known as Assessor's Parcel Number 132-201-02 and further identified as the Incline Village Elementary School Site.
 - 1.2 Buyer wishes to purchase the subject real property.

2. PURCHASE AND SALE OF REAL PROPERTY.

2.1 Subject to the terms and conditions of this Agreement, Seller hereby agrees to sell and Buyer hereby agrees to purchase the subject real property together with all of Seller's right, title and interest herein.

3. PURCHASE PRICE.

3.1 The purchase price for the subject real property shall be the amount of <u>Two Million Three Hundred Fifty Thousand Dollars (\$2,350,000)</u> (the "Purchase Price"). Buyer shall deposit full purchase price, plus buyer's portion of closing costs at close of escrow.

4. WATER RIGHTS/MINERAL RIGHTS.

- 4.1 This Agreement includes all Seller's right, title or interest to appropriated or unappropriated groundwater lying underneath the surface of the subject real property and any right of Seller to surface water appurtenant or otherwise found on the subject real property.
- 4.2 The subject real property includes all right, title and interest of Seller, if any, in and to all aggregates, minerals, gas, oil, coal, hydrocarbon, shale, steam, geothermal and other subterranean rights in the land, of whatever nature, upon or under the subject real property.

5. ESCROW AND CLOSING.

5.1 The consummation of the purchase and sale contemplated by this Agreement shall take place through an escrow at <u>Ticor Title Company</u>, <u>Attn: Luann Barnes</u> hereinafter referred to as "Escrow Holder" or "Title Company".

- 5.2 Consummation of this escrow shall be in accordance with the following terms and conditions.
 - (A) A fully executed copy of this Agreement shall be deposited with Escrow Holder as escrow instructions, with any amendments or additional instructions which may be needed from time to time by Escrow Holder for purposes of performing its functions under this Agreement. Escrow Holder is hereby appointed and designated to act as such and is authorized and instructed to deliver, pursuant to the terms and conditions of this Agreement, the documents and money to be deposited into escrow as hereinafter provided, with the terms and conditions continued herein to apply to such escrow. Seller and Buyer hereby agree that each shall, during the escrow period, execute any and all documents and perform any and all acts reasonably necessary or appropriate to consummate the purchase and sale pursuant to the terms set forth in this Agreement.
 - (B) Seller shall deposit into escrow, on or before close of escrow for each closing:
 - (i) An executed Grant, Bargain and Sale Deed ("Deed") in recordable form conveying the subject real property purchased and sold hereunder; and
 - (ii) Executed FIRPTA certificate.
 - (C) Escrow Holder shall cause to be drafted any other documents to be recorded or signed by the parties.
- 5.3 Buyer shall cause Escrow Holder to supply Buyer a preliminary title report on the subject real property within five (5) days of the date of execution hereof, including copies of the documents giving rise to the items of exceptions thereto. Within twenty (20) days of the date of execution hereof, Buyer shall object to any item contained in said preliminary title report and the failure to do so shall constitute Buyer's acceptance that the subject real property shall be conveyed in accordance with the preliminary title report subject to that item. In the event that Buyer objects to any item contained in the preliminary title report, Seller shall have twenty (20) days in which to discharge or arrange for the discharge of said item from record title. If Seller cannot or will not discharge the item, in Seller's sole discretion, and Buyer will not waive its objection, Seller or Buyer may terminate this Agreement and the earnest money deposit together with the interest earned thereon shall be refunded to Buyer.

In the event of such termination, neither party shall have a claim for damages against the other party. Seller agrees to convey the property free and clear of all liens and encumbrances, save and except those exceptions contained in the preliminary title report to which Buyer has agreed. If Buyer fails to terminate this Agreement as specified in Subsection 8.3 of this Agreement prior to the satisfaction of any conditions or provisions contained in this Subsection, Buyer shall be deemed to have waived them.

5.4 Buyer shall cause a policy of standard title insurance to be issued at closing issued by First American Title insuring title on the subject real property conveyed, subject only to matters of record appearing on the preliminary title report which are not disapproved by Buyer. The title policy shall have liability limits of not less than the Purchase Price.

6. <u>ESCROW CHARGES</u>.

6.1 Escrow Holder shall charge and collect from the Seller the following at each closing:

- (A) The cost of the title insurance for a customary ALTA standard coverage title policy, however, if Buyer requires an ALTA extended coverage policy of title insurance, any costs in excess of those set forth in this subsection shall be borne by Buyer;
- (B) One-half of the escrow charges;
- (C) One-half of the tax on the transfer of real property provided for in Sections 375.010 through 375.110 of the Nevada Revised Statutes, as amended; and
- (D) Any taxes for the current fiscal year, which taxes shall be pro-rated between the Seller and the Buyer as of the date of the close of escrow.
- (E) \$3,500 for the cost of the April, 2019 appraisal performed by Johnson-Perkins and Associates and reviewed by Carter-Ott, with credit for same amount issued to Buyer.
- (F) \$2,500.00 for the cost of the October 2020 Phase 1 Environmental Assessment performed by Converse Consulting, with credit for same amount issued to Buyer.
- 6.2 Escrow Holder shall charge and collect from the Buyer the following at each closing:
 - (A) The remaining cost of the title insurance, survey required by the title company and/or desired by Buyer and additional title endorsements, if any;
 - (B) One-half of the escrow charges, together with charges, if any, for investing the earnest money deposit;
 - (C) One-half of the tax on the transfer of real property provided for in Sections 375.010 through 375.110 of the Nevada Revised Statutes, as amended;
 - (D) The cost of recording the Deed; and
 - (E) Any taxes for the current fiscal year, which taxes shall be pro-rated between the Seller and the Buyer as of the date of close of escrow.
 - (F) The Washoe County School District is exempt from taxes. A credit shall be issued by the title company at closing for any taxes charged to the District; OR a letter from the title company to the Washoe County Treasurer shall be issued requesting a refund to the Washoe County School District for any taxes paid as a part of this transaction.
- 6.3 Seller and Buyer hereby authorize Escrow Holder to insert the date of close of escrow as the recordation date of each deed. The Escrow Holder is further authorized to insert the date of close of escrow and to fill in the blank spaces in any and all documents and instruments delivered to it, so long as it is done in conformity with this Agreement.
 - 6.4 At each closing as hereinafter defined, Escrow Holder shall:
 - (A) Cause the Deed to be recorded in the office of the County Recorder of Washoe County, Nevada;

- (B) Deliver to Buyer a copy of the recorded Deed, the original FIRPTA certificate signed by Seller, and the title policy as provided herein and other instruments conveying title to the real property; and
- (C) Deliver to Seller the payment specified in Section 3 above.

7. CLOSE OF ESCROW.

7.1 Close of escrow shall occur on or before <u>forty (40) days</u> from the execution date hereof. If escrow does not close in a timely manner, this Agreement shall be terminated.

8. <u>DUE DILIGENCE</u>.

- 8.1 Buyer shall have thirty (30) days from the date of execution to conduct such due diligence investigations as Buyer, in Buyer's sole discretion, deems necessary to determine the feasibility, economic or otherwise, of its intended development. Buyer shall pay all costs and expenses incurred to conduct the investigation and studies.
- 8.2 Buyer shall have thirty (30) days from the date of execution to obtain formal approval of this purchase from Board of Trustees.
- 8.3 If Buyer fails to obtain approval from the Board of Trustees and/or determines within this due diligence period that Buyer's intended development is not feasible, Buyer shall so notify Seller in writing and this Agreement shall be immediately terminated. If Buyer fails to so notify Seller within this due diligence period, Buyer shall be deemed to have waived its right to so terminate and the due diligence period shall have expired.
- 8.4 The subject property is being sold "as is", "where is" and "with all faults" as of closing, without any representation or warranty whatsoever as to its condition, fitness for any particular purpose, merchantability or any other warranty, express or implied other than those listed herein. Buyer acknowledges that Buyer is purchasing the property based solely upon Buyer's own independent inspections, investigations and findings and not in reliance upon any information provided by Seller or Seller's agents. Buyer acknowledges that the zoning of the subject real property may not meet Buyer's requirements for development ("Buyer's Intended Use"). Seller makes no representations and warranties in this regard, or with regard to any other issue of the feasibility of developability of the subject real property for Buyer's Intended Use (including Buyer's ability to acquire any permits required by government entities, or any agreements with government entities). It is the intent of the parties that Buyer shall independently verify and satisfy itself on all issues of development feasibility during the due diligence period without reliance on any representation of Seller (or Seller's representatives), and that Buyer's sole remedy in the event any aspect of Buyer's development feasibility expectations are not satisfied, in Buyer's sole discretion, is to terminate this Agreement pursuant to Subsection 8.3.

9. SELLER REPRESENTATIONS AND WARRANTIES.

- 9.6 Seller represents and warrants that it has no knowledge of any use, placement, storage, discharge or release of any hazardous or toxic wastes or substances as defined or regulated under federal, state, or local laws ("Hazardous Substances") on the subject real property nor, to the best of Seller's knowledge, except as specified in this subsection, have any Hazardous Substances at any time been used, placed, stored, discharged, or released on the subject real property by Seller or any third party.
- 9.7 Seller represents and warrants to Buyer that Seller is not, and will not be at the time of close of escrow, a foreign person as defined in Section 1445 of the Internal Revenue Code of 1986, as amended, and agrees prior to close of escrow to execute a non-foreign person affidavit.

All notices, requests, demands or other communications required under this Agreement or given pursuant to this Agreement shall be in writing and shall be deemed given and duly delivered: (i) upon personal delivery; or (ii) if delivered by overnight express carrier, upon the next business day following delivery to said carrier; or (iii) as of the second day following the day deposited in the United States mail with postage prepaid and properly addressed to the appropriate party at its address set forth in preceding Subsection above, or at such other place as such party from time-to-time hereafter designates to each other party in writing.

All such notices, requests, demands or other communications may also be given by telecopier, telex, telegram, or cable provided the same shall be confirmed by letter dispatched on the same date in accordance with the requirements described above. In such event, such notices, requests, demands or other communications shall be deemed given upon actual transmission to the recipient party of the telex, telegram or cable.

That said, there have been recent issues for which the board and/or Superintendent has acted without seeming to consider the evidence. In particular I am deeply concerned about Superintendent McNeill's decision to remove the mask requirements in schools. As a scientist I know that it is critical to consider the evidence before making a decision. In the case of masks it has been reported that the county health officials were not consulted and national public health expert recommendations were not followed. Comments to the Washoe County Board of Trustees

Dear Trustees,

May I first say that your service on the Board during this difficult time is commendable. The task is especially grueling considering the difficult decisions made concerning COVID-19 restrictions on the following:

- 30% distance learning on 62,000 students equates to 43,400 in class learning students.
 (If NICHE Washoe County School District data is used 67,113 students are in grade PK, K-12 with a student-teacher ratio of 18 to 1. This calculates to approximately 3,729 teachers.)
- 2. Facemask wearing requirements for children.

In pointing out that the WCSD *current number* of reported active cases of COVID-19 is **25** across attending students equals .06% of all physically attending students in the school district. *One* case of COVID-19 in staff. Or .03% of staff.

As of today, the 26 cases in the school district are approximately .0000056 or .0006% of the population of Washoe County's 465,735 residents. (Proposed population of 485,849 for the year 2021 according to the World Population Review.) Currently there are 357,214 adults of which 72,890 are seniors in Washoe County.

Using the statistics of .001 mean statistics of the number of IFR= Covid deaths/Covid Infections for 5-9 and 10-14 year old's and .003 for 15-19 year old. Note: 1.075 for 65-69 year old, 1.674 for age group 70-74, 3.203 for 75-79 year olds, and 8.292 infection death rates for those adults over 80. These statistics are available from an article COVID Infection Fatality Rates by Sex and Age by Alex Berezow, PhD, November 18, 2020. This indicates that the virus discriminates attacking and killing those in the age groups 65+, 107 times more often than those in the age group of 5-14 year olds.

To generate the best estimates possible, a team of scientists led by Megan O'Driscoll and Henrik Salje collected data on COVID 19 deaths. Observations worth noting are, "people of college age and younger are very unlikely to die. The 5-9 and 10-14 age groups are the least likely to die. Those in the 0-4 and 15-19 age groups are three times likelier to die than the 5-9 and 10-14 age groups, but the risk is still exceedingly small at .003% or 3 deaths for every 100,000 infected." Since only 4,614 total cases of students and staff infections of COVID-19

have been reported in the WCSD, this is a total ratio of 7% infection rate. Calculating 4614 WCSD infections /220124 confirmed cases for the state of Nevada, the rate of 2% of the WCSD/total State of Nevada confirmed cases.

Based upon the percentages, .00001 or .001% (1 out of 100,000) of the 34,133 5-10 year olds, and .003 (3 out of 100,000) 11-18 year olds of 50,920 (Population of the age groups per WCSD website, the total of 85,053 is still less than 100,000 and therefore, zero deaths for WCSD have been calculated and zero deaths have been recorded.

In the US., just over 100 children under the age of 15 have died from COVID-10 in 2020 per TIME article, "Fewer Children Died in 2020. Despite the Pandemic, Experts are Trying to Figure Out Why." By Emily Barone, January 14, 2021. COVID is amounting to 100 out of 26,000 deaths in children. This is .5% of all children's deaths." Citing US Data, Dr. Perri E Klass, a New York pediatrician and author of the 2020 book, A Good Time to be Born: How Science and Public Health Gave Children a Future, "most child deaths are in the first month of life, and they are linked to premature gestation and reasons that are connected to the circumstances right around their birth. Indeed, the leading cause of childhood mortality in the U.S., after the newborn stage is unintentional injury, things like drownings, car accidents, pedestrian fatalities and accidental suffocations."

While it is possible that the wearing of facemasks have kept children from getting ill, researchers found that influenza, respiratory syncytial virus and other common respiratory viruses died out quickly in response to lockdown measures designed to target COVID-19 such as mask wearing and washing hands. These prevented COVID-19 as well as the other viruses. Unfortunately, the lockdowns may have contributed to a lessening of prenatal care for the unborn.

It appears from the data that the risk of infection and death in the attending students of Washoe County School District is low and could be considered nominal. While everyone's reaction is different and those with underlying conditions are more at risk, most cases are mild to moderate. Are we subjecting our children and students to unnecessary and trivial requirements of "distance learning" and wearing of facemasks in lieu of a providing quality education.

We can try to protect our children but to what cost? Lack of quality education, mental health issues, confidence issues, and unreported childhood abuse and neglect are the issues that are the flip side of our protecting them from COVID-19.

- 1) Parents were not consulted and the decision to remove masks was literally communicated to parents 12 hours before the new rule would go into effect. Such an expeditious decision did not seem to be in the best interest of the children or their community.
- 2) The Washoe County Health district was not consulted and they are against this decision.
- 3) The CDC still recommends that school-age children continue to wear masks until the end of the school year, as not a single child under the age of 16 will be fully vaccinated by the end of the school year.

My mother again reiterated about my family and to embrace my culture and to feel proud that I am of a mixed race. She began to explain how unfortunate it was this teacher was very misguided in her teaching methodology. She explained that this private matter regarding family roots was something that should be taught to children by a parent or extended family member regarding their heritage and family history, so a child can feel a sense of pride and not to be ridiculed by a teacher that apparently didn't know her place and had overstepped her authority.

Being called "Black" is a derogatory term when you are in fact an African American. To be a mixed race and to have to pick one race to identify with is earth shattering when in the comfort of your home you are taught to embrace both or multiple (as I have many). NOTICE FOR EMPLOYERS, UNIVERSITIES AND OTHER INSTITUTIONS MANDATING COVID-19 MASKS

April 26, 2021

This serves as notice that the mandate for any individual to wear a mask against COVID-19 for employment or attendance at a university or other institution violates federal law. All COVID-19 masks, whether surgical, N95 or other respirators, are authorized, not approved or licensed, by the federal government; they are Emergency Use Authorization (EUA) only. They merely "may be effective." Federal law states:

Title <u>21 U.S.C.</u> § <u>360bbb-3(e)(1)(A)(ii)(I-III)</u> of the Federal Food, Drug, and Cosmetic Act (FD&C Act) states:

individuals to whom the product is administered are informed—

(I) that the Secretary has authorized the emergency use of the product; (II) of the significant known and potential benefits and risks of such use, and of the extent to which such benefits and risks are unknown; and (III) of the option to accept or refuse administration of the product, of the consequences, if any, of refusing administration of the product, and of the alternatives to the product that are available and of their benefits and risks.

EUA products are by definition experimental and thus require the right to refuse. Under the Nuremberg Code, the foundation of ethical medicine, no one may be coerced to participate in a medical experiment. Consent of the individual is "absolutely essential." A federal court held that even the U.S. military could not mandate EUA vaccines to soldiers. *Doe #1 v. Rumsfeld*, 297 F.Supp.2d 119 (2003).

In a <u>letter</u> dated April 24, 2020, the Food and Drug Administration stated that authorized face masks must be labelled accurately and may not be labeled in a way that misrepresents the product's intended use as "source control to help prevent the spread of SARS-CoV-2." The letter specifies that the labeling "may not state or imply that the product is intended for antimicrobial or antiviral protection or related uses or is for use such as infection prevention or reduction." Any EUA mandate requiring individuals to wear face masks conflicts with Section 360bbb-3(e)(1)(A)(ii)(I-III), which provides that the person must be informed of the option to refuse to wear the device.

Liability for forced participation in a medical experiment, including possible injury, may be incalculable. Children's Health Defense urges U.S. employers, universities and other institutions to respect and uphold the rights of individuals to refuse to wear EUA masks.
