MINUTES OF THE JUNE 22, 2021 REGULAR MEETING OF THE WASHOE COUNTY SCHOOL DISTRICT BOARD OF TRUSTEES

June 22, 2021

1. Opening Items

1.01 CALL TO ORDER

The regular meeting of the Board of Trustees was called to order at 2:00 p.m. in the Board Room of the Central Administration Building, located at 425 East Ninth Street in Reno, Nevada.

1.02 ROLL CALL

President Angela Taylor and Board Members Jacqueline Calvert, Andrew Caudill, Jeff Church, Ellen Minetto, and Diane Nicolet were present. Board Member Kurt Thigpen was present via video conferencing. Superintendent Kristen McNeill and staff were also present.

1.03 PLEDGE OF ALLEGIANCE

Debra Biersdorff, Deputy Superintendent led the meeting in the Pledge of Allegiance.

1.04 **ACTION TO ADOPT THE AGENDA**

President Taylor opened the meeting to public comment.

John Eppolito expressed disappointment in the divisiveness President Taylor and Superintendent McNeill had fostered in the District and community. He felt by removing the first General Public Comment agenda item, the Board was trying to silence the parents and community members who were not following their line.

Nicol Herris stated it was inappropriate for President Taylor to remove the first General Public Comment agenda item because it would force the community members to stand outside in the hot sun or sit for very long periods of time in order to exercise their freedom of speech. She recommended the Board reduce the number of agenda items they heard instead of the public comment periods.

Bruce Parks remarked that by removing the first General Public Comment period, President Taylor was showing her clear distain for the community. He stated the Board should focus on their job of producing students who could function in society.

Melanie Sutton agreed with the prior comments. She noted there were a lot of people who wanted to attend the meetings but there was no room in the Board Room for everyone so they had to stay outside.

Neil Rombardo, Chief General Counsel, noted the meeting began with 27 empty seats in the Board Room. At the present time, there were 12 empty seats and the overflow room was not being used.

Matt True felt if the Board managed their time better, their meetings would not last as long and there would be ample time for public comment.

Val White claimed that moving the General Public Comment period to the end of the meeting was an effort by the Board to silence those who disagreed with them. She urged parents to pull their children from District schools.

James Benthin felt the Board was in violation of Open Meeting Law by removing the first General Public Comment period. He was also interested in having Board Reports added back onto the agendas.

Katherine Snedgar claimed the Board was in violation of her free speech rights by removing public comment periods from the meeting.

Margaret Martini stated the Board was attempting to stifle those who did not agree with what they were doing in the schools by removing the public comment periods.

Blair Speth agreed with the prior comments about removing public comment. He urged the Board to conduct an external review of all policy changes made by Superintendent McNeill since she was responsible for the agendas.

The Board received an email from Kristen DeHaan regarding the agenda item.

Trustee Church expressed concerns about the changes made to the agenda format. He stated he could not approve the agenda because he believed the public comment period should not have been removed.

President Taylor stated the initial General Public Comment period was removed by the Board Leadership Team, after consultation with Legal Counsel, to allow those members of the community interested in specific agenda items the opportunity to have their voices heard as well.

It was moved by Trustee Caudill and seconded by Trustee Nicolet that **the Board of Trustees approves the agenda as presented.** The result of the vote was 6-1:

(Yea: Jacqueline Calvert, Andrew Caudill, Ellen Minetto, Diane Nicolet, Angela Taylor, and Kurt Thigpen. Nay: Jeff Church.) Final Resolution: Motion Carries.

2. Consent Agenda Items

Trustee Church requested Consent Agenda Items 2.04, 2.06, 2.14, and 215 be pulled for additional discussion.

President Taylor opened the meeting to public comment.

Valerie Fiannaca spoke on Consent Agenda Item 2.33. She felt the expenditure of close to \$4.3 million for insurance coverage was too much and that the Board would see additional law suits if they approved social justice policies.

It was moved by Trustee Caudill and seconded by Trustee Thigpen that **the Board of Trustees approves Consent Agenda Items 2.02, 2.03, 2.05, 2.07 through 2.13, and 2.16 through 2.37.** The result of the vote was Unanimous: (Yea: Jacqueline Calvert, Andrew Caudill, Jeff Church, Ellen Minetto, Diane Nicolet, Angela Taylor, and Kurt Thigpen.) Final Resolution: Motion Carries.

- 2.03 The Board of Trustees approved the minutes of the February 23, 2021 Work Session of the Board of Trustees.
- 2.05 The Board of Trustees approved the University of Nevada, Reno Field Based Instructor Agreement between Washoe County School District and the College of Education for reimbursement to the District of one (1) counselor in the amount of \$97,149 and three (3) teachers in the amount of \$242,000, for a total of \$339,149.
- 2.07 The Board of Trustees approved the purchase of bus fleet tires estimated at \$250,000 from authorized Michelin Tire and Service Centers through Joinder BuyBoard Contract #636-21 for the period of twelve (12) months July 1, 2021 through June 30, 2022.
- 2.08 The Board of Trustees approved the contract for Comprehensive K-12 Virtual School Program for one year beginning July 1, 2021 and ending June 30, 2022 in the estimated amount of \$415,350 to Pearson Online & Blended Learning K-12 USA (PEARSON).

- 2.09 The Board of Trustees approved the one-year agreement with Specialty Health for Wellness Screenings for 2021, in the amount of \$145,000.
- 2.10 The Board of Trustees approved the Agreement for Professional Services Contract for Architecture Services between H&K Architects & Washoe County School District for the Veterans Seismic Retrofit Phase 2 (Building A) in the total amount of \$320,000.
- 2.11 The Board of Trustees approved the renewal of the software licenses for comprehensive English Language (EL) programming from ELLevation Inc. in the approximate amount of \$236,857.82 for use throughout the District.
- 2.12 The Board of Trustees approved Amendment #2 to renew the College Readiness and Success Agreement with College Board for the SpringBoard English Language Arts (ELA) Program including student and teacher materials and resources for one (1) year beginning July 1, 2021 through June 30, 2022 in the estimated amount of \$130,851.05.
- 2.13 The Board of Trustees approved the Master Software and Services Agreement with Dreambox Learning for both distance learning and inperson instruction for math skills for all elementary schools and middle schools using the Elementary and Secondary School Emergency Relief Fund (ESSER II) under the Coronavirus Response and Relief Appropriations Act (CRRSA) not to exceed \$967,629.38.
- 2.16 The Board of Trustees approved the award of Request for Proposal (RFP) 21-004, Commercial Purchasing Card Program, to Commerce Bank for an estimated annual revenue share of \$350,000 for an initial term of one (1) year beginning July 1, 2021 and ending June 30, 2022 with four (4) optional one (1) year renewals.
- 2.17 The Board of Trustees approved, the following re-appointments to the Safe and Healthy Schools Commission (SHSC) for 2 year terms ending June 30, 2023: Leanne McCulley, Misty Vaughn Allen, Darin Balaam, Charlene Bybee, and Lorraine Benuto; and approved the appointment of Elizabeth Flores for a 2-year term ending June 30, 2023.
- 2.18 The Board of Trustees approved Renewal #3 of Request for Bid (RFB) #054-04-03-17, District-wide Heating, Ventilation, and Air Conditioning (HVAC) Repairs, to Quality Control Systems, Inc. as the primary supplier, Gardner Engineering and Mechanical Services, Inc. as the secondary supplier and Elite Air as the tertiary supplier in the estimated amount of

- \$402,000 for an additional one (1) year beginning August 1, 2021 and ending July 31, 2022.
- 2.19 The Board of Trustees approved the Authorization to Move Forward with Bid #21-106-B-05-DA, Tennis Court Replacement Project at Incline High School, in the estimated amount of \$400,000 with Ratification of the Award of this Project at a Future Board Meeting.
- 2.20 The Board of Trustees approved the Authorization to Move Forward with Bid #21-109-B-06-DA, Relocation of Portable Classroom Buildings to Nick Poulakidas Elementary School, in the approximate amount of \$470,000 with Ratification of the Award of this Project at a Future Board Meeting.
- 2.21 The Board of Trustees approved the Authorization to Move Forward with Bid #21-110-B-06-DA, Pavement Rehabilitation Projects at Lois Allen Elementary School, Caughlin Ranch Elementary School, Roy Gomm Elementary School, Hunter Lake Elementary School, Incline Elementary School, Smithridge Elementary School, Spanish Springs Elementary School, B.D. Billinghurst Middle School, and Fred W. Traner Middle School, in the estimated amount of \$402,500 with Ratification of the Award of these Projects at a Future Board Meeting.
- 2.22 The Board of Trustees awarded Bid #21-101-B-05-AA, Irrigation Upgrades at Huffaker Elementary School, to Garden Shop Nursery Landscaping Division, Inc. for \$102,550.
- 2.23 The Board of Trustees approved the appointments to the Audit Committee for two-year terms, beginning July 1, 2021 and ending June 30, 2023, of Wesley Chewjalearn, Vitalis Ozoude, and Debra Yates.
- 2.24 The Board of Trustees accepted the Annual Follow-up of the Transportation Department White Fleet and School Bus Services Audit, as recommended by the Audit Committee.
- 2.25 The Board of Trustees accepted the Annual Follow-up of the Property Control Audit, as recommended by the Audit Committee.

- 2.30 The Board of Trustees approved the Memorandum of Understanding between the Washoe County School District and the Washoe Education Support Professionals for the isolation allowance for Education Support Professionals assigned at Incline Village schools for \$325 per year.
- 2.31 The Board of Trustees accepted the Budget Transfer Reports and provided authorization to include budget transfers between functions or programs for the General Fund, Special Education Fund, Medicaid Fund, 2005 AB299 Indian Colony Fund, 2017C WC-1 G.O. Bonds Fund, 2019B WC-1 G.O. Bonds Fund, 2020A WC-1 G.O. Bonds Fund, 2017B Extended Rollover Bonds Fund, and the 2019 Extended Rollover Bonds Fund for the period May 1, 2021 through May 31, 2021 and approved the transfer of \$77,520.00 from the District's General Fund Contingency account to the Board of Trustees budget account in the official Board minutes, as required by Nevada Revised Statute 354.598005.
- 2.32 The Board of Trustees approved the grant application to The Nell J. Redfield Foundation for the Redfield Community Outreach Program for \$311,277.
- 2.33 The Board of Trustees approved the recommendation of the Risk Management Department for the renewal of the District's property, liability, excess workers' compensation, network security, crime, National Flood Insurance and Assault Threat & Response Coverage for the renewal policy period of July 1, 2021 through June 30, 2022 for \$4,296,222.
- 2.34 The Board of Trustees approved, pursuant to Nevada Revised Statute 286.523, Pupil Transportation Assistant as critical labor shortage areas in order to hire individuals under critical needs status.

- 2.35 The Board of Trustees approved the extension of the letters of agreement between the District and Accelify (Frontline) in the estimated amount of \$423,000 from July 1, 2021 to June 30, 2022.
- 2.36 The Board of Trustees approved the Memorandum of Understanding with the Board of Regents of the Nevada System of Higher Education, to support the dual enrollment and participation of Washoe County School District students with Intellectual/Developmental Disabilities (IDD) in the Path to Independence (P2I) Program at the University of Nevada, Reno during the 2021-2022 School Year in the amount of \$60,000.
- 2.37 The Board of Trustees approved the appointments of the following members to the Zoning Advisory Committee: Kristen DeHaan, Trustee Zone C Representation, for a 1-year term ending June 30, 2022; Lauren Rushing, At-Large Representative, for a 2-year term ending June 30, 2023; and Rachel Fisher, Certified Teacher/Counselor, for a 2-year term ending June 30, 2023.
- 2.04 POSSIBLE ACTION TO PROVIDE PRELIMINARY APPROVAL TO THE ADOPTION OF BOARD POLICY 9300, REPORTING OF FRAUD, WASTE, OR ABUSE, TO OUTLINE THE FILING AND INVESTIGATION PROCESS FOR COMPLAINTS, AND INITIATE THE 13-DAY PUBLIC REVIEW AND COMMENT PERIOD

Trustee Church requested additional clarification on the confidentiality of reporting because he was interested in seeing all complaints publicly reported, if legally allowable. He moved the Board of Trustees sends Board Policy 9300, Reporting of Fraud, Waste, or Abuse, back to the Board Policy Committee for additional revisions. The motion died for lack of a second.

It was moved by Trustee Minetto and seconded by Trustee Calvert that **the Board of Trustees provides preliminary approval to the adoption of Board Policy 9300, Reporting of Fraud, Waste, Or Abuse, and initiates the 13-day public review and comment period.** The result of the vote was 6-1: (Yea: Jacqueline Calvert, Andrew Caudill, Ellen Minetto, Diane Nicolet, Angela Taylor, and Kurt Thigpen. Nay: Jeff Church.) Final Resolution: Motion Carries.

2.06 APPROVAL TO PURCHASE FLEET FUELS ESTIMATED AT \$1,500,000 FROM PILOT THOMAS LOGISTICS THROUGH THE JOINDER STATE OF NEVADA PURCHASING FUEL CARD LOCK CONTRACT #99SWC-NV21-7551 FOR THE PERIOD OF TWELVE (12) MONTHS JULY 1, 2021 THROUGH JUNE 30, 2022

Trustee Church mentioned he had heard the District did not accept a lower bid and wondered why that was the case. Scott Lee, Director of Transportation, stated the contract was issued and approved by the State of Nevada. The District was only joining onto the State's contract.

It was moved by Trustee Caudill and seconded by Trustee Nicolet that the Board of Trustees approves the purchase of fleet fuels estimated at \$1,500,000 from Pilot Thomas Logistics through the Joinder State of Nevada Purchasing Fuel Card Lock Contract #99SWC-NV21-7551 for the period of twelve (12) months July 1, 2021 through June 30, 2022. The result of the vote was Unanimous: (Yea: Jacqueline Calvert, Andrew Caudill, Jeff Church, Ellen Minetto, Diane Nicolet, Angela Taylor, and Kurt Thigpen.) Final Resolution: Motion Carries.

2.14 APPROVAL OF THE MASTER SUBSCRIPTION LICENSES AND SERVICES AGREEMENT WITH ILLUMINATE EDUCATION FOR THE SCHOOLCITY WEB-BASED STUDENT DATA ASSESSMENT SYSTEM FOR A TERM OF THREE (3) YEARS BEGINNING JULY 1, 2021 AND ENDING JUNE 30, 2024 IN AN ESTIMATED AMOUNT BETWEEN \$1,258,424 AND \$1,295,481

Trustee Church requested additional information on the program and the fluctuation in the total amount. Sandra Aird, Director of Assessment, explained Illuminate Education provided the District with their assessment platform. The price was based on the number of students, so there was a possibility the cost could increase.

President Taylor opened the meeting to public comment.

Paulina Gersocvick remarked that the description of the program made it sound wonderful; however, she was concerned there was no evaluation on how the students performed after using the program.

It was moved by Trustee Caudill and seconded by Trustee Calvert that the Board of Trustees approves the Master Subscription Licenses and Services Agreement with Illuminate Education for the SchoolCity web-based student data assessment system for a term of three (3) years beginning July 1, 2021 and ending June 30, 2024 in an estimated amount between \$1,258,424 and \$1,295,481. The result of the vote was Unanimous: (Yea: Jacqueline Calvert, Andrew Caudill, Jeff Church, Ellen Minetto, Diane Nicolet, Angela Taylor, and Kurt Thigpen.) Final Resolution: Motion Carries.

2.15 APPROVAL OF MASTER SERVICES AGREEMENT WITH PROGRESSUS THERAPY, LLC FOR EDUCATION AND EDUCATION-RELATED SERVICES

FOR THE PLACEMENT OF UP TO 45 SOCIAL WORKERS IN SCHOOLS IN AN AMOUNT NOT TO EXCEED \$2,159,120

Trustee Church wondered why the District could not provide services in-house. Katherine Loudon, Counseling Coordinator, explained the District did not have an adequate number of social workers needed and had been working with temp agencies to place the additional staff needed.

President Taylor opened the meeting to public comment.

Darla Lee felt that if the District did not utilize screens so much when teaching students, they would not need as many social workers in the schools. She remarked that the District should focus on educating students in the basics and not on social policy. She stated if students were so "messed up" that there was a need for that many social workers in the schools, then the problem was with the schools and not the students.

Superintendent McNeill countered that students and families who needed the services of social workers should never be referred to as "messed up."

It was moved by Trustee Thigpen and seconded by Trustee Calvert that **the Board of Trustees approves the Master Services Agreement with Progressus Therapy, LLC for Education and Education-Related Services for the placement of up to 45 social workers in schools.** The result of the vote was Unanimous: (Yea: Jacqueline Calvert, Andrew Caudill, Jeff Church, Ellen Minetto, Diane Nicolet, Angela Taylor, and Kurt Thigpen.) Final Resolution: Motion Carries.

3. Legislative Items

3.01 PRESENTATION AND DISCUSSION ON LEGISLATION APPROVED DURING THE 2021 NEVADA LEGISLATIVE SESSION BASED ON THE APPROVED 2021 WASHOE COUNTRY SCHOOL DISTRICT LEGISLATIVE PLATFORM, TO INCLUDE SUPPORT OF OPTIMAL K-12 PUBLIC EDUCATION FUNDING, SUPPORT OF STUDENT AND STAFF MENTAL HEALTH AND SAFETY, PROMOTION OF ACADEMIC SUCCESS AND EQUITY FOR ALL STUDENTS, SUPPORT FOR EDUCATORS, AND PROVIDING A COMMUNITY CENTERED APPROACH TO DECISION-MAKING, AS WELL AS A UPDATE ON THE WASHOE COUNTY SCHOOL DISTRICT'S LEGISLATION ASSEMBLY BILL (AB) 57

Lindsay Anderson, Director of Government Affairs, provided a presentation on the 2021 Nevada Legislative Session and bills impacting the Washoe County School District. The District's bill, Assembly Bill (AB) 57, was approved and signed by Governor Sisolak.

Trustee Nicolet asked what the next steps in the process were since the Legislative Session was over and the upcoming redistricting process. Ms. Anderson indicated staff would work to review District policies and procedures against new legislation. The redistricting process would begin once the District received final population numbers from the federal government.

4. Budget Items

4.01 PRESENTATION AND DISCUSSION ON THE DISTRICT'S FISCAL YEAR 2021-22 AMENDED FINAL BUDGET FOR ALL DISTRICT FUNDS; UPDATE ON STATE FUNDING AND THE NEW PUPIL CENTERED FUNDING PLAN; CONSIDERATION OF POSSIBLE DIRECTION TO THE SUPERINTENDENT AND STAFF ON THE BUDGET; AND APPROVAL OF THE FISCAL YEAR 2021-22 AMENDED FINAL BUDGET

The Board of Trustees received a presentation on the amended final budget for Fiscal Year 2021-22. A comparison with prior fiscal years was provided and included information on the changes between the Board approved budget and the amended final budget, which was based on final legislation approved during the 2021 Nevada Legislative Session.

President Taylor opened the meeting to public comment.

D. Anderson requested the District provide a clearer breakdown of how all District Offices were funded, as well as their associated departments. She would also like the budgets for the schools to be more transparent.

George Lee thanked staff for the in-depth budget presentation. He mentioned the District should be cautious because of the rising inflation rate.

It was moved by Trustee Caudill and seconded by Trustee Minetto that **the Board of Trustees approves the Amended Final Budget for Fiscal Year 2021-22.** The result of the vote was Unanimous: (Yea: Jacqueline Calvert, Andrew Caudill, Jeff Church, Ellen Minetto, Diane Nicolet, Angela Taylor, and Kurt Thigpen.) Final Resolution: Motion Carries.

4.02 DISCUSSION, PRESENTATION, AND POSSIBLE ACTIONS REGARDING THE ADOPTION OF WASHOE COUNTY SCHOOL DISTRICT BOARD RESOLUTIONS 21-010, 21-011, 21-012, 21-013, 21-014, 21-015, 21-016, 21-017, AND 21-018, RESOLUTIONS TO AUGMENT THE FISCAL YEAR 2020-21 BUDGET, AND APPROVAL OF AUGMENTATION AND TRANSFERS FOR THE FISCAL YEAR 2020-21 BUDGET

The Office of Business and Finance reviewed the Board Resolutions associated with the final budget augmentation for the 2020-21 Fiscal Year.

President Taylor opened the meeting to public comment.

George Lee requested additional information on how the average mean attendance was counted in the schools.

It was moved by Trustee Caudill and seconded by Trustee Minetto that **adopts**Washoe County School District Board Resolutions 21-010, 21-011, 21-012,
21-013, 21-014, 21-015, 21-016, 21-017, and 21-018, Resolutions to
Augment the Fiscal Year 2020-21 Budget and approves budget transfers as
proposed. The result of the vote was Unanimous: (Yea: Jacqueline Calvert, Andrew
Caudill, Jeff Church, Ellen Minetto, Diane Nicolet, Angela Taylor, and Kurt Thigpen.)
Final Resolution: Motion Carries.

President Taylor recessed the meeting for 15 minutes.

5. Items for Presentation, Discussion, Information and/or Action

5.01 APPROVAL OF INCREASE TO OWNERS' CONTINGENCY IN THE AMOUNT OF \$1,133,000 FOR A TOTAL OF \$1,458,000 FOR THE GUARANTEED MAXIMUM PRICE (GMP) #4 OF THE NEW COMPREHENSIVE HIGH SCHOOL AT WILDCREEK, CMAR #C-61600A, FOR OFF SITE IMPROVEMENTS

Adam Searcy, Chief Facilities Management Officer, explained why the District was requesting an increase to the Owners' Contingency Account for the new Procter R. Hug High School located at Wildcreek.

President Taylor opened the meeting to public comment.

Darla Lee expressed frustration that the presentation referred to "unforeseen" issues. She noted she, and many other community members, had raised various concerns regarding the location of the proposed school, especially related to the safety of students going to and from school.

George Lee stated all the sidewalks in the surrounding area of the new Procter R. Hug High School should be widened.

Pablo Nava Duran remarked that he was hopeful the new athletic facilities would be similar to those at Damonte Ranch High School so they could be used as a regional facility, since Wildcreek was a more central location.

It was moved by Trustee Caudill and seconded by Trustee Taylor that **the Board of Trustees approves the increase to owners' contingency in the amount of \$1,133,000 for a total of \$1,458,000 for the guaranteed maximum price (GMP) #4 of the New Comprehensive High School at Wildcreek, CMAR C-61600A, for Off Site Improvements. The result of the vote was Unanimous:** (Yea: Jacqueline Calvert, Andrew Caudill, Jeff Church, Ellen Minetto, Diane Nicolet, Angela Taylor, and Kurt Thigpen.) Final Resolution: Motion Carries.

5.02 INFORMATION AND DISCUSSION TO UPDATE THE BOARD OF TRUSTEES ON MENTAL WELLNESS SUPPORTS INCLUDING THE USE OF, AND POTENTIAL USE OF, TELEHEALTH IN THE DELIVERY OF MEDICAL AND MENTAL HEALTH SUPPORTS FOR STUDENTS IN THE WASHOE COUNTY SCHOOL DISTRICT

The Board of Trustees received a presentation on mental wellness supports provided to students, including the use of telehealth in the District.

President Taylor recessed the meeting for 30 minutes. Trustee Jeff Church was not present when the meeting reconvened.

President Taylor pulled Agenda Item 5.03, Review of COVID-19 case counts, as there was no new information to be presented to the Trustees.

5.04 DISCUSSION AND POSSIBLE ACTION TO AFFIRM THE RECOMMENDATION OF THE GROUP INSURANCE COMMITTEE FOR A GROUP HEALTH INSURANCE RATE INCREASE OF 0% FOR PLAN YEAR 2022 AND A BENEFIT CHANGE TO MOVE PREVENTATIVE DENTAL SERVICES OUTSIDE OF THE CALENDAR YEAR MAXIMUM FOR A \$100,000 COST TO THE HEALTH INSURANCE PLAN

5.05 PRESENTATION, DISCUSSION, AND POSSIBLE ACTION TO PROVIDE DIRECTION TO THE SUPERINTENDENT ABOUT THE PROCESS TO ENGAGE STAKEHOLDERS ON POSSIBLE CHANGES TO SCHOOL START TIMES FOR THE 2022-23 SCHOOL YEAR

The Board of Trustees received a presentation on the process the District would use to engage stakeholders related to possible changes to school start times for the 2022-23 School Year. Six options would be presented to the community for review. It was important to note changes to school start times would have impacts to athletics and activities, before and after school care programs, individual school considerations, and family childcare or work options for older students.

President Taylor opened the meeting to public comment.

Pablo Nava Duran thanked the Board for the focus on student wellness as the reason for looking into changes to school start times. He believed any changes should occur at the start of the 2024-25 School Year.

Marika Moore urged the Trustees to conduct additional community outreach on the proposed Strategic Plan because she did not believe parents had enough time to review the document.

It was moved by Trustee Caudill and seconded by Trustee Minetto that **the Board of Trustees Board of Trustees approves the new Washoe County School District 2-Year Strategic Plan, "Response to Recovery."** The result of the vote was Unanimous: (Yea: Jacqueline Calvert, Andrew Caudill, Ellen Minetto, Diane Nicolet, Angela Taylor, and Kurt Thigpen.) Final Resolution: Motion Carries.

7. Closing Items

7.01 **PUBLIC COMMENT**

Valeria Fiannaca thanked Trustee Caudill for his service to the District and wished him luck in the future. She spoke against the teaching of critical race theory in the schools and believed history should be taught accurately.

Lexi Deeter was a recent graduate of Galena High School. She urged the Board to be more inclusive in the Sexuality, Health and Responsibility Education (SHARE) curriculum by providing more information on LGBTQ+ topics. She was frustrated that LGBTQ+ students were not provided the same information as straight, cisgender students.

James Benthin wondered why the Board was continuing to enforce mask mandates when other governments were not.

Stephanie Olcamp expressed frustration that the Board would conduct surveys to gather input from parents and the community, then ignore the results if they were not

the same as what the Board and Superintendent wanted to do. She was referring to the survey regarding the supplemental materials for the K-5 curriculum and that the parents overwhelmingly opposed it, so the Board created a task force instead.

D. Anderson stated she did not believe the initial public comment period was removed to make the meetings more efficient but was a punitive response to those who disagreed with President Taylor.

Shannon Coley read from an article in *This is Reno!* She expressed her agreement with the tone of the article and that the District wanted to make the community members who disagreed with them feel ignored.

Marika Moore remarked there were workshops being held throughout Washoe County on how parents could remove their children from the District because of the mask mandate and teaching of critical race theory. She urged parents to participate.

Pablo Nava Duran remarked that he could not understand the objection to the supplemental materials because it was important to learn the good and bad in history.



I appreciate how important it is to try to get through important agenda items in a timely manner. I appreciate that when there are several hours of public comment prior to getting to agenda items, you are exhausted by the time they get to the items that need your full attention! As I stated earlier, I am glad there are other ways to share my public comment in the record. I was unable to attend today and am using the email option to do this.

To my recollection, prior to COVID, all board meetings were held in this same venue with seating in the room and in overflow rooms. If people are outside of the meetings, they can listen into the live stream on YouTube. That is what I have done previously. Then I can sit in my car if I don't want to sit in an overflow room. When the meetings were held at other schools, there were issues then as well. Nothing you all choose to do will please all people. Sometimes I am the person who isn't pleased (Damonte Ranch High School is WAY far away from where I live), but I get there when I need to.

I deeply appreciate how long not just you, but district staff as well, must stay when meetings go into the wee hours of the morning. I appreciate everyone for doing that. It was disappointing to me to hear Trustee Church vehemently state he would not stay past 6:30. Sometimes, even without ANY public comment (at 3.01 or 7.01), meetings go longer than 6:30. When I voted for Trustee Caudill, my belief was that he would attend meetings until they ended, not until he got tired. I am also disappointed to hear Trustee Church say at every meeting that he is the new guy. He doesn't fully understand xyz. With all due respect, it has been more than 6 months since you were sworn in as a trustee. My hope would be that you would have a better understanding by this point.

Many public commenters have talked about the survey that was taken about the extra questions in Benchmark Advance. While 84% of those who responded to the survey disagreed with adding the questions, only 2% of adults responded if we look at just one parent/guardian per student responding (based on 62,000 students). If we look at all adults in Washoe County (357, 214 adults), it is .4% who are against the extra questions. Not even 1%.

I would have been overjoyed had the Benchmark Advanced additional questions been approved to be added at the last meeting. I am okay with there being a task force to discuss questions that can be added. What I know is that Critical Race Theory is not being taught at any school I've been in and what would have been taught in the 4 units with the one to four extra questions would not be that it is bad to be white or that if you are white you are racist. And for people who are upset about being told they have privilege (again, not something being taught in schools), I would like to state that privilege is not trying to say that you haven't had a challenging, hard, or difficult life. It doesn't mean you haven't worked hard to get where you are. It means the challenges have not been made more difficult due to the color of your skin, your gender, or your sexuality.

For the record, legal counsel is not an elected official and may not participate in board affairs as an elected trustee. When Rombardo initiates remarks when not requested by trustees, he is assuming powers that he does not have. He needs to sit at the dais silently, and on the extremities of the dais, and speak only when spoken to. Public commenters are not addressing him or asking for his response to any issues. Public comments are made to board trustees and the superintendent.

On 6/15, during public comment, I reminded Rombardo of his duties as legal counsel, and reminded him that his presence and ability to speak is only permissible when a trustee requests his legal opinion. At today's 6/22/2021 WCSD Board Meeting, Rombardo again interjected without any trustee requests.

A formal complaint regarding his professional duties will be made if Rombardo continues to interject when he is not legally entitled to speak.
