1. Opening Items

The regular meeting of the Board of Trustees was called to order at 2:00 p.m. in the Board Room of the Central Administration Building, located at 425 East Ninth Street in Reno, Nevada.

President Taylor opened the meeting to public comment.

President Taylor opened the floor to nominations.

Trustee Minetto nominated Dr. Diane Nicolet.

Trustee Calvert nominated Beth Smith.

Trustee Rodriguez nominated Jeff Church.

No other nominations were received.

It was moved by Trustee Minetto and seconded by Trustee Calvert that **the Board of Trustees selects Diane Nicolet to serve as Clerk of the Board of Trustees through the remainder of 2021.** The result of the vote was 6-1: (Yea: Jacqueline Calvert, Ellen Minetto, Diane Nicolet, Joe Rodriguez, Beth Smith, and Angela Taylor. Nay: Jeff Church.) Final Resolution: Motion Carries.

Pursuant to Nevada Revised Statute (NRS) 386.310, the salary of the clerk was no different than that of any other member of the Washoe County School District Board of Trustees and amounted to \$750 per month.

President Taylor recessed the meeting for 15 minutes to allow for reseating of the Board based on the results of Board of Trustees Officer elections.

3. Consent Agenda Items

Trustee Church requested Consent Agenda Items 3.03, Approval of renewal #2 of request for proposal (RFP) #18-002, Investment Management Services, to Buckhead Capital Management, LLC with estimated annual fees of \$369,000 for a term of one (1) year beginning August 15, 2021 and ending August 14, 2022, and 3.04, Discussion and Action to Approve the Fiscal Year 2021-22 Class Size Reduction Plan and authorization to file the plan with the State Superintendent of Public Instruction, be pulled for additional discussion.

Trustee Smith requested Consent Agenda Item 3.10, Approval of the appointment of the following members to the Zoning Advisory Committee for 2-year terms, effective immediately and ending June 30, 2023: Brooke Snyder, Educational Support Staff, and Tyler Rogers, Trustee Zone D Representative, be pulled for additional discussion.

President Taylor opened the meeting to public comment.

Janet Butcher provided comments related to Consent Agenda Items 3.02 and 3.05. She wondered if the District had received any other bids related to the cost of the new pump station or if they just accepted the information from Truckee Meadows Water Authority for item 3.02. In regard to item 3.05, she believed the District would be seeing additional children requiring special education services because of the impacts of the mask mandates and delayed speech.

Valerie Fiannaca spoke in reference to item 3.07. She wondered how much taxpayer money would be used to finance a special sick leave bank or if the teachers would be required to donate any leave they had to this bank.

John Eppolito requested clarification on item 3.09 and what "prevention intervention specialist" actually did in the schools.

It was moved by Trustee Minetto and seconded by Trustee Rodriguez that **the Board of Trustees approves Consent Agenda Items 3.02 and 3.05 through 3.09**. The result of the vote was Unanimous: (Yea: Jacqueline Calvert, Jeff Church, Ellen Minetto, Diane Nicolet, Joe Rodriguez, Beth Smith, and Angela Taylor.) Final Resolution: Motion Carries.

- 3.02 The Board of Trustees approved the Agreement for the Delivery of Water and the Non-Potable Water Service (NPS) Rate Schedule with Truckee Meadows Water Authority and authorized the expenditure of \$158,375 to rebuild the Truckee River pump station.
- 3.05 The Board of Trustees approved the Local Plan for Fiscal Year 2022 pertaining to the assurances required by Part B of the federal Individuals with Disabilities Education Act (IDEA).

- 3.06 The Board of Trustees awarded Bid #21-115-B-06-AA, Replacement of Lock Hardware at Bernice Mathews Elementary School, to Gary Romero, Inc. for \$122,150.
- 3.07 The Board of Trustees approved the memorandum of agreement between the Washoe County School District and the Washoe Education Association for the terms of the C-19 Sick Leave Bank.
- 3.08 The Board of Trustees approved the Memorandum of Understanding between the Washoe County School District and the Washoe School Principals' Association providing for approval of a fixed, range 41 placement for the position of Principal at Natchez Elementary School.
- 3.09 The Board of Trustees approved the Memorandum of Understanding between the Washoe County School District and the Washoe Education Support Professionals providing for placement options for displaced Prevention Intervention Specialists.
- 3.03 **APPROVAL OF RENEWAL #2 OF REQUEST FOR PROPOSAL (RFP) #18-002, INVESTMENT MANAGEMENT SERVICES, TO BUCKHEAD CAPITAL MANAGEMENT, LLC (BUCKHEAD) WITH ESTIMATED ANNUAL FEES OF \$369,000 FOR A TERM OF ONE (1) YEAR BEGINNING AUGUST 15, 2021 AND ENDING AUGUST 14, 2022**

Trustee Church requested clarification on the cost and if the District would be paying more if the management company was responsible for more money. Mark Mathers, Chief Financial Officer, explained how the fee schedule was determined. The fees were based on a sliding scale and based on the amount of assets the company managed; thus, if the assets fell, the fees were reduced and if the assets increased, the fees were increased. The use of an investment management company had seen a positive return on investment for the District.

Trustee Church wondered if the District went out to bid for the services. Andrea Sullivan, Director of Procurement and Contracts, mentioned the agenda item was the final renewal allowed under the original contract. The District could consider issuing another Request for Proposal next year.

President Taylor opened the meeting to public comment.

Janet Butcher questioned why the District selected an investment management company from Georgia and not one from Washoe County. She believed there were plenty of local firms who could handle institutional investments.

It was moved by Trustee Nicolet and seconded by Trustee Minetto that **the Board of Trustees approves Renewal #2 of Request for Proposal (RFP) #18-002, Investment Management Services, to Buckhead Capital Management, LLC with estimated annual fees of \$369,000.00 for a term of one (1) year beginning August 15, 2021 and ending August 14, 2022.** The result of the vote was Unanimous: (Yea: Jacqueline Calvert, Jeff Church, Ellen Minetto, Diane Nicolet, Joe Rodriguez, Beth Smith, and Angela Taylor.) Final Resolution: Motion Carries.

3.04 DISCUSSION AND ACTION TO APPROVE THE FISCAL YEAR 2021-22 CLASS SIZE REDUCTION PLAN AND AUTHORIZATION TO FILE THE PLAN WITH THE STATE SUPERINTENDENT OF PUBLIC INSTRUCTION

Trustee Church requested additional information on the Class Size Reduction Plan. Superintendent McNeill indicated the item was fairly standard to the Consent Agenda and was a report school districts were required to provide to the state under Nevada Revised Statutes. The report was related to class sizes for grades K-3. No determination on allocations would be done until the final count day numbers were provided.

It was moved by Trustee Minetto and seconded by Trustee Calvert that **the Board of Trustees approves the Fiscal Year 2021-22 Class Size Reduction Plan to be filed with the State Superintendent of Public Instruction.** The result of the vote was Unanimous: (Yea: Jacqueline Calvert, Jeff Church, Ellen Minetto, Diane Nicolet, Joe Rodriguez, Beth Smith, and Angela Taylor.) Final Resolution: Motion Carries.

3.10 APPROVAL OF THE APPOINTMENT OF THE FOLLOWING MEMBERS TO THE ZONING ADVISORY COMMITTEE FOR 2-YEAR TERMS, EFFECTIVE IMMEDIATELY AND ENDING JUNE 30, 2023: BROOKE SNYDER, EDUCATIONAL SUPPORT STAFF, AND TYLER ROGERS, TRUSTEE ZONE D REPRESENTATIVE

Trustee Smith read a statement from Tyler Rogers on why he was interested in serving on the Zoning Advisory Committee. She indicated she had met with both Brooke Snyder and Tyler Rogers regarding their possible service on the Committee.

It was moved by Trustee Smith and seconded by Trustee Rodriguez that **the Board of Trustees approves the appointments of the following members to the Zoning Advisory Committee for 2-year terms, effective immediately and ending June 30, 2023: Brooke Snyder, Educational Support Staff, and Tyler Rogers, Trustee Zone D Representative.** The result of the vote was Unanimous: (Yea: Jacqueline Calvert, Jeff Church, Ellen Minetto, Diane Nicolet, Joe Rodriguez, Beth Smith, and Angela Taylor.) Final Resolution: Motion Carries.

4. Items for Presentation, Discussion, Information and/or Action**4.03 PRESENTATION REGARDING THE SUPERINTENDENT'S TASK FORCE FOR SUPPLEMENTARY MATERIALS INCLUDING THE CURRENT APPLICATION PROCESS AND OUTREACH TO FAMILIES AND COMMUNITY**

The Board of Trustees received an update on the status of the Superintendent's Task Force for Supplementary Materials. The Task Force was created based on direction from the Board on June 8, 2021. The composition of the Task Force was reviewed and included the following: five elementary school parents/guardians from each of the regular Trustee electoral districts, four community members, two elementary school teachers, one middle school teacher, one high school teacher, one elementary school principal, two central services representatives, and two students from the Superintendent's Student Advisory Council. The application process for parent and the community member positions was explained and the communications plan related to outreach efforts presented.

Dr. Kristen McNeill, Superintendent, indicated the only meeting she planned on attending for the Task Force was the first meeting so she could welcome and thank the volunteers for their interest in serving the District. Future updates from the Task Force would include information on the work that had been occurring and the chair of the Task Force would be invited to participate in the presentations.

Trustee Church asked if the meetings of the Task Force would be public meetings and the community allowed the opportunity to provide their comments. Superintendent McNeill stated the meetings would not be public meetings. The public would be allowed the opportunity to provide their comments during meetings of the Board of Trustees. The meeting agendas and notes would be posted on the District's website to allow the Board and community the ability to review what was discussed.

Trustee Church expressed concern over the scope of work of the Task Force. Superintendent McNeill noted the Board had previously approved the Equity and Diversity Plan and that the K-5 English Language Arts (ELA) supplemental curriculum was part of that plan. The initial focus of the Task Force would be to develop that supplemental curriculum based on the Board's action from June 8, 2021.

Trustee Church wondered what the teachers would currently be using in the classroom since there were no materials. Debra Biersdorff, Deputy Superintendent, explained the District was in the third year of the new Benchmark K-5 ELA curriculum. The teachers were following state content standards and had expressed interest in having additional

supplemental materials to enhance what they were already using for their lessons. All state standards were posted on the Nevada Department of Education's website.

Trustee Church asked if the Board and community were able to review the books, curriculum, and lesson plans being used. Ms. Biersdorff stated the information was available through the District's scope and sequence guide provided to teachers so they knew what to teach to ensure the standards were met. The lesson plans were developed by the individual teachers to allow them to determine the needs of the students in their classes. Superintendent McNeill provided additional information on what was included in a lesson plan.

Trustee Church claimed he was getting emails and phone calls from constituents that alleged the District was already teaching topics related to white privilege, oppression, suspension of voting rights, and other divisive topics. He believed the Trustees had a right to know if that was occurring by reviewing the lesson plans. Superintendent McNeill recommended, if a parent was concerned about the information and materials being used in a classroom, that the parent contact the teacher and ask to see the information. One of the reasons she had previously recommended the supplemental materials from Benchmark not be approved was because there were concerns over the materials and language used. It was also important to distinguish between the subjects being taught and the content of the lesson.

President Taylor appreciated that parents were able to contact the teachers and ask to see what was being taught in the classroom. Ms. Biersdorff highlighted that the teachers would be excited to hear from parents and have them take an active interest in the lessons.

Trustee Church remarked that he was receiving emails and wanted to be able to respond accurately. He felt what he was hearing was that if a social studies teacher wanted to teach white privilege, systemic racism, systemic oppression, or suppression of voter rights, that those lessons could and were occurring in the District. Ms. Biersdorff reiterated any lesson would have to be tied to Nevada Academic Content Standards for the specific subject area and the materials used part of the approved list of supplementary materials.

Trustee Smith requested clarification on the ages of the students who would be on the Task Force and if parental consent would be required. Ms. Biersdorff indicated the students were high school age and parental consent would be obtained.

Trustee Smith asked if the names of the members of the Task Force would be public. Ms. Biersdorff mentioned the intent was that the names would be posted on the website. Superintendent McNeill added that group norms would be established at the

first meeting so members of the Task Force were able to feel safe in having difficult conversations.

Trustee Nicolet suggested the individual Trustees, when they conducted school visits, speak with the principals and teachers about what they were teaching, sit in on lessons, and even ask to see lesson plans while they were in the classroom. In her experience, the teachers were very excited to share what they were teaching.

Trustee Church wondered how the Equity and Diversity Task Force would interact with the new Task Force. Superintendent McNeill remarked that there would only be interaction between the two if a member of the Equity and Diversity Task Force applied and was accepted to be a member of the Superintendent's Task Force.

Trustee Church asked if a grandparent would be able to serve in a parent/guardian position. Superintendent McNeill noted the request was for a parent/guardian because they would be closest to the students.

Trustee Minetto reminded everyone part of the motion from June 8 did include that the Task Force should not consider materials that were divisive or political in nature.

President Taylor added that the Task Force would provide recommendations that would need to ultimately be approved by the Board of Trustees at a public meeting.

President Taylor opened the meeting to public comment.

Laurie Agnew believed it would be important to remember the "social justice and Critical Race Theory" standards and materials were inconsistent with recorded American history and that students should be taught about merit, morality, and living together. She had heard from students that they were told by teachers they would be taught Black Lives Matter during their history class and nothing about the United States Constitution or the Civil War.

Bev Stenehjem mentioned the feedback from the survey on the supplemental materials showed 84% were against the Critical Race Theory social justice curriculum and the District was continuing to move forward with it. She felt any Task Force had to be balanced and not include divisive and political information, but that there was a difference of opinion of what was divisive and political. She believed Black Lives Matter was a Marxist organization and that the District should have a class on the wonderfulness of America.

Kasey Thelander felt the application process was designed to allow those selecting the members of the Task Force to select people who believed in Critical Race Theory and

social justice. He requested the first question on the application be removed because it was biased.

Shannon Coley provided the Trustees with a copy of the state standards and urged them all to review them before voting to approve the formation of any task force. She believed the schools already followed the state social justice standards under social studies and more did not need to be added to the ELA curriculum. She mentioned the District's standards were adopted in 2018 and the Board did not need to approve anything more.

Victoria Meyer spoke against Critical Race Theory being taught in the schools because she believed it was built on teaching racism to students and telling them to be anti-American. She claimed her grandson was told by his teacher not to tell his parents what they were being taught.

John Eppolito agreed with the prior comments. He urged the Board to focus on teaching students the basics, such as math and how to communicate, and spend less time on divisive issues.

Mindy Lilquist wondered how the District would audit the Task Force to ensure it was unbiased, serving the stated purpose, and that it was useful. She expressed frustration that the public comment process did not allow for a back and forth dialogue between the Board and the community because she felt that would help to dispel many of the concerns raised by the public.

4.02 PRESENTATION AND INTRODUCTION OF NEW PRINCIPALS IN THE WASHOE COUNTY SCHOOL DISTRICT

The Office of School Leadership presented new the principals for both the 2020-21 School Year and 2021-22 School Year.

4.04 DISCUSSION AND POSSIBLE ACTION TO REVIEW AND PROVIDE DIRECTION ON CURRENT COVID-19 MITIGATION MEASURES IN EFFECT FOR THE 2021-22 SCHOOL YEAR INCLUDING FACILITIES MANAGEMENT, TRANSPORTATION, STAFF AND STUDENT EXCLUSIONS, AND FACE COVERINGS FOR DISTRICT FACILITIES AND SCHOOL SITES BASED ON CURRENT FEDERAL, STATE, AND LOCAL GUIDANCE

The Board of Trustees received a presentation on the impacts on the District from Emergency Directives 047 and 048, including current enrollment numbers for North Star Online School, mitigation measures, and guidance regarding athletics. Emergency Directive 048 provided additional clarification to Directive 047 for school districts, including the requirement of face coverings in school districts in counties with a population of 100,000 or greater (currently Clark County and Washoe County) while inside school buildings unless granted an exception. All school staff were required to wear face coverings regardless of vaccination status and parents, vendors, volunteers, visitors, and guests who were unable or unwilling to wear face coverings should not be

allowed on school buses or inside school buildings. Additional information on the requirements for activities and athletics was reviewed, which included the requirement of weekly testing for athletes, coaches, volunteers, and staff who were unvaccinated for those participating in high contact sports. The Nevada Interscholastic Activities Association (NIAA) was currently in the process of developing their procedures related to the Directive. The recommendation was to direct the Superintendent to adhere to Emergency Directive 048.

Trustee Smith requested clarification on the definition of a close contact. Dr. Paul LaMarca, Chief Strategies Officer, stated a close contact was defined as being within 6 feet of someone who was positive of the virus for a total of 15 minutes per day. Face masks did not change that as the masks were designed to prevent the wearer from spreading the virus.

Trustee Minetto wondered if the current COVID strain was one of the variants, if breakthrough cases were occurring, what the tests were specific for, and if there were concerns related to health privacy and parental permission regarding the testing of athletes. Jennifer Crane, Director of Student Health Services, indicated any positive tests were sent to the state lab for testing and they would determine which strain of the virus it was. Washoe County was seeing an increase in breakthrough cases and those who received the vaccine could continue to spread the virus. The tests used by the Washoe County Health District were specific to COVID, though some early tests approved for emergency usage did have difficulty distinguishing between the COVID virus and the flu virus. Dr. LaMarca noted the District was in the process of providing information to parents on the current guidance related to athletics and activities, but in general, the parents were aware of any requirements if they wanted their children to participate in an activity or sport. Neil Rombardo, Chief General Counsel, added school districts were entitled to view vaccination status of students under federal law.

Trustee Nicolet indicated there was information being spread in the community that COVID did not affect children and she wondered if that was true. Ms. Crane stated that was not true and the number of cases in children were increasing.

Trustee Nicolet asked if there were any side effects to the weekly testing. Ms. Crane explained a cotton swab was used to gather a sample from inside the nose. Nothing was added to the swab prior to the test and the solution to run the sample was administered after.

Trustee Nicolet wondered if the District would conduct contact tracing for those in attendance at a Board meeting if someone were to test positive. Ms. Crane remarked that ideally the District would try to determine who the individuals were, where they were sitting, and how long they were sitting in a specific location; however, the reality

was people was constantly getting up and moving in and out of the room so it would be very difficult.

Trustee Rodriguez requested clarification on exemptions for masks versus face shields and if the District was continuing to require social distancing in the schools. Dr. LaMarca acknowledged the District was continuing to urge social distancing whenever possible. The Emergency Directives and guidance did allow students to remove masks while outside and exerting themselves. Due to the number of directives issued, there was some confusion on who was required to wear masks and what was required for an exemption. It was important to note those students and staff members who had an exemption were asked to wear face shields.

Trustee Church asked if the school nurse had the ability to review a student's medical history to make a determination on if a student could use a face shield. Ms. Crane stated the District had requested clarification from the state and told, no a school nurse was not able to make that determination.

Trustee Church wondered why Directive 048 only applied to Clark and Washoe Counties. He expressed frustration because it appeared the two counties were being treated in a disparate manner, especially since their case numbers, per capita, were lower than other counties. Mr. Rombardo noted the Directive applied to all counties in Nevada, but there were specific sections that only applied to Clark and Washoe because of population. Nevada law recognized the 100,000-population line in numerous statutes and Clark and Washoe were held to different requirements because of that in other areas as well, such as Open Meeting Law. If there had been no reason for the reason in the difference, then there could be a legal concern; however, the logic behind the decision was that, because of their size, a rapid outbreak could cause greater challenges in Clark and Washoe Counties than in the smaller counties.

Trustee Church believed the science did not support the use of masks and he did not support masks. He would also like to see the Board hold the meetings in a larger venue because the current room did not allow for proper social distancing. The emails from the community wanted the District to stand up to the Governor regarding masks, even with the Directive, because the masks were ridiculous. He wondered, since the case numbers were increasing, if the District should shut the schools down for a couple of weeks until the numbers in the community started to decrease.

Trustee Minetto asked why the District was only testing those students who were unvaccinated, especially if those who were vaccinated could still catch and spread the virus. Dr. LaMarca indicated the requirement from the state was that school districts had to test unvaccinated student athletes. Staff was concerned about the potential for bullying or other impacts on students who were not vaccinated either because of their own choice or the choice of their parents.

President Taylor opened the meeting to public comment.

Dr. Troy Ross claimed to be one of the few preventative medicine providers in Northern Nevada and that he had experience in endemic planning, infection control, vaccine program development, and public health policy. In his opinion, the current pandemic mitigation efforts and policies were doing more harm to the children than helping them. He provided data points that he felt showed that the use of masks were not help contain virus spread.

Tessa Drescher was a student from Incline Village. She spoke against the mask requirements in Incline because the community was removed from the majority of the population in Washoe County. She felt there were numerous carcinogens in the materials used to produce the masks that would cause harm to students and used masks were polluting the environment. She encouraged the Board to reconsider the mask mandate for all students.

Dr. Maureen Lamerden was a resident of Incline Village and also believed the schools there should be exempted from the mask mandate. She noted there were less than a total of 1,000 students at the three schools in Incline Village, which was less than the number of students at other schools in the smaller counties. She provided different examples of how Incline students were treated the same as students in the Truckee Meadows and that was not necessary. She spoke of her experience with COVID, the vaccines, and her patients as a general practitioner.

Spencer Armstrong was a student in the District and had asthma. He mentioned he was kicked out of school because he refused to wear his mask over his nose. He claimed he was unable to breathe because of the mask and the smoke conditions. He believed he was being discriminated against because of his medical condition. He remarked that COVID could be contracted through the eyes so masks did nothing.

Janet Butcher mentioned the District would be psychologically oppressing the students who were unvaccinated because they were the only ones who would be tested. She agreed with some of the prior comments that the mask mandate should only apply to the heavily populated areas of Washoe County. She felt there was a lot of misinformation being provided by the Governor and staff because they wanted to control the population.

Kasey Thelander felt the mask mandates and social distancing requirements were emotionally impacting the children. He believed the COVID tests were actually testing for the influenza virus and could not distinguish between flu and COVID. He expressed frustration over his elementary school child's principal because he believed the principal was playing mind games with the students.

Kurt Baker agreed with the prior comments that the masks did not work. He noted the language on the mask boxes even stated they would not protect against bacteria or viruses. He was not sure where the District was receiving the scientific information they were basing their decisions on, but he did not believe they were following any actual science. He mentioned he had pulled his children out of the District because he did not want them wearing masks all day and would urge other parents to do the same.

John Eppolito agreed with the comments made by the other speakers from Incline Village. He urged the Board to conduct their meetings in a larger venue because they were contributing to the increase in COVID cases.

James Benthin demanded any documentation on him held by the Washoe County School District and Superintendent McNeill that would allow them to issue health mandates on him. The Board of Trustees was not the Health District but in charge of education.

Shannon Coley spoke in support of the comments from Dr. Troy Ross and urged the Board to review his information on the pandemic.

Hope Backman claimed the masks did nothing but collect bacteria and then force her child to breathe the bacteria. She did not believe it was appropriate for the District to require the "vaccine" and that the vaccine was actually gene therapy. She urged the Board and Superintendent to resign and called for a citizen's arrest of the Governor and President for lying and hiding hydroxychloroquine and other preventative treatments.

Bev Stenehjem wondered why the District was requiring the use of masks if the virus was 99.7% survivable. She did not believe it was appropriate for the District to force students to wear masks and that the vaccines were only experimental. She claimed the District was violating the Nuremberg Code by forcing them to get the vaccine. She asked why the District was not talking about the natural antibodies someone had if they had COVID. She believed the District was acting like China and would require people to show their vaccine cards before going anywhere.

Victoria Meyer urged the Board to listen to the members of the public who had provided comments because the people were giving them good information. She believed the Board had the authority to defy the Governor, especially since he had overstepped his bounds. She noted the community had previously provided information to the Board on studies that showed masks did not work but the Board had not showed the community any studies that showed masks did work.

Trustee Church indicated he would be interested in having a discussion on providing direction to the Superintendent to ask the Governor to rescind Emergency Directive 048 because he believed it treated Clark and Washoe Counties differently. He would like the individual school districts to have the ability to make decisions related to masks on their own.

President Taylor reminded the Board and community a request had been sent to the Governor prior to the issuance of Emergency Directives 047 and 048 to allow for local control; however, the Governor decided that was not something he was interested in entertaining at the present time.

Trustee Church mentioned he would then be interested in having a discussion on closing the schools if the case counts were as bad as being reported because the masks were ineffective.

Trustee Minetto opined that it was critical for the District to keep schools open as much as possible for the physical and mental welfare of the students.

President Taylor noted there were additional mitigation measures in place in the schools, such as increased handwashing and HVAC, so the masks were not the only thing in place to mitigate transmission. She concurred with Trustee Minetto that it was critical to keep schools open as much as possible.

Superintendent McNeill explained the District had dedicated numerous resources and federal dollars to not only open schools, but to keep them open, including opening

vaccination clinics. As the Superintendent, she could not recommend or support the closing of the schools.

Student Representative Gomez expressed that she would like to see the schools remain open. She noted that during the 2020-21 School Year, the middle and high school students were having a lot of challenges because they were not in-person every day. She believed, even with the masks, students would be able to socialize with their peers more and improve their mental health.

Dr. LaMarca clarified that the action taken by the Board during the 2020-21 School Year to move secondary schools to full distance learning after the Thanksgiving Break was related to staffing concerns and not the high case counts.

Trustee Nicolet asked what the major problems would be in the schools if mask wearing was a choice. Dr. LaMarca indicated that prior to the issuance of Emergency Directive 048, the District had recommended to the Board that mask wearing should be a choice. Superintendent McNeill added there could be management issues if mask choice was tied to vaccination status because then teachers would need to determine who was vaccinated.

Trustee Rodriguez remarked that he understood the frustrations of the community because no one liked wearing the masks; however, his understanding was the Board and District could be held liable if they did not follow the Governor's directives. Mr. Rombardo mentioned the issues would probably not come from the state, but there could be concerns related to negligence and standard of care. If the District did not follow the directives and a child or employee were to get sick and able to link it to the schools, the District could be held liable. He added that the District did not have the authority to act outside of what authority had been provided to them because Nevada was a Dillon's Law State, not a Home Rule State.

Trustee Church reiterated that based on the case numbers, the District should consider closing the schools.

It was moved by President Taylor and seconded by Trustee Nicolet that **the Board of Trustees directs the Superintendent to adhere to Emergency Directive 048, and staff to continue to be encouraged to find innovative ways to allow mask breaks throughout the day for all students.** The result of the vote was 5-2: (Yea: Jacqueline Calvert, Diane Nicolet, Joe Rodriguez, Beth Smith, and Angela Taylor. Nay: Jeff Church and Ellen Minetto.) Final Resolution: Motion Carries.

5. Reports

5.01 STUDENT REPRESENTATIVE REPORT

Student Representative Victoria Gomez reported on activities, meetings, and events of the Superintendent's Student Advisory Council.

5.02 SUPERINTENDENT'S REPORT

Superintendent Kristen McNeill reported on her activities including meetings with staff, community leaders and the media.

6. Closing Items

6.01 PUBLIC COMMENT

James Benthin mentioned the COVID vaccines were authorized for emergency use only and only if there were no other treatments; however, he claimed there were numerous positive treatments available to the public that would allow for herd immunity.

Valerie Fiannaca spoke about an article in *This is Reno* by former Trustee Kurt Thigpen. She disagreed with much of the information in the article because the parents, grandparents, and community members had the right to express their opinions, even if they were different than what others believed. She stated she had not heard anyone threaten a Trustee during a meeting and expressed frustration that many who disagreed were considered threatening and dangerous.

Katherine Snedeger claimed the Governor's directives only applied to the internal workings of the government and did not apply to the public at large. She believed no government entity had the right or authority to tell anyone what to do about their health. She claimed the Board and District could also be liable if they forced someone to wear a mask and that person got sick because of it.

President Taylor recessed the meeting for 6 minutes.

Spencer Armstrong indicated he attended the first day of school at Robert McQueen High School, but had unenrolled himself because his United States History teacher had told the class they would not be learning about the American Revolution, Civil War, or Constitution but that she would instead be teaching only about Black Lives Matter and LGBTQ+. He claimed the teacher encouraged the students to lie to their parents so they could teach them evil and brainwash them.

Bev Stenehjem spoke in support of Mr. Armstrong and believed many parents would be removing their children from the schools because the parents did not like the politics of the Board. She expressed frustration that the Trustees had not listened to any of the

members of the public with regard to Trustee Church serving as a part of Board Leadership.

Victoria Meyer remarked that the people paid the Trustees to do their jobs and the District's attorney to defend the Trustees and the District. She was interested in the Board and District acting against the Governor's directives and the attorney defending them.

Cindy Sassenrath wondered how the students were selected to serve on the Task Force when the application period was still open. She believed that the Task Force was a way to justify the implementation of Critical Race Theory in the classroom. She spoke against the Board officer election process and the wearing of masks.

Janet Butcher asked what the impacts of the "vaccine" would be on the children in the years to come. She claimed there had been deadlier pandemics in the past and people survived without vaccines or masks. She could not understand why the District and Board continued to make everything so complicated.

Jonathan Meeks was the parent of multiple students in the District and claimed one of his sons was being taught that he was the cause of all the bad in the world because of his "white privilege." He stated he would be pulling his children out of the schools and that others should do the same because of what they were being taught.

Dr. Maureen Lamerden commented that kids and adults were still getting COVID, even with the vaccine, so she believed the District was discriminating against her child and others who did not receive an experimental vaccine. She urged the Board to work with Joey Gilbert to remove the mask requirements.

Dr. Troy Ross stated his goal was to ensure kids were healthy and safe, which should be the goal of the Trustees and not to keep everyone happy. He believed masks restricted children's ability to interact with each other and a two-tiered system would be created. He did not think any school district would be held to a standard of care requirement because it was a medical term.

John Eppolito urged the Board to listen to the students who spoke during public comment, because there were a lot of issues in the schools. He did not believe the Board, especially President Taylor, supported the public attending meetings to provide comments since they forced parents to wait over 6 hours before providing comment.

Shannon Coley urged the Board to listen to what students and parents were saying because there was serious mistrust in the Board with what was occurring in the schools. She felt the community was not being listened to, provided any feedback, or were lied

to when someone did comment. She hoped the Trustees would hold town halls that would allow dialogue.

Thank you for your email regarding COVID-19 and the upcoming school year. As you may know, updated guidelines were released by the Governor's office this week, requiring specific actions by the Board of Trustees.

According to Tuesday's update from the Centers for Disease Control (CDC), Washoe County is currently deemed as having substantial or high transmission. The CDC recommends that everyone, including fully vaccinated individuals, wear a mask in public indoor settings in counties with substantial or high transmission.

To allow communities and businesses in counties with substantial or high transmission time to implement the new requirements, Governor Sisolak issued Emergency Directive 047, which allows a three-day grace period to implement the new State mask mandate, meaning that Tuesday's updates from the CDC will formally go into effect on Friday, July 30, 2021.

We are seeking further clarifying information on Directive 047 as it relates to school aged children, prior to its implementation. At that time, we will release any additional guidance that may impact our actions moving forward.

I very much appreciate the studies and information that you and other members of the community have shared on the varying views pertaining to the COVID-19. I recognize that there is not consensus. Please be assured that the Board of Trustees takes this issue very seriously and recognize that there is no decision we can make that will meet the desires of everyone. We will continue to review the COVID protocols and actions bi-monthly, as a regular agenda item during our Board meetings in order to be responsive to changes in State directives and community conditions.

Thank you for sharing your thoughts and concerns. I appreciate hearing from you.

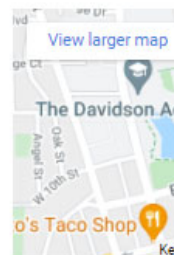

Good evening,

I'd like to implore you, the Nevada Department of Education, and the Governor to revise your stance on mask requirements for children in school. I have messaged the Governor through the online system and understand you can only make requirements more restrictive than what he directs and not less. I'm asking that in your meetings and reports to the Governor and his team that you advocate for unmasking students and vaccinated teachers using some of my points below.

I do not think you understand the negative impacts of forced mask wearing for children. You say the science says or you're following the directives of the Governor. However, in a recently article published by the Wall Street Journal they found only 1 retrospective study on the question (mandating mask wearing for children), and its results were inconclusive.

Authorities in many places took the cue to impose mandates in schools and elsewhere, on the theory that masks can't do any harm. As a mother and educator I disagree. Masks do harm.

Ireland's Department of Health announced that it won't require masks in schools because they "may exacerbate anxiety or breathing difficulties for some students."

According to the Wall Street Journal article, "Some children compensate for such difficulties by breathing through their mouths. Chronic and prolonged mouth breathing can alter facial development. It is [well-documented](#) that children who mouth-breathe because adenoids block their nasal airways can develop a mouth deformity and elongated face."

In addition to this there have been many other difficulties children and adolescents face because of mask mandates.

- "People with myopia can have difficulty seeing because the mask fogs their glasses." *I had a student last year who has glasses and struggled everyday with his glasses fogging to the point he would ask to remove his glasses instead of his mask.*
- "Masks can cause severe acne and other skin problems." *I didn't have students with this problem, but can you imagine the embarrassment older children and some adults may face because of this?*
- "By increasing airway resistance during exhalation, masks can lead to increased levels of carbon dioxide in the blood." *This is called hypercapnia. Hypercapnia can cause headaches, dizziness, fatigue, and serious complications such as seizures and loss of consciousness. Is this something we are willing to have happen to our children?*
- Masks can be [vectors for pathogens](#) if they become moist or are used for too long.
- The discomfort of a mask distracts some children from learning. *While my kindergarten students and own children can wear masks better than most adults. They are constantly touching or chewing on them. Often times they will chew on them to the point of needing to get a new one from their backpack, office, or clinic. Not only is this not hygienic but reduces the time they are learning and is a huge distraction.*
- "Facial expressions are integral to human connection, particularly for young children, who are only learning how to signal fear, confusion and happiness."
- "Covering a child's face mutes nonverbal forms of communication and can result in robotic and emotionless interactions, anxiety and depression. Seeing people speak is a building block of phonetic development."

I have stated in my last 2 emails the following: *Mask requirements restrict peer interaction and limit language development. Having a mask covering a teacher's face limits a child's ability to see how certain sounds and words are formed. It limits their ability to hear clear directions. Having a mask cover children's faces limits their willingness to engage with each other and the teacher. Having a mask covering a teacher's and children's faces doesn't allow for children to read facial expressions. All of this delays language development and decreases positive peer interaction and relationships. Limiting interaction by enforcing social distancing, not allowing the use of shared materials, and mask wearing is detrimental to their growth, relationships, and education.*

The article goes on to state, "The adverse developmental effects of requiring masks for a few weeks are probably minor." **However**, we have been forcing children to wear them for much longer than a few weeks in schools. **35 weeks at least.** Any child who wants to wear a mask should be free to do so. If families don't want their child wearing masks, please, give them the choice.

Why are we requiring masks for children when the science on the topic is inconclusive?? Why are parents having their choices decided for them? Please make the necessary changes and remove the mask mandates for children and vaccinated adults. Let us assess and take our own risks.

Subject: Weekly Covid Testing

I am a concerned parent of 3 children in the Washoe County School District. As a matter of choice none of my children have received the covid 19 shot. The sciences I have studied by independent scientist and the peer reviewed articles I have read indicate to me that this Covid shot is not necessary for me and my family. We still have the choice to not get it.

I am also aware of the Governors directive that student athletes must be tested weekly if not vaccinated.
