



## To Whom It May Concern:

My son is a student athlete who plays basketball at Reed High School in Sparks, Nevada. Unfortunately, basketball has been considered a high-risk sport and is therefore prohibited under Directive 034. I am aware the NIAA sent correspondence to the governor's office on December 22, asking the provision for basketball and wrestling be revised to allow either or both. The Governor's office responded, "Upon review of the proposed plans and feedback from state and county public health officials, the Governor will not be revising the directive as requested at this time."

I am sending this email to ask the Governor's office to reverse the provision for high-risk sports, in particular basketball regardless of the "pause". Young adults playing high school sports are extremely low risk for complications from COVID-19. I have not seen any study illustrating youth sports of any type are a primary spread of COVID-19. In fact, it is well established the household is the primary place COVID-19 is spread. Many other States are successfully playing all youth sports.

Participating in sports is a choice. If a parent and/or athlete is not comfortable competing, they do not have to. If a coach is not comfortable coaching they do not have to. This virus disproportionately impacts individuals who are unhealthy. The Governors Office is asking young adults to avoid one of the best ways to prevent having complications to COVID-19, health. Our children need healthy outlets. Sports is one of the best activities to reduce stress, provide exercise and garner the feeling of being a part of something greater than yourself.

I fear the blanket directives from the Governor's office do indiscriminately impact populations who are not at risk from complications secondary to COVID-19. I am troubled the myopic approach to this pandemic will cause more harm to our youth than the virus itself. The "pause" was advertised as a two-week period following the Thanksgiving holiday. What does it teach our children when the Government gives them hope of normalcy and then arbitrarily pulls it away?

Subject: Addressing Agenda Item: COVID-19 Update Re: Use of Playground Equipment

#### Good morning,

Welcome to the new board members. As a teacher and a parent I look forward to working with all of you in efforts to support our students and children in every aspect of education.

In this correspondence I am hoping that teachers and parents will be receiving a timeline for use of playground equipment at elementary schools.

If students have been permitted to share balls, jump ropes, hula hoops, etc. then the use of playground equipment should also be permitted.

My son is in a pre-k program but can't use the playground equipment. Kindergartners can play with tennis balls on a ball wall (all touching the ball), 4th graders can play football (all touching and catching the same ball), the 6th graders can play basketball (all touching the same ball), but can't use the playground equipment. I also would add that the football and basketball games are played in rather close proximity because that is the nature of the game, but they still can't use the playground equipment.

My question still remains, why is the playground equipment still off limits if other games and balls are already being shared? Stating that social distancing can't be maintained is absurd as students are playing games together anyway. All students are still required to wash hands after touching the shared balls, hula hoops, jump ropes, etc. The protocol would be the same with playground equipment. I know for a fact that if my students (Kindergarteners) had the opportunity to play on equipment they would also be willing to help wipe it down after to sanitize.

Or is it a matter of teacher comfort? Could schools and/or teachers at schools have the autonomy to decide what they would like to do for their students? Or is it an a factor of liability? Could schools, with the help of the district legal department, develop a waiver for students to use the equipment with verbiage that indicates that all sanitary protocols for use and hand washing would still be in place?

My son's class is unique as they are the only ones who would utilize the playground equipment on the playground they use, so sanitizing it isn't an issue. As a parent who also works at the same school I would volunteer to sanitize it for them if required. They also wash hands so often throughout the day that their hands would be clean after use of equipment.

To further support the use of playground equipment for young children, the American Association of Pediatrics published an article in October stating, "Reducing classmate interactions/play in Pre-K aged children may not provide substantial COVID-19 risk reduction." Similarly, they also stated, "Reducing classmate interactions/play in Elementary school-aged children may not provide substantial COVID-19 risk reduction to justify potential harms."

I am aware and have been told that many community members, teachers, administrators, doctors, and pediatricians are a part of the COVID re-opening committee for our district. Is this being discussed? When can pre-k and elementary aged students expect to be allowed to interact and play again? If it's being worked on and discussed this is fabulous! Providing teachers and parents with a date and/or timeline is even better and deserved for our children.

The district may move forward with plans to open schools for in-person and hybrid learning beginning next Tuesday, January 19<sup>th</sup>. What problems exist with that plan?

First problem: teacher illness and the substitute shortage. The district has been short up to 200 substitutes a day since August. **Where is the data-** how many substitutes have been hired and trained, ready to work next Tuesday?

Second problem: Covid-19 cases among students and staff and contact tracing. **Where is the data**how many people are fully trained and prepared to contact trace beginning next Tuesday? If my school, Vaughn Middle School, has an outbreak, which contact tracer will be there for us to find out who was exposed?

Third problem: A deadly virus spreading silently and quickly through our county. Despite low testing numbers, 21% of Covid-19 tests in Washoe County are coming back positive (RGJ 1/11/21). New variants of highly infectious Covid-19 are also certainly spreading, silently and undetected, through our community. 84% of hospital beds are currently occupied in Reno (RGJ 1/11/21). My students are majority Latinx, which means their risk for testing positive for covid-19 is 50% higher than white people, and their risk of hospitalization is 48% higher than white people (RGJ 1/4/21).

Well-to-do families, healthy families, organic food families, can't understand the devastation and pain occurring in the dim backstreets and crowded apartments of the city. What cries of grief and loss are muffled by the wealthy & white who demand "back to normal!" What normal?

27% of teachers are considering **quitting** after this school year (CNBC 12-14-20) Returning to inperson learning will cement and exacerbate those numbers. I am teaching in the oldest middle school building in Reno, built in 1956. Our school is not equipped for safe social distancing in cramped hallways and classrooms or air purification during breakfast and lunch.

Plan and prepare for the long-term success of your school district. Keep schools on the current distance model until March 29<sup>th</sup> or later- when our test positivity rate lowers to 5%. Train teachers in effective, caring, successful distance learning pedagogy. Protect your teachers. Keep us and our students safe from schools and the deadly Covid-19 virus.


Hello Wonderful WCSD Folks, Below is my public comment for the WCSD BOT 1/12/21 Meeting.

Last night, Governor Sisolak extended COVID-related restrictions for an additional 30 days, because of the high rates of spread of the virus and the strains placed on hospitals and health-care providers. ### Board of Trustees,

I am writing to voice my approval of Dr. Kristin McNeill's reminders of district and community resources that might assist families after witnessing the DC riots last week. The idea that her message was somehow political speech does not ring true to me. Whose political beliefs include the desire to change the outcome of a democratic election and why would we want to present that political ideology as viable to our students?

It seems to me that the real question of protest should always be whether or not the ends justify the means. In the case of last week's riot, the ends(overturning the process of the Electoral College and instilling fear in the minds of democracy-supporters) was clearly not a case of the ends justifying the means. Some responses to the superintendent's message I have read seem to think that the ends did not justify the means with the Black Lives Matter events that were especially prevalent this summer and that somehow this opinion is relevant to the DC riot. This is not a useful line of argument. Many have argued more convincingly than I could about the disparate treatment of BIPOC communities in the United States. Progressives and conservatives might argue about the causes of these disparate treatments and outcomes, and there are disagreements as to what the "means" of improving conditions should be. But each end of the political spectrum can at least appreciate the need for some kind of "means" to fix the inequalities in the United States. What occurred at Black Lives Matter events across the nation might not reflect the same "ends" everyone in the country might have thought best or most appropriate, but at least they were advocating for a cause(end of disparities) that a wide range of people can get behind. I fail to understand how anyone could appreciate either the ends or the means of the riots last week. This is why the comparison to Black Lives Matter doesn't make sense to me.

President Trump lost the election yet he has continued to lie to his supporters for months. His supporters rioted against our nation's political ideals of democracy. That is frightening and flies in the face of the democratic ideals our school district should be promoting. The district cannot expect civics and history education to take happen while refusing to acknowledge the world today in all its shades of gray. Our students deserve an education that engages the world. If students aren't prepared to engage the world and all of its complexities from any perspective other than their own, we will continue to have misinformed people angry with the wrong power structures causing riots whose purpose is to undermine the very values they are claiming to protect. I am disheartened that I have to articulate this idea, but I truly appreciate that the district has encouraged dialogue about the riots in DC. Students have questions after major events and school staff need to be equipped to talk about the wider world.

I don't consider Black Lives Matter to be political speech, but even if I did, their actions didn't lead to the death of police officers this summer despite being pepper sprayed, beaten, and harassed all summer. The rioters last week killed an officer. There is video of another officer being bludgeoned with an American flag on a pole while people sang the Star Spangled Banner. Imagine if a Black Lives Matter protester did this. If these events and groups were comparable, and I want to be clear that I don't think that they are, we should be comparing Black Lives Matter's relative peace this summer to the embarrassing spectacle last week. The rioters in DC erected gallows! Thankfully, nobody was hanged, but the symbolic effects were powerful. Our children need help processing this spectacle that opposes the ideals of the United States.

**Subject:** [EXTERNAL] Revision of Distance Learning to Be More Equitable

The current plan for middle and high school students is a poorly rated supplement used primarily for credit recovery. Schools are left to implement distance learning with no consistency between schools. For stable students, this is inadequate as many schools leave students to fend for themselves with little guidance from teachers. This is especially problematic for transient students who may move schools and see no consistency.

Edgenuity is rated 1.5 stars in reviews and has been dropped by most states. Materials are well over a decade outdated - for example "Academic Success" references MySpace and using CD-Roms, PE teaches about the Presidential Fitness Award which was discontinued in 2013. Students are learning about things that are no longer relevant.

Edgenuity also does not provide curriculum like actual music, theater and other connected curriculum. Some schools have implemented and integrated these other classes while others like SSHS rely solely on the Edgenuity platform.

Students are also disconnected from their classmates creating more social and emotional issues.

I ask you implement an equitable distance learning plan that is uniform across schools especially middle and high school and that allows for interaction and continuity.

The district can and should do better.

Superintendent McNeill's phone call expressing her concern for our children over the impact of the Capitol breach on January 6<sup>th</sup> was astoundingly tone-deaf, to say the least, and here's why:

COVID-19

Madam Superintendent, School Board Trustees, and applicable School District Staff,

Over the past months, many of you lauded the districts openness and reporting in regards to reporting the spread of COVID-19 through the "WCSD COVID Data Dashboard".

Admittedly the dashboard is a great tool to display a snap shot of information but for me there are multiple issues that should be addressed and fixed:

- First the updates do not happen as advertised. The first sentence of the district homepage says the Dashboard will be updated on "Tuesday, Thursday, and Saturday of each week" but as I write this during the break in the school board meeting, the dashboard reads "Updated 1/11/2021 11:00 A.M." (which was a Monday).
- Second the data does not match the information provided on the "School-by-School Covid-19 Case Status." The sum of total student cases and staff cases on the Dashboard is 444 (235 student/209 staff). The sum of the "Total Since 8/7/2020" column on the Case Status Report is 468.
- Finally, the dashboard does not have a historical record in which readers can look how things have changed over time. The TMRPA Risk Rating which is the first metric listed on the Dashboard does maintain a historical record for people to look at changes over time.

Please get whomever is posting this information to: check their work, and publish each update to the dashboard not only to the homepage but also to the "News Release" section of the Communications Department.

The district stopped publishing news releases regarding COVID-19 on 13 September. If nothing else, please return to publishing any updates to the case numbers, and exclusions like you once did.

#### Dear esteemed board members:

January 6th was a devastating day to be a parent and to be an American. My daughter, a freshman at AACT's medical academy, was busy doing her studies via distance learning. My son and I opted to watch Congressional proceedings live as part of our homeschool studies on government. We watched in horror as domestic terrorists smashed out windows of the Capitol building and gained entrance to terrorize members of Congress. We watched our nation's representatives don gas masks and evacuate through tunnels. We were both in tears, not quite knowing how to react. My son, an eight year old with a genetic disorder (Williams Syndrome) that makes him friendly and empathic asked, "mommy, are we going to have a civil war?" How does a parent answer this question? My daughter showed me messages from classmates who were engaged in heated conflict about the day's events.

Parents, children, and everyone in our nation is exhausted from the collective trauma of surviving a global pandemic that has killed loved ones and hospitalized others. We have prevailed through mutual aid, sharing resources, being kind, and checking up on each other. I was so relieved to receive the call from Dr. McNeil. I gathered my children around to listen together. We sighed collectively. We felt seen. We felt heard. We felt cared for.

The message, which I received via telephone and email, was to offer resources to students who may be feeling stressed. As a doctoral student in public health, as a person who works in behavioral health, and as a person in long-term recovery from substance use and mental health challenges, I will offer my perspective. It is well documented that national conflict and community violence adversely affects physical, emotional, and psychological health. In fact, it can impact adverse childhood experiences (ACES) and disproportionately impact students who experience chronic stress via other stressors (domestic violence, parental substance use, divorce, etc.) Given those factors coupled with everything else our children have experienced in the past 10 months (more toxic stress) it is right for us to be worried about the children and know where to get resources. I'm proud to be a parent of a child in the WCSD and I'm damn proud of Dr. McNeil! Thank you, Dr. McNeil for putting your students first. Keep up the good work. Board members, I urge you to support our Superintendent and the health and wellness of our children. They truly are our future, let's focus on keeping them well in the present.
