- 1. An official game ball (women's) will be the official ball**
- 2. There will be two 20 minute running time halves.**
- 3. Stop time will be played during the last two minutes if the score is within 12 points.**
- 4. Five minutes between hlaves**
- 5. Each team has two full time outs and three 30 second time outs.**
- 6. The clock will stop during free throws and time outs.**
- 7. All coaches are encouraged to activiely play as many players as possible during the course of the game**
- 8. No Full, Half court or trap once a 20 point lead is established (technical foul)**
- 9. OVERTIME - (2) 3 MINUTE OVERTIMES**
10. Bring your own Basketballs when traveling - make sure they are labeled.
11. If an athlete or coach is ejected form the game they have to sit out the next game.

#### **Team Selection**

Theres should be a minimum of 12 players on each of the basketball teams. When splitting A/B basketball teams.

The A Team will be the top 5-7 players and the B team selects the next top 5-7 players.

The remaining players will be divided up by the coaches with consideration given

to the placement which benefits the players the most.

Coaches are required to to keep a RUBRIC and accurate records when choosing teams.

Once the teams are chosen, copies should be given to the prinicipal, VP, secretary, MALC member and staff. It is also

It is also required that a copy of team rules, and a parent letter be handed out to each player and sent home for parents

A copy of the team schedule/practice should be included in this information, along with rules for transporting team

members to and from games.
