Nominations

The Selection Committee will develop a form or application which nominations will be made. The form must be completed, and the qualifications of the proposed inductee must be clearly set forth in the form.

- Nominations may be made by anyone, however self-nominations or unsigned/anonymous nominations will not be accepted.
- Committee Members may not make nominations.
- Application for nominations are available on the NVHS website for a publicized period of time every other year.
- Nominations must be received by specified deadline to be considered for the current induction class.
- The Selection Committee shall have the discretion to narrow the field of nominees.
- The Selection Committee shall induct no more than 7 new members in each induction year.
- Nomination forms will be kept and reviewed bi-annually if the candidate is not inducted for current class. Applications will be held on file for 2 Induction cycles.

IV. Eligibility/Criteria

• Athletes, coaches, teams, administrators or supporters, living or deceased, shall be eligible for induction subject to the criteria below. All nominees must represent the North Valleys High School tradition of excellence and the values and of being a Panther.

Athletes:

- Eligible 10 years after graduation from NVHS (i.e.; 2008 grad for 2018 induction)

• Must be an NVHS graduate - selection committee will have discretion in unique, special circumstances (i.e.; death, accident, etc.).

• Must have lettered in one or more Varsity sports.

• Athletic ability, sportsmanship, character, leadership, contribution to team and the Athletic Contests he/she participated in. A similar standard of ethics shall have characterized the years following their time at North Valleys High School, to the best of the committee's knowledge.

• Awarded All-Conference, All -Region, All-State, any individual or team championship, any record or winning streak, league leader in recognized statistical category, and/or college scholarships should be considered. Achievements should be on record and verified by copies of news clippings, yearbooks, certificates of awards, etc. All-star teams, tournaments, and awards were less common in earlier eras and documentation of achievements might be more difficult to find. This should be taken into consideration.

• Committee may also consider post-graduate activities including college and professional experience.

Coaches:

- Any coach with 5 or more years coaching experience at NVHS is eligible (the Committee may make exceptions as to years experience in unique, special circumstances) for nomination.
- The nominee must be inactive or retired for 5+ years or have a minimum of 20+ years if service.
- Accomplishments must take into consideration league and/or statewide recognition, and/or significant contributions to the athletic programs at NVHS.
- Coaching ability, loyalty to NVHS, leadership, character, athletic expertise, significant contribution to their teams and to the sports they coached must have been demonstrated.
- The same ethical and life standards expected of his/her athletes shall also characterize the life of the coach.

<u>Teams:</u>

• Championship teams having attained record status at least 10+ years after the historic season may be nominated and considered.

Administrators/Staff/Volunteers/Supporters

• Staff Members and Administrators must be inactive or retired for 5 or more years. Volunteers and Supporters must have a minimum of 5 years of service to be considered. Each must possess exceptional leadership, character, loyalty to NVHS and the passion for, support of, and the success of North Valleys athletics is paramount..

North Valleys High School reserves the right to remove any individual from the Hall of Fame for personal conduct, which reflects discredit upon the school.
