Dave Solaro opened up both 2.03 and 2.04 items to be presented by Mark Mathers.

Mark Mathers, WCSD Chief Financial Officer, combined items 2.03 and 2.04 since they are related. Mr. Mathers gave a brief power point presentation. WCSD is requesting \$200,000,000.00 of new authority for issuance of roll over bonds for a three year cycle. It will fund the Capital Renewal Program for the next three years and to assist in crossing over from calendar year authorizations to fiscal year authorizations to sync up with State Law in terms of the Capital Renewal Program. These bonds will also provide funding for a potential project at O'Brien MS. For all of these projects WCSD is asking for authorization to issue debt. Debt will not be issued until this Committee approves the program and the WCSD Board of Trustees has approved. WCSD is requesting pre authorization of funding.

There was a brief discussion with Committee Members and Mr. Mathers.

Devon Reese made a motion to Approve the Resolution Concerning the Submission to the Washoe County Oversight Panel for School Facilities by Washoe County School District, Nevada, of a Proposal to Issue General Obligations in one series or more, in an Aggregate Principal Amount Not to Exceed \$200,000,000 for the Constructing, Expanding, Improving, and Equipping School Facilities within the District. Paul Anderson seconded the motion. The vote was unanimous.
