December 13, 2021

1. OPENING ITEMS

1.01 CALL TO ORDER

The meeting of the Sexuality, Health and Responsibility Education (SHARE) Advisory Committee was called to order at 5:32 P.M.

1.02 Roll Call

Chair Ashley Wade and Committee Members – Ashley Wade, Lydia DeFlorio, Stephanie Shuman, Kelly Roper, Manuel Magana, and Andrea Thompson were present; Rabbi Benjamin Zober was present shortly after roll was taken. Vanessa Vancour and Sara Linda Kiser were absent. Staff Liaison Rochelle Proctor and staff were also present.

2. ITEMS FOR DISCUSSION, PRESENTATION AND/OR ACTION

2.01 Approval of the minutes of minutes of the October 11, 2021, Sexuality, Health and Responsibility Education (S.H.A.R.E.) Advisory Committee Meeting (FOR POSSIBLE ACTION)

Chair Ashley Wade stated she understood people had driving to do tonight and would be pressing to keep things moving quickly along and asked if someone had something to say on an item to please raise their hand instead of asking for individual input from everyone on every agenda item so everyone could get home safely.

Chair Wade opened the item for discussion, legal counsel reminded to ask for public comment. There was one public comment received from Mindy Lilyquist, Chair Wade asked that the members take a moment to look at the comment, Staff Liaison Rochelle Proctor emailed to the committee.

On motion by Stephanie Shuman, second by Manual Magana, the Sexuality, Health, and Responsibility Education (S.H.A.R.E.) Advisory Committee approved the minutes from the October 11, 2021 S.H.A.R.E Advisory Committee meeting (Yea: Lydia DeFlorio, Stephanie Shuman, Kelly Roper, Manuel Magana, Andrea Thompson, Ashley Wade, and Rabbi Benjamin Zober) Final Resolution: Motion Carries 7-0.

Chair Wade opened the item for discussion, S.H.A.R.E. Coordinator, Rochelle Proctor asked for clarification on if they had heard Rabbi Benjamin Zober's voice in the vote. Chair Wade confirmed he was in the meeting. Chair Wade asked for public comment. There was no public comment provided.

On motion by Manual Magana, second by Stephanie Shuman, the Sexuality, Health, and Responsibility Education (S.H.A.R.E.) Advisory Committee approved the minutes from the November 8, 2021 S.H.A.R.E Advisory Committee meeting (Yea: Lydia DeFlorio, Stephanie Shuman, Kelly Roper, Manuel Magana, Andrea Thompson, Ashley Wade, and Rabbi Benjamin Zober) Final Resolution: Motion Carries 7-0.

Fourth (4th) grade curriculum for draft lesson So, What is Puberty?; and possible action to either recommend the adoption of the proposed curriculum, with any additional revisions, and deletion of the existing curriculum related to the 4th grade S.H.A.R.E. curriculum lesson Puberty, Physical and Emotional Changes, by the WCSD Board of Trustees or recommend revisions to the 4th grade draft S.H.A.R.E. lesson So, What is Puberty? to the S.H.A.R.E. S.H.A.R.E. Coordinator, Rochelle Proctor stated she highlighted the edits that were discussed to make viewing the edits easier. The first edits were on slide 4, What are Some Changes That Occur During Puberty under teacher notes. This is information is for teachers to have when having those discussions with students. Edits were made under the sections regarding weight gain, sweat starts to smell, and there were enlarged wording for slide 9, social changes and slide 10, emotional changes.

Chair Wade stated she ran this through with her current 4th grader to see what their opinions were and they stated it was great. Committee Member, Kelly Roper had a question if the videos on item 2.04 are attached to lesson from 2.03, which it was confirmed they are.

Chair Wade asked if there was public comment. No public comment was received.

On motion by Stephanie Shuman, second by Ashley Wade, the Sexuality, Health, and Responsibility Education (S.H.A.R.E.) Advisory Committee approved moving forward with revisions from November 8, 2021 S.H.A.R.E Advisory Committee meeting and recommend forwarding to the Board of Trustess (Yea: Lydia DeFlorio, Stephanie Shuman, Kelly Roper, Manuel Magana, Andrea Thompson, Ashley Wade, and Rabbi Benjamin Zober) Final Resolution: Motion Carries 7-0.

Curriculum lesson So, What is Puberty? to the S.H.A.R.E. Coordinator for future additional consideration by the S.H.A.R.E. Advisory Committee (FOR POSSIBLE ACTION)

S.H.A.R.E. Coordinator, Rochelle Proctor stated she put these two videos forward after doing more research. Committee Member, Kelly Roper stated she liked both videos and enjoyed the true/false paddles in the fake classroom because she thought it was the best way to have everyone answer. She also stated she did not like "expert" on the video and proposed that the video stops when the kids write down questions.

Committee Member, Andrea Thompson stated it would be helpful to know what part of the video she could look at to reference what Ms. Roper was discussing. Ms. Roper clarified that it was in question number one of the video, why doesn't puberty take place in elementary school, because the response seemed inaccurate because they have previously discussed puberty can happen as soon as eight or nine years old. Committee Member, Manny Magana echoed what Ms. Roper said and suggested a link or let teachers know to stop video before it gets to the very end and get to all the ads. Ms. Thompson said she didn't recall that there was a mention of what kind of expert the person was and believes it is contradictory to what has been told to the kids and had concern over the length of the video.

Committee Member Rabbi Benjamin Zober agreed with the first part of the video and then it loses steam with the expert, did have concerns about comparing testicles to kiwis as it is not realistic. Ms. Thompson suggested having more information in the teacher's note that they are really trying to show we all come in different shapes and sizes.

Committee Member, Stephanie Shuman stated she liked the videos, and asked if they could do edits on taking care of your body during puberty to remove the first ad that shows or make sure teachers know to quickly skip ad. Chair Wade said most teachers get the video ready before and move past the ads before showing to the class.

Ms. Roper had a clarifying question for the agenda for replacing the videos from the bottom two that are mentioned. Ms. Proctor stated that was correct and reiterated that she asks the teachers in advance to have the videos ready to play before the students are present as there always seems to be strange ads.

Chair Wade asked if they had received any public comment. No public comment had been submitted.

Mr. Magana wanted to clarify that teacher's not show the video on guest wi-fi as it will not allow them to access the videos and they need to make sure they are logged in properly.

On motion by Kelly Roper, second by Ashley Wade, that the Sexuality, Health, and Responsibility Education (S.H.A.R.E.) Advisory Committee accept the videos, What is Puberty, Feeling Happy, Depressed and Other Emotions and Every Body Curious/Puberty ending at 3 minutes and 45 seconds to replace videos, Taking Care of Your Body and Puberty, Finding Out Who You Are and recommend forwarding to the Board of Trustess (Yea: Lydia DeFlorio, Stephanie Shuman, Kelly Roper, Manuel Magana, Andrea Thompson, Ashley Wade, and Rabbi Benjamin Zober) Final Resolution: Motion Carries 7-0.

Coordinator for future additional consideration by the S.HA.R.E. Advisory Committee (FOR POSSIBLE ACTION)

S.H.A.R.E. Coordinator, Rochelle Proctor highlighted edits to show she added a video that was not previously in proposed lesson. Ms. Proctor updated verbiage to "most bodies with" when discussing body parts. The video was added on slide 10 about what makes someone a trusted adult.

Chair Wade stated she liked the addition of the video and asked for discussion from the members, there was none. Chair Wade asked for public comment. There was no public comment provided.

On motion by Andrea Thompson, second by Manny Magana, that the Sexuality, Health, and Responsibility Education (S.H.A.R.E.) Advisory Committee approve the 4th grade curriculum lesson Understanding Our Bodies recommend forwarding to the Board of Trustess (Yea: Lydia DeFlorio, Stephanie Shuman, Kelly Roper, Manuel Magana, Andrea Thompson, Ashley Wade, and Rabbi Benjamin Zober) Final Resolution: Motion Carries 7-0.

S.H.A.R.E. Coordinator clarified that this was for the addition of video Finding an Adult you Can Trust. Chair Wade asked if there was any public comment. No public comment was received.

On motion by Manny Magana, second by Ashley Wade, that the Sexuality, Health, and Responsibility Education (S.H.A.R.E.) Advisory Committee approve including this video in 4th grade curriculum lesson Understanding Our Bodies recommend forwarding to the Board of Trustess (Yea: Lydia DeFlorio, Stephanie Shuman, Kelly Roper, Manuel Magana, Andrea Thompson, Ashley Wade, and Rabbi Benjamin Zober) Final Resolution: Motion Carries 7-0.

2.07 Presentation and discussion of the proposed Sexuality, Health, and Responsibility Education (S.H.A.R.E.) Fourth (4th) grade curriculum, to include lesson plans and accompanying PowerPoint presentation materials, for draft lesson Friendships and the concepts proposed to include; characteristics of healthy and unhealthy friendships, positive and negative ways friends and peers can influence relationships, consent, identify trusted adults, and the inclusion of two videos: Consent for Kids (2:30) https://youtu.be/h3nhM9UlJjc and What Makes a Good Friend (2:22) https://youtu.be/iPb0Ww7qDIo; and possible action to either recommend adoption of the proposed curriculum, with any additional revisions, and deletion of the existing curriculum related to the 4th grade S.H.A.R.E. curriculum lesson Friendships, by the WCSD Board of Trustees or recommend revisions to the 4th grade draft S.H.A.R.E. lesson Friendships to the to the S.H.A.R.E. Coordinator for future additional consideration by the S.HA.R.E. Advisory Committee (FOR POSSIBLE ACTION)

S.H.A.R.E. Coordinator, Rochelle Proctor reviewed objectives, activities, lesson prep, lesson intro, use of slang works, lesson one focus on friendships, relationships with others, types of relationships, positive and negative influences on relationships and reviewed what people might say or do to be in a positive or negative friendship. Reviewed consent – permission for something to happen or not happen, ongoing process as person can always change their own mind.

Chair Wade stated she was happy to see discussion of friendship and consent and it lays good groundwork for future lessons. Committee Member, Kelly Roper loved it and believed the discussion of friendship was awesome and enjoyed the diverse friends saying what makes a good friend. Chair Wade echoed those comments. Committee Member, Manny Magana asked if after slide five there is a slide six. Ms. Proctor it was her numbering, he made a suggestion for slide 6 to expand on consent to make sure it stated it needs to be asked each time. Chair Wade asked if he was good with saying consent is an ongoing process, that's why friends check in with each other every time. Mr. Magana stated that even though it is a simple concept, it may go over their heads. Chair Wade asked if he had better verbiage and he stated if she gave him a couple of minutes, he would work on it.

Chair Wade asked if there was public comment. No public comment was provided.

Committee Member, Lydia DeFlorio asked if the true/false quiz was in the provided documents, Ms. Proctor apologized it was not included. Ms. DeFlorio suggested adding a bullet point in teacher's notes about asking for consent every time.

Committee Member, Kelly Roper liked adding an extra slide for consent and asked if it made more sense to have it after the video so it is more of a closer and ties it together. Chair Wade since they do not have that activity to preview, they don't need to settle on verbiage and could possible revisit revisions. Chair Wade asked for public comment. No public comment was provided.

Ms. Roper asked that the other purpose was for the committee and public to see the quiz. Chair Wade stated that was correct and was her intent.

On motion by Ashley Wade, second by Manny Magana, that the Sexuality, Health, and Responsibility Education (S.H.A.R.E.) Advisory Committee revisit this lesson with changes as discussed at a future meeting (Yea: Lydia DeFlorio, Stephanie Shuman, Kelly Roper, Manuel Magana, Andrea Thompson, Ashley Wade, and Rabbi Benjamin Zober) Final Resolution: Motion Carries 7-0.
