Dear Parent or Guardian,

The purpose of this letter is to notify you that your child's school has been newly identified as a TSI/ATSI school for the 2022-2023 school year. This letter provides important information regarding your child's school and describes the protocol for measuring the academic performance of public schools in Nevada.

In December 2015, the Every Student Succeeds Act (ESSA) was signed into law. Highlights of ESSA include holding all students to high academic standards and identifying low performing schools along with appropriate supports for school improvement. Under ESSA, there are two main school designations: Comprehensive Support and Improvement (CSI) and Targeted Support and Improvement (TSI). Additionally, Targeted Support and Improvement (TSI) is another school designation.

The State uses results from its school rating system, the Nevada School Performance Framework (NSPF), to identify CSI, TSI, and ATSI schools.

TSI Schools

TSI schools are schools that meet the following conditions:

- Schools with consistently underperforming subgroups (25 students or more) across these indicators
 - Academic Achievement: Math and ELA proficiency (for elementary schools, Read by Grade 3 proficiency),
 - Academic Growth,
 - English Learner Growth,
 - Student Engagement.
- Schools with underperforming subgroups in the Academic Achievement indicator AND two other indicators

TSI schools are schools with consistently underperforming student subgroups that did not meet targets for two years in a row.

ATSI Schools

ATSI schools are identified annually and are:

- A subset of TSI schools that require additional targeted support because of significant subgroup performance challenges that would, on their own, lead to a CSI designation,
- Based on subgroup number of students greater than or equal to 25.



ATSI schools were those with very low performing subgroups in 2019 only. ATSI schools must reduce the number of non-proficient students identified in subgroup performance by at least 10% for two consecutive years or meet the school's measures of interim progress for two consecutive years.

The following root causes have been identified as reasons why your child's school has been listed as underperforming:

- Staff capacity to provide high quality, differentiated, Tier I instruction (including co-teaching and inclusive practices service delivery models) is developing.
- Lack of exposure to and practice with strong language models resulting in more limited vocabulary and background knowledge.
- Skills-based focus vs. deeper level/ conceptual understanding focus in the past.
- Lack of consistency in delivering a guaranteed & viable curriculum across a grade level-common objectives/assessments not used uniformly within grade levels over time.
- High staff turn-over contributing to difficulty in establishing momentum towards school vision/goals.
- Lack of school exposure/opportunities to access rigorous content in early years & ENSURE a standards-based approach to planning & instructional delivery.

With this determination, your child's school will receive increased levels of support which will include: Access to the CSI/TSI/TSI-ATSI Microsoft Team which gives updates regarding designation, information and access to trainings, updates from the Nevada Department of Education, and all relevant information for designated schools.

1. Priority scheduling for professional development, professional trainings, data analysis, and meetings designed to navigate designation status.
2. Access to information that outlines their designation, target areas for improvement, professional development, and guidance in CIP-SPP planning.
3. Access to the Nevada Department of Education CSI/TSI/TSI-ATSI padlet which contains information, training updates, and other valuable tools for school improvement.

The following have been identified as district goals for the 2022-2023 school year:

- Academic Growth
- Developing Recruiting, and Training Highly-Effective Personnel
- Family and Community Engagement
- Continuous Improvement
- Safe and Welcoming Schools

School Specific Actions:

To provide support and meet school and district goals, Lemmon Valley ES is using Title 1 funding to provide all teachers at Lemmon Valley extended Professional Learning Community (PLC) planning time. Additionally, your child's school is engaging in high quality instructional coaching and prioritizing Tier 1 instruction



implementation to ensure Students will be engaged in 85% of the learning and text to ensure Tier 1/grade level learning is occurring with high quality instructional supports and language development integration for all students to access Nevada Academic Content Standards learning. The district will support your child's school by providing a Learning Facilitator instructional coach and a English Language Development coach. Also, the district will support your child's school by working with the school to create a TSI/ATSI plan. You will receive further information on how you can engage in this process, as required under federal law. You will also receive a copy of this plan once it is created.
